MF TIBAYAN CONSTRUCTION AND TRADING CORPORATION a domestic company duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with principal Office at 36 Sixto Extension, Tandang Sora, Quezon City and herein represented by MS. MARISSA F. TIBAYAN in her capacity as PRESIDENT/GENERAL MANAGER hereinafter referred to as the CONTRACTOR;

WHEREAS, the QUEZON CITY GOVERNMENT is desirous that the Contractor execute for the *PROPOSED REHABILITATION OF TENNIS COURT ROOFING*, *BARANGAY PROJECT 6 & PROJECT NO. 23-00006* and the City has accepted the Bid for *THREE MILLION FOUR HUNDRED SEVENTY THOUSAND EIGHT HUNDRED FORTY TWO PESOS & 92/100 CTVS.* (\$\mathbb{P} 3,470,842.92) by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

  - (i) Eligibility requirements, documents and/or statements;

- (j) Performance Security;
- (k) Notice of Award of Contract and the Bidder's conforme thereto;
- (I) Other contract documents that may be required by existing laws and/or the Entity.
- In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.

The Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
- That the Contractor hereby certifies that the site was regularly inspected and verified
- 6. The Contractor further undertakes to implement the awarded project in accordance with the approved plans, specifications and cost of contract.
