JOSEFINA G. BELMONTE**, in her capacity as City Mayor, herein after referred to as the **QUEZON** CITY GOVERNMENT;

CHING ENTERPRISES a domestic company duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with principal Office at 171 Caballero Montserat Subdivision, Barangay Sto. Angel Sur, Sta. Cruz, Laguna and herein represented by MR. JAIME B. CHING in his capacity as GENERAL MANAGER hereinafter referred to as the CONTRACTOR;

WHEREAS, the QUEZON CITY GOVERNMENT is desirous that the Contractor execute for the **PROPOSED CONSTRUCTION OF FIVE (5) STOREY WITH ROOF DECK MULTI-PURPOSE HALL, BARANGAY BATASAN HILLS & PROJECT NO. 23-00015** and the City has accepted the Bid for **ONE HUNDRED SIXTY TWO MILLION THREE HUNDRED NINETY NINE THOUSAND SEVEN HUNDRED ELEVEN PESOS & 37/100 CTVS. (P 162,399,711.37)** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

- 5. That the Contractor hereby certifies that the site was regularly inspected and verified
- 6. The Contractor further undertakes to implement the awarded project in accordance with the approved plans, specifications and cost of contract.
