JOSEFINA G. BELMONTE**, in her capacity as City Mayor, herein after referred to as the **QUEZON CITY GOVERNMENT**;

ANN - GIE BUILDERS a domestic company duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with principal Office at 9 *Almaciga Street, Old Balara, Quezon City* and herein represented by **MS. VIRGINIA G. BRIOSO** in her capacity as **GENERAL MANAGER** hereinafter referred to as the **CONTRACTOR**;

WHEREAS, the QUEZON CITY GOVERNMENT is desirous that the Contractor execute for the **PROPOSED FABRICATION AND INSTALLATION OF ENVIROMENTAL GRAPHICS DESIGN (EGD) SIGNAGES ALONG GORA LANE, BARANGAY VARIOUS BARANGAYS & PROJECT NO. 23-00017** and the City has accepted the Bid for **ONE MILLION SIX HUNDRED EIGHTY FIVE THOUSAND EIGHT PESOS & 90/100 CTVS. (P 1,685,008.90)** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

The Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
5. That the Contractor hereby certifies that the site was regularly inspected and verified
6. The Contractor further undertakes to implement the awarded project in accordance with the approved plans, specifications and cost of contract.
