VILLACORTE CONSTRUCTION** a domestic company duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with principal Office at 53 Cluster 3 Manunggal Street, Tatalon, Quezon City and herein represented by **MR. EDUARDO I. VILLACORTE** in his capacity as **GENERAL MANAGER** hereinafter referred to as the **CONTRACTOR**;

WHEREAS, the QUEZON CITY GOVERNMENT is desirous that the Contractor execute for the *PROPOSED IMPROVEMENT OF GSIS SUBDIVISION TENNIS COURT, BARANGAY BAHAY TORO & PROJECT NO. 23-00019* and the City has accepted the Bid for *TWO MILLION SIX HUNDRED NINETY THREE THOUSAND THREE HUNDRED THIRTY THREE PESOS & 93/100 CTVS. - (j) Performance Security;
- (k) Notice of Award of Contract and the Bidder's conforme thereto;
- (I) Other contract documents that may be required by existing laws and/or the Entity.
- 3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.

The Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
- That the Contractor hereby certifies that the site was regularly inspected and verified
