**CZERJ CONSTRUCTION AND TRADING** a domestic company duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with principal Office at 10 K8th Street, West Kamias, Quezon City and herein represented by MS. CYNTHIA C. ROBILLOS in her capacity as GENERAL MANAGER hereinafter referred to as the CONTRACTOR;

WHEREAS, the QUEZON CITY GOVERNMENT is desirous that the Contractor execute for the PROPOSED FABRICATION AND INSTALLATION OF PLANTBOX BARRIERS ALONG COMMONWEALTH AVENUE BIKE LANE AND AND FABRICATION OF BIKE RACKS ON VARIOUS LOCATIONS AT COMMONWEALTH AVENUE, BARANGAY VARIOUS LOCATIONS & PROJECT NO. 23-00020 and the City has accepted the Bid for THREE MILLION NINE HUNDRED EIGHTY FIVE THOUSAND SIX HUNDRED SIXTY PESOS & 24/100 CTVS. (# 3,985,660.24) by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

- (i) Performance Security;
- (k) Notice of Award of Contract and the Bidder's conforme thereto;
- (I) Other contract documents that may be required by existing laws and/or the Entity.
- 3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.
- 4. The Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
- 5. That the Contractor hereby certifies that the site was regularly inspected and verified
- 6. The Contractor further undertakes to implement the awarded project in accordance with the approved plans, specifications and cost of contract.
