LOURDES AVEN SEÑAR in her capacity as AUTHORIZED REPRESENTATIVE OF THE JOINT VENTURE PARTNER hereinafter referred to as the CONTRACTOR;

WHEREAS, the QUEZON CITY GOVERNMENT is desirous that the Contractor execute for the **PROPOSED REHABILITATION** (SURFACE IMPROVEMENT) AT **PANAY AVENUE** (TIMOG AVENUE - EDSA), BARANGAY SOUTH TRIANGLE & **PROJECT NO.** 23-00041 and the City has accepted the Bid for TWENTY THREE MILLION SIX HUNDRED SEVENTY SIX THOUSAND ONE HUNDRED SEVENTEEN **PESOS & 55/100 CTVS.** (# 23,676,117.55) by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

- 3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.
- 4. The Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
- 5. That the Contractor hereby certifies that the site was regularly inspected and verified
- 6. The Contractor further undertakes to implement the awarded project in accordance with the approved plans, specifications and cost of contract.
