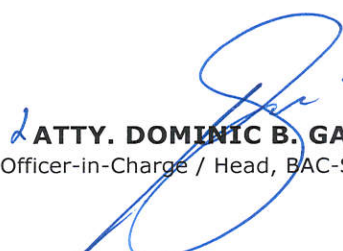

TERMS OF REFERENCE

ONLINE ASSESSMENT / PSYCHOLOGICAL TESTING SUBSCRIPTION FOR QUEZON CITY UNIVERSITY STUDENTS

I. RATIONALE AND BRIEF BACKGROUND

The psychological testing helps to assess students' potential and helps them become aware of their personality and ability as part of discovering their strengths and weaknesses. The ratio of guidance counselors or staff to students can be a challenge in the administration, scoring, and interpretation of psychological tests. In addition, the quantity of original answer sheets could cause a storage issue and original booklets are wear-and-tear-prone. Thus, online testing can help to resolve this challenge. Online testing can provide the following benefits: flexibility of assessment scheduling, ease of administration, shorter assessment turn-around time, accuracy of scoring, standardized assessment reports, and online storage of psychometric data and reports.

Quezon City University was accredited by the Association of Local Colleges and Universities Commission on Accreditation (ALCUCA) in October 2022, and they provided their findings and recommendations. On January 25, 2023, the CHED - Regional Quality Assessment Team (RQAT) conducted an evaluation for the opening of new programs for the College of Computer Studies. Both the ALCUCA and the CHED-RQAT recommend having a psychological testing subscription to serve the student population.

II. SCOPE OF WORK & DELIVERABLES

- Test accounts that will be distributed to the students.

3. The service provider shall guarantee that the system shall abide with the DATA PRIVACY ACT of 2012 to ensure that the personal information is protected.

V. PROJECT DURATION & DELIVERY

Project duration shall be until December 31, 2023 and can be accessed within 15 days upon issuance of the Notice to Proceed (NTP).

VI. APPROVED BUDGET FOR THE CONTRACT

IX. CANCELCATION OR TERMINATION OF CONTRACT

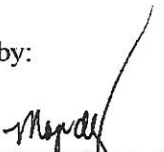
