WHEREAS, the QUEZON CITY GOVERNMENT is desirous that the Contractor execute for the *PROPOSED REHABILITATION OF TRASH RAKE ALONG GREGORIO ARANETA AVENUE, BARANGAY MANRESA AND MASAMBONG & PROJECT NO. 23-00050* and the City has accepted the Bid for *NINE MILLION SIX HUNDRED SIXTY THREE THOUSAND NINE HUNDRED NINETY PESOS & 92/100 CTVS. The Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
