QUEZON CITY, a public corporation duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with principal office at City Hall, Diliman, Quezon City, Metro Manila and herein represented by MA. JOSEFINA G. BELMONTE, in her capacity as City Mayor, herein after referred to as the QUEZON CITY GOVERNMENT;

- and -

TRI DG TRADING AND CONSTRUCTION a domestic company duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with principal Office at *Unit 706, 6th Floor Bali Garden Residences, No. 140 South Zuzuaregui Street, Capitol Hills Drive, Matandang Balara, Quezon city and herein represented by MR. CARSWELL M. CABRERA in his capacity as GENERAL MANAGER hereinafter referred to as the CONTRACTOR;*

WHEREAS, the QUEZON CITY GOVERNMENT is desirous that the Contractor execute for the *PROPOSED REHABILITATION OF ROAD AND DRAINAGE AT KASUNDUAN STREET AND KATARUNGAN STREET (PORTION ONLY), BARANGAY COMMONWEALTH & PROJECT NO. 23-00054* and the City has accepted the Bid for *SIXTEEN MILLION SEVEN HUNDRED TWO THOUSAND THREE HUNDRED EIGHTY ONE PESOS & 12/100 CTVS. (₽ 16,702,381.12)* by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

 - (g) Addenda and/or Supplemental/Bid Bulletins, if any;

- Bid form, including all the documents/statements contained in the (h) Bidder's bidding envelopes, as annexes;
- (i) Eligibility requirements, documents and/or statements;
- Performance Security; (j)
- Notice of Award of Contract and the Bidder's conforme thereto; (k)
- Other contract documents that may be required by existing laws (1) and/or the Entity.
- 3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.
- 4. The Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
- 5. That the Contractor hereby certifies that the site was regularly inspected and verified
- 6. The Contractor further undertakes to implement the awarded project in accordance with the approved plans, specifications and cost of contract.
