JOSEFINA G. BELMONTE, in her capacity as City Mayor, herein after referred to as the QUEZON CITY GOVERNMENT;

GERCEL CONSTRUCTION & DEVELOPMENT GROUP INC. a domestic company duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with principal Office at 3rd Floor Rojul Building, Mc-Arthur Hiway, San Fernando City Pampanga and herein represented by MR. CHESTER C. CONCEPCION in his capacity as AUTHORIZED SIGNATORY hereinafter referred to as the CONTRACTOR:

WHEREAS, the QUEZON CITY GOVERNMENT is desirous that the Contractor execute for the *PROPOSED CONSTRUCTION OF DEPARTMENT OF JUSTICE STOCK ROOM, BARANGAY CENTRAL & PROJECT NO. 23-00060* and the City has accepted the Bid for *SIX MILLION NINE HUNDRED EIGHTY FOUR THOUSAND SIX HUNDRED EIGHTY FOUR PESOS & 18/100 CTVS.* (£ 6,984,684.18) by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

#### NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

  - (d) Invitation to Bid;
  - (e) Instructions to Bidders;
  - (f) Bid Data Sheet;
  - (g) Addenda and/or Supplemental/Bid Bulletins, if any;
  - (h) Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes;

- (i) Eligibility requirements, documents and/or statements;
- (j) Performance Security;
- (k) Notice of Award of Contract and the Bidder's conforme thereto;
- (I) Other contract documents that may be required by existing laws and/or the Entity.
- 3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.
- 4. The Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
- 5. That the Contractor hereby certifies that the site was regularly inspected and verified
- The Contractor further undertakes to implement the awarded project in accordance with the approved plans, specifications and cost of contract.
