JOSEFINA G. BELMONTE**, in her capacity as City Mayor, herein after referred to as the **QUEZON CITY GOVERNMENT**;

- and -

A. C. MOJARES CONSTRUCTION, INC. DOING BUSINESS UNDER THE NAME & STYLE OF A. C. MOJARES CONSTRUCTION a domestic company duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with principal Office at *2nd Floor ACM Building, 400 Tandang Sora Avenue, Culiat, Quezon City* and herein represented by **MR. ALEJANDRO C. MOJARES** in his capacity as **PRESIDENT** hereinafter referred to as the **CONTRACTOR**;

WHEREAS, the QUEZON CITY GOVERNMENT is desirous that the Contractor execute for the **PROPOSED REHABILITATION (SURFACE IMPROVEMENT) AT PANGASINAN STREET, BARANGAY STO. CRISTO / ALICIA & PROJECT NO. 23-00066** and the City has accepted the Bid for **EIGHT MILLION THREE HUNDRED TWENTY SIX THOUSAND THREE HUNDRED THIRTY ONE PESOS & 55/100 CTVS. (P 8,326,331.55)** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.
4. The Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
5. That the Contractor hereby certifies that the site was regularly inspected and verified
6. The Contractor further undertakes to implement the awarded project in accordance with the approved plans, specifications and cost of contract.




