**CREATING THE STEERING COMMITTEE ON THE 28TH BARANGAY DAY
CELEBRATION IN QUEZON CITY ON SEPTEMBER 21, 2023**

WHEREAS, pursuant to the City Ordinance No. SP-280, Series of 1995 as amended by City Ordinance No. SP-1155, Series of 2002 and City Ordinance No. SP-2077, Series of 2011, respectively, the Quezon City Barangay Day is to be implemented in the City to give due recognition to the vital contributions of barangay officials to nation building and to forge stronger ties among all local elective officials which will redound to the benefit of all those residing and doing business in Quezon City;

WHEREAS, the 28th Barangay Day Celebration shall comply with all existing health and safety protocols being implemented by the Quezon City Government, in accordance with the guidelines set forth by the Inter-Agency Task Force for the Management of Emerging Infectious Diseases (IATF-MEID);

WHEREAS, under the principle of local autonomy, and pursuant to their duty and power to protect the general welfare, each barangay has implemented localized measures to protect the health and safety of their residents.

NOW THEREFORE, I, HON. MA. JOSEFINA G. BELMONTE, Mayor of Quezon City, by virtue of the powers vested in me by law, do order:

SECTION 1. CREATION. The Quezon City Steering Committee for the 28th Barangay Day Celebration is hereby created with the members stated below.

SECTION 2. COMPOSITION. The Steering Committee shall be composed of the following:

The Mayor may add/designate or remove members, as needed. Each member may send an authorized representative or alternate to any meeting of the Steering Committee.

SECTION 3. DUTIES AND FUNCTIONS. The Steering Committee shall perform all the duties and functions necessary to implement City Ordinance No. SP-280, Series of 1995 as amended by City Ordinance No. SP-1155, Series of 2002 and City Ordinance No. SP-2077, Series of 2011, respectively, and to thresh out the details of the 28th Quezon City Barangay Day Celebration.


SECTION 4. SECRETARIAT. The Barangay and Community Relations Department shall provide staff to act as Secretariat to the Steering Committee.

SECTION 5. FUNDING. Funding requirements shall be drawn from any available funds from the Office of the City Mayor and the Barangay and Community Relations Department.

SECTION 6. DISSEMINATION. A copy of this Executive Order shall be furnished to the Office of the President and the Metropolitan Manila Development Authority (MMDA) for information and guidance, pursuant to Section 455 (1) (xii) of RA7160, as amended, the 142 Barangays of Quezon City, and shall be posted at the official website of the Quezon City Government.

SECTION 7. EFFECTIVITY. This order shall take effect immediately.
