ORDINANCE NO. SP- 3188 , S-2023

AN ORDINANCE UPDATING THE CRITERIA AND GUIDELINES FOR THE SEAL OF GOOD HOUSEKEEPING IN ALL BARANGAYS OF QUEZON CITY, AMENDING ORDINANCE NOS. SP-3114, S-2022, AND SP-3125, S-2022.

WHEREAS, on 10 February 2014, the 19th Quezon City Council institutionalized the Seal of Good Housekeeping in Quezon City through the adoption of Ordinance No. SP-2273, S-2014, entitled "An Ordinance Adopting the Seal of Good Housekeeping in all Barangays of Quezon City";

WHEREAS, Ordinance No. SP-2273, S-2014 empowered the barangay officials to aspire for excellence as local leaders and take pride in all their initiatives as they practice good governance in the barangays;

WHEREAS, Ordinance No. SP-2273, S-2014 was later amended by Ordinance Nos. SP-2523, S-2016; SP-2588, S-2017; SP-2898, S-2020; SP-3114, S-2022; and finally, SP-3125, S-2022, all of which updated the performance indicators and expanded the awards given to the barangags;

WHEREAS, upon review of the 2022 implementation of the "Ordinance Adopting the Seal of Good Housekeeping in all barangays of Quezon City", the Technical Working Group resolved to submit recommendations to the 22nd City Council to amend and further streamline the criteria for the Seal of Good Housekeeping in the Barangays to align with the evolving needs and target goals of Quezon City;

WHEREAS, the 22nd City Council supports the recommendation of the Technical Working Group to amend and update the criteria of the Seal of Good Housekeeping to keep up with the current needs of our QCitizens.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. TITLE. - This Ordinance shall be known as the "2023 Ordinance on the Quezon City Seal of Good Housekeeping".

SECTION 2. OBJECTIVES. - This Ordinance is promulgated to:

- a. Promote excellence in public service in the barangays;
- b. Recognize the initiatives of the barangays in promoting the programs and projects of the City and national government;
- c. Promote transparency in data and records management;
- d. Encourage the sharing of programs and practices between the barangays; and
- e. Identify the services of the barangays that needs attention and development.

SECTION 3. COVERAGE. - All one hundred forty-two (142) barangays within the territorial jurisdiction of Quezon City.

SECTION 4. PERFORMANCE AREAS. - The criteria for the awards shall be on the following performance areas:

- a. Financial and Institutional Development:
 - 1. Full Disclosure Policy of the Department of the Interior and Local Government (DILG);

- 2. Accounting;
- 3. Budget;
- 4. Administrative Requirements;
- b. Social Services:
 - 1. Informal Settler Families and Housing;
 - 2. Social Welfare;
 - 3. Persons with Disabilities and Senior Citizens;
 - 4. Gender and Development, Violence Against Women, Women;
 - 5. Solo Parent;
 - 6. Children;
- c. Disaster Preparedness;
- d. Health Services:
 - 1. Non-Communicable Diseases;
 - 2. Dengue Prevention and Control;
 - 3. Barangay Health Emergency Response Team Functionality;
 - 4. Nutrition;
- e. Peace and Order and Public Safety and Anti-Drug Abuse Campaign:
 - 1. Peace and Order (Barangay Peace and Order Committee);
 - 2. Traffic and Road Clearing;
 - 3. Anti-Drug Abuse Campaign (Barangay Anti-Drug Abuse Council);
 - 4. Lupong Tagapamayapa;

- f. Business Friendliness and Competitiveness:
 - 1. Ease of Doing Business;
 - 2. Anti-Red Tape Authority;
- g. Legislative Services;
- h. Environmental Management.

SECTION 5. MAJOR AWARDS. - The Seal of Good Housekeeping shall have the following major awards:

- a. Dangal ng Lungsod Award All barangays who have garnered a total average score of at least 90% and above shall be given this award with a cash incentive of Five Hundred Thousand Pesos (Php500,000.00), as long as they shall not have a rating lower than 85% in any of the performance areas.
- b. Gawad sa Huwarang Pamamahala All barangays who have garnered a total average score of at least 85% shall be given this award with a cash incentive of Two Hundred Thousand Pesos (Php200,000.00), as long as they shall not have a rating lower than 80% in any of the performance areas.

SECTION 6. BARANGAY BEST PRACTICE AWARD AND OTHER SPECIAL CITATIONS. - Barangays who get a score of at least 90% and above on their chosen best practice or innovation shall receive a special award with a cash incentive of One Hundred Thousand Pesos (Php100,000.00).

All barangays who were able to get a score of at least 90% in any of the performance areas enumerated in Section 4 hereof shall also receive a noteworthy citation and a cash incentive of Fifty Thousand Pesos (Php50,000.00).

SECTION 7. UTILIZATION OF THE CASH INCENTIVE. - All cash awards provided under this Ordinance shall be utilized solely on programs, projects, and initiatives of the barangay, in furtherance of both national and local government goals and strategic thrusts, subject to existing accounting and auditing rules and regulations and the guidelines prescribed in the Implementing Rules and Regulations of this Ordinance.

SECTION 8. CREATION OF A TECHNICAL WORKING GROUP. - To ensure the implementation of this Ordinance, there shall be a Technical Working Group to be composed of representatives from the following offices:

- a. Office of the City Mayor;
- b. Office of the Vice Mayor;
- c. Office of the City Administrator;
- d. Office of the Secretary to the Sangguniang Panlungsod;
- e. Barangay and Community Relations Department;
- f. City Budget Department;
- g. City Accounting Department;
- h. DILG Quezon City Field Office;
- i. Business Permits and Licensing Department;
- j. Department of Sanitation and Clean-Up Works;
- k. Quezon City Health Department;
- l. Quezon City Disaster Risk Reduction and Management Office;
- m. Quezon City Anti-Drug Abuse Advisory Council;
- n. Department of Public Order and Safety;
- o. Transport and Traffic Management Department;
- p. Housing Community Development and Resettlement Department;
- q. Social Services Development Department.

SECTION 9. FUNCTIONS OF THE TECHNICAL WORKING GROUP. - The members of the Technical Working Group shall have the following functions:

- a. Oversee the implementation of this Ordinance, including the drafting of its Implementing Rules and Regulations;
- b. Create, review, and amend the indicators per performance area to ensure that it is continuously updated;
- c. Assess and validate the performance ratings of the barangays;

- d. Facilitate a post-review of the assessment year and recommend to the City Council any amendments to this Ordinance;
- e. Create a feedback system for the barangays that will effectively inform them of their performance in all areas that will serve as their guide to improve their services;
- f. Determine the best practices and innovation of barangays and create a program that will serve as a sharing or benchmarking platform for all other barangays; and
- g. Perform other functions necessary for the effective implementation of this Ordinance.

SECTION 10. ANNUAL APPROPRIATION. - The amount of Twenty Million Pesos (Php20,000,000.00) is hereby appropriated for the following purposes:

- a. Conduct of Information Campaign and Orientation with the barangays;
- b. Operational costs of the Technical Working Group;
- c. Cash awards, citations and plaques and the conduct of an Awarding Ceremony;
- d. Assessment and validation of data; and
- e. Book publication.

For the first year of implementation of this Ordinance, the amount provided in this Section shall be taken from any available funds of the City. Thereafter, the budget shall be included in the general funds which shall form part of the office budget of the Office of the City Mayor, subject to existing accounting and auditing rules and regulations.

The Office of the City Mayor may also allocate additional funding necessary for the full implementation of this Ordinance.

SECTION 11. IMPLEMENTING AGENCY. - The Barangay and Community Relations Department shall immediately convene the Technical Working Group and disseminate a copy of this Ordinance to the one hundred forty-two (142) barangays of Quezon City.

SECTION 12. IMPLEMENTING RULES AND REGULATIONS. - Within sixty (60) days from the approval of this Ordinance, the Technical Working Group shall formulate and issue the appropriate rules and regulations necessary for the effective and efficient implementation of this Ordinance.

SECTION 13. SEPARABILITY CLAUSE. - If any part or section of this Ordinance is declared unconstitutional for any reason whatsoever, such declaration shall not in any way affect the other parts or sections of this Ordinance.

SECTION 14. REPEALING CLAUSE. - All ordinances, resolutions, executive orders, rules, regulations, and other administrative issuances contrary to the provisions hereof are hereby amended or repealed accordingly.

SECTION 15. EFFECTIVITY CLAUSE. - This Ordinance shall take effect immediately upon its enactment and publication.
