ORDINANCE NO. SP- 3198 , S-2023

AN ORDINANCE AMENDING SECTION 1 OF ORDINANCE NO. SP-2160, S-2012, ENTITLED "AN ORDINANCE ADJUSTING THE ZONING CLASSIFICATION OF A PORTION OF THE UNIVERSITY OF THE PHILIPPINES, DILIMAN, QUEZON CITY, MORE SPECIFICALLY IDENTIFIED AS LOT NO. 42-C-12 OF TRANSFER CERTIFICATE OF TITLE NO. 27912 (192686), OTHERWISE KNOWN AS THE UP DILIMAN EAST CAMPUS PROPERTY, FROM INSTITUTIONAL (INST) TO SPECIAL URBAN DEVELOPMENT ZONE (SUDZ), PROVIDING CERTAIN CONDITIONS THEREFOR, AND FOR OTHER PURPOSES", CORRECTING THE LOCATION OF THE RECLASSIFIED LOT WHICH IS BARANGAY UP CAMPUS

WHEREAS, on May 21, 2012, the 18th City Council enacted Ordinance No. SP-2160, S-2012, entitled "An Ordinance Adjusting the Zoning Classification of a Portion of the University of the Philippines, Diliman, Quezon City, more specifically identified as Lot No. 42-C-12 of Transfer Certificate of Title No. 27912 (192686), otherwise known as the UP Diliman East Campus Property, From Institutional (Inst) To Special Urban Development Zone (SUDZ), Providing Certain Conditions therefor, and for other purposes";

WHEREAS, Section 1 of Ordinance No. SP-2160, S-2012 erroneously mentioned Barangay Pansol as the location of Lot No. 42-C-12 of UP Diliman East Campus Property instead of Barangay UP Campus, where UP Town Center is ultimately erected;

WHEREAS, such error led to confusion that UP Town Center is under the jurisdiction of Barangay Pansol;

WHEREAS, various offices of the Quezon City Government, namely the City Planning and Development Department, the Department of Building Official, and the Business Permits and Licensing Department, all agree that UP Town Center is under the jurisdiction of Barangay UP Campus;

WHEREAS, the Locational Clearance LC No. C-13-15636, evaluation sheet, and project evaluation of UP Town Center all recognize UP Campus as its barangay;

WHEREAS, there is a need to amend Ordinance No. SP-2160, S-2012 in order to properly reflect the true barangay of UP Town Center.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. Section 1 (Area Coverage) of Ordinance No. SP-2160, S-2012 is hereby amended to read as follows:

"SECTION 1. AREA COVERAGE. - In view of the redevelopment vision and proposed land uses in UP Diliman East Campus Property and subject to the conditions herein provided, Lot No. 42-C-12 under TCT No. RT-27912 (192686) with an area of approximately 85,505 square meters, located along Katipunan Avenue in Barangay UP Campus, Quezon City, is hereby reclassified from its present zoning classification of Institutional (INST) to Special Urban Development Zone (SUDZ)."

SECTION 2. REPEALING CLAUSE. - All previous issuances which are inconsistent with this Ordinance are hereby repealed or modified accordingly.
