This Contract made and entered in Quezon City, Metro Manila, this day of SEP 27 2023, by and between:

QUEZON CITY, a public corporation duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with principal office at City Hall, Diliman, Quezon City, Metro Manila and herein represented by **MA. JOSEFINA G. BELMONTE**, in her capacity as City Mayor, herein after referred to as the **QUEZON CITY GOVERNMENT**;

- and -

OSCORD BUILDERS CORPORATION JV WITH IREDDRAGON CONSTRUCTION SERVICES a domestic company duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with principal Office at No. 10 South AA Street, Barangay Paligsahan, Quezon City and herein represented by **MR. OSMUNDO CHRISTOPHER R. DIZON** in his capacity as **PRESIDENT** hereinafter referred to as the **CONTRACTOR**;

WHEREAS, the QUEZON CITY GOVERNMENT is desirous that the Contractor execute for the **PROPOSED REHABILITATION OF ROAD AND DRAINAGE AT PAJO STREET, BARANGAY QUIRINO 2-A & QUIRINO 2-B & PROJECT NO. 23-00069B** and the City has accepted the Bid for **SIXTY FIVE MILLION NINETY THOUSAND SIX HUNDRED THIRTY SIX PESOS & 86/100 CTVS. (P 65,090,636.86)** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

 - (h) Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes;

5. That the Contractor hereby certifies that the site was regularly inspected and verified
6. The Contractor further undertakes to implement the awarded project in accordance with the approved plans, specifications and cost of contract.


