This Contract made and entered in Quezon City, Metro Manila, this day of SEP 22 2023, by and between:

**QUEZON CITY**, a public corporation duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with principal office at City Hall, Diliman, Quezon City, Metro Manila and herein represented by **MA. JOSEFINA G. BELMONTE**, in her capacity as City Mayor, herein after referred to as the **QUEZON CITY GOVERNMENT**;

- and -

**CARAG BUILDERS, INC.** a domestic company duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with principal Office at *287 Ermin Garcia Street, Cubao, Quezon City* and herein represented by **MR. ROBERT JOSEPH L. CARAG** in his capacity as **CORPORATE TREASURER** hereinafter referred to as the **CONTRACTOR**;

WHEREAS, the QUEZON CITY GOVERNMENT is desirous that the Contractor execute for the **PROPOSED CONSTRUCTION OF SWIMMING POOL AT AMORANTO SPORTS COMPLEX (PHASE 3), BARANGAY PALIGSAHAN & PROJECT NO. 23-00081** and the City has accepted the Bid for **ONE HUNDRED TWENTY NINE MILLION ONE HUNDRED THIRTY ONE THOUSAND SIX HUNDRED FORTY ONE PESOS & 84/100 CTVS. (₱ 129,131,641.84)** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

The Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
  5. That the Contractor hereby certifies that the site was regularly inspected and verified
  6. The Contractor further undertakes to implement the awarded project in accordance with the approved plans, specifications and cost of contract.


