This Contract made and entered in Quezon City, Metro Manila, this day of <u>spp 22 2023</u>, by and between:

QUEZON CITY, a public corporation duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with principal office at City Hall, Diliman, Quezon City, Metro Manila and herein represented by MA. JOSEFINA G. BELMONTE, in her capacity as City Mayor, herein after referred to as the QUEZON CITY GOVERNMENT;

- and -

MF TIBAYAN CONSTRUCTION AND TRADING CORPORATION a domestic company duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with principal Office at 36 Sixto Extension, Tandang Sora, Quezon City and herein represented by MS. MARISSA F. TIBAYAN in her capacity as PRESIDENT/GENERAL MANAGER hereinafter referred to as the CONTRACTOR;

WHEREAS, the QUEZON CITY GOVERNMENT is desirous that the Contractor execute for the **PROPOSED REHABILITATION OF PAVEMENT AND DRAINAGE OF UP VILLAGE BARANGAY HALL, BARANGAY UP VILLAGE & PROJECT NO. 23-**00085 and the City has accepted the Bid for **TWO MILLION EIGHT HUNDRED SEVENTY FOUR THOUSAND EIGHT HUNDRED EIGHTY SEVEN PESOS & 34/100 CTVS.** (**P** 2,874,887.34) by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

- The Entity hereby covenants to pay the Contractor in consideration of the 4. execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
- That the Contractor hereby certifies that the site was regularly inspected 5. and verified
- The Contractor further undertakes to implement the awarded project in 6. accordance with the approved plans, specifications and cost of contract.
