CONTRACT AGREEMENT

This Contract made and entered in Quezon City, Metro Manila, this day of SFP 22 2023, by and between:

QUEZON CITY, a public corporation duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with principal office at City Hall, Diliman, Quezon City, Metro Manila and herein represented by MA. JOSEFINA G. BELMONTE, in her capacity as City Mayor, herein after referred to as the QUEZON CITY GOVERNMENT;

- and -

CRAFTSMEN DEVELOPMENT & CONSTRUCTION CORP. a domestic company duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with principal Office at 72 Sct. Tuason Street, South triangle, Quezon City and herein represented by MR. ROBERTO B. INUMERABLE in his capacity as PRESIDENT hereinafter referred to as the CONTRACTOR;

WHEREAS, the QUEZON CITY GOVERNMENT is desirous that the Contractor execute for the *PROPOSED REHABILITATION OF ROAD AND DRAINAGE AT PAGATPAT STREET, BARANGAY VETERANS VILLAGE & PROJECT NO.* 23-00091 and the City has accepted the Bid for *TEN MILLION FOUR HUNDRED THIRTY EIGHT THOUSAND SEVEN HUNDRED TWENTY THREE PESOS & 50/100 CTVS.* (\$\mathbb{P}\$ 10,438,723.50) by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
- The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, to wit:
 - (a) General and Special Conditions of Contract;
 - (b) Drawings/Plans;
 - (c) Specifications;
 - (d) Invitation to Bid;
 - (e) Instructions to Bidders;
 - (f) Bid Data Sheet;
 - (g) Addenda and/or Supplemental/Bid Bulletins, if any;
 - (h) Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes;
 - (i) Eligibility requirements, documents and/or statements;

- (j) Performance Security;
- (k) Notice of Award of Contract and the Bidder's conforme thereto;
- (I) Other contract documents that may be required by existing laws and/or the Entity.
- In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.
- 4. The Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
- 5. That the Contractor hereby certifies that the site was regularly inspected and verified
- 6. The Contractor further undertakes to implement the awarded project in accordance with the approved plans, specifications and cost of contract.
