WHEREAS, the **QUEZON CITY GOVERNMENT** is desirous that the Consultant execute **CONSULTING SERVICES FOR THE QUEZON CITY BUSINESS ECOSYSTEM RESEARCH** with project number **CONSUL-23-001**.  - (g) Bid forms, including all the documents/statements contained in the Bidder’s bidding envelopes, as annexes, and all other documents/ statements submitted (e.g., bidder’s response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity’s bid evaluation;

The **QUEZON CITY GOVERNMENT** hereby covenants to pay the **PHILIPPINES INSIGHTASIA, INC.** in consideration of the execution and completion of the Consulting Services, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.

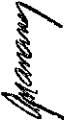
