A RESOLUTION ON THE RECOMMENDATION TO AWARD TO R.S JARDIN AND ASSOCIATES FOR THE CONSULTING SERVICES FOR THE CONDUCT OF GEOTECHNICAL INVESTIGATION FOR VARIOUS INFRASTRUCTURE PROJECTS

WHEREAS, a Request for Expression of Interest was posted in the PHILGEPS, Quezon City website and at conspicuous places of Quezon City Hall Complex premises for the Public Bidding of the CONSULTANCY SERVICES FOR THE CONDUCT OF GEOTECHNICAL INVESTIGATIONS FOR VARIOUS INFRASTRUCTURE PROJECTS with project number CONSUL-23-002;

WHEREAS, the Approved Budget for the Contract (ABC) is in the total amount of Three Million Seven Hundred Thousand Pesos Only (Php 3,700,000.00);

WHEREAS, seven (7) prospective consultants responded to the Request for Expression of Interest and obtained eligibility documents within the scheduled issuance period, namely:

- 1. R.S Jardin and Associates
- 2. RMM Geotechnical Services
- 3. Solar Surveying Corporation
- 4. KS Construction Materials Testing Center
- 5. Terms Concrete Testing
- 6. Arma NPrecision Materials testing Laboratory and Geotechnical Services Corp.
- 7. Anchors Geotechnical Consulting Services

WHEREAS, the Bids and Awards Committee on Infrastructure and Consultancy (BAC) conducted the opening of eligibility proposals of the prospective Consultants on July 21, 2023 for consulting services bidding pursuant to Section 24.4.1 Rule VIII of the 2016 Revised IRR of R.A. 9184;

WHEREAS, the prospective Consultants' eligibility proposals had undergone the preliminary assessment and shortlisting process pursuant to Section 24.4.2 Rule VIII and Section 30.1 Rule IX of the 2016 Revised IRR of R.A. 9184, the result of which are as follows:

WHEREAS, as required in the Eligibility Documents, shortlisted consultants must obtain a minimum passing score of 70% and the prospective consultants who will be entitled to submit bids shall not exceed to three (3).

WHEREAS, R.S Jardin and Associates, Solar Surveying Corporation, and Anchors Geotechnical Consulting Services, being the top three (3) highest eligibility scores, passed the shortlisting process;

WHEREAS, the Technical Working Group (TWG) recommended to the Bids and Awards Committee the qualifications of R.S Jardin and Associates, Solar Surveying Corporation, and Anchors Geotechnical Consulting Services in the shortlisting process for the Consultancy Services for the Conduct of Geotechnical Investigations for Various Infrastructure Projects;

WHEREAS, the BAC confirms and approves the recommendation of the TWG for the qualifications of R.S Jardin and Associates, Solar Surveying Corporation, and Anchors Geotechnical Consulting Services in the shortlisting process for the Consulting Services for the Conduct of Geotechnical Investigations for Various Infrastructure Projects;

WHEREAS, the Shortlisted consultants were notified for the submission of their technical proposals for the opening of bids held on September 13, 2023;

WHEREAS, R.S Jardin and Associates, Solar Surveying Corporation, and Anchors Geotechnical Consulting Services complied with all the requirements subject for detailed technical evaluation;

WHEREAS, the TWG conducted the detailed evaluation on the technical bid proposal of R.S Jardin and Associates, Solar Surveying Corporation, and Anchors Geotechnical Consulting Services based on the following criteria as stated in the Terms of Reference (Quality-Cost Based Evaluation):

- 20% Financial Proposal
- 80% Technical Proposal
 - (50% Quality of personnel to be assigned to the project)
 - (40% Experience and capability of the consultant)
 - (10% Plan of approach and Methodology)

WHEREAS, the following are the results of the detailed evaluation on the technical proposal of R.S Jardin and Associates, Solar Surveying Corporation, and Anchors Geotechnical Consulting Services;

WHEREAS, based on the results of the evaluation, R.S Jardin and Associates, Solar Surveying Corporation, and Anchors Geotechnical Consulting Services obtained passing scores of 94%, 97%, and 90%, respectively;

WHEREAS, the TWG recommended to the BAC for the opening of the financial proposal of R.S Jardin and Associates, Solar Surveying Corporation, and Anchors Geotechnical Consulting Services for the public bidding of the Consulting Services for the Conduct of Geotechnical Investigations for Various Infrastructure Projects for the purpose of completing the Quality-Cost based evaluation procedure for this consultancy services pursuant to Sec. 33.2.1 b) Rule IX of the 2016 Revised IRR of R.A. 9184;

WHEREAS, the BAC confirmed and approved the recommendation of the TWG for the opening of the financial proposal of R.S Jardin and Associates, Solar Surveying Corporation, and Anchors Geotechnical Consulting Services for the public bidding of Consulting Services for the Conduct of Geotechnical Investigations for Various Infrastructure Projects for the purpose of completing the Quality-Cost based evaluation procedure for this consultancy services pursuant to Sec. 33.2.1 b) Rule IX of the 2016 Revised IRR of R.A. 9184.

WHEREAS, the shortlisted Consultant's financial proposals were opened on September 21, 2023 the result of which are as follows:

WHEREAS, as stated in the Terms of Reference for the bidding of this consultancy service, the bid proposals of the prospective Consultants shall be evaluated using the Quality-Cost Based Evaluation. The Technical proposal shall be given a weight of 80% whereas the financial proposal shall be given a weight of 20%

WHEREAS, the Technical Working Group (TWG) computed the rating of each financial proposal in the following manner:

- a. The Firm/Consultant with the lowest bid price proposal gets 100 points; and
- b. The score of the other Firm/Consultant will be computed using the formula:

SF = 100 x Fl/F

Where:

SF = Financial Score

Fl = Lowest Financial Proposal

F = Financial Proposal under consideration

WHEREAS, pursuant to Sections 33 Rule X of the 2016 Revised IRR of R.A. 9184 the technical proposal and financial proposal submitted by R.S Jardin and Associates emerged as the Highest Rated Bid with a total rating/score of 95.2% while Solar Surveying Corporation obtained a rating/score of 92.18% and Anchors Geotechnical Consulting Services obtained a rating/score of 86%;

WHEREAS, the Technical Working Group (TWG) recommended to the Bids and Awards Committee (BAC) to declare R.S Jardin and Associates as the Highest Rated Bid for the public bidding of the Consulting Services for the conduct of Geotechnical Investigation for Various Infrastructure Projects;

WHEREAS, The Technical Working Group (TWG) also recommended to the Bids and Awards Committee (BAC) to proceed with the negotiation with R.S Jardin and Associates (Highest Rated Bid) pursuant to Sec. 33.2.5 of the 2016 Revised IRR of R.A. 9184 and to subject the said Consultant to post qualification process in accordance to Sec. 34, Rule X of the 2016 Revised IRR of R.A. 9184;

WHEREAS, the Bids and Awards Committee (BAC) confirms and approves the recommendation of the Technical Working Group (TWG) to R.S Jardin and Associates as the Highest Rated Bid for the public bidding of the Consulting Services for the conduct of Geotechnical Investigation for Various Infrastructure Projects; *FURTHER*, the Bids and Awards Committee (BAC) also approved and confirmed the recommendation of the Technical Working Group (TWG) to proceed with the negotiation with R.S Jardin and Associates pursuant to Sec. 33.2.5 of the 2016 Revised IRR of R.A. 9184 and to subject the said Consultant to post qualification process in accordance to Sec. 34, Rule X of the 2016 Revised IRR of R.A. 9184;

WHEREAS, as required under Sec. 34.2 Rule X of the Revised IRR of R.A. 9184, R.S Jardin and Associates submitted their latest income and business tax returns, and other appropriate licenses and permits required in the bidding documents;

WHEREAS, pursuant to Sec.34.3 Rule X of the Revised IRR of R.A. 9184, the Bids and Awards Committee (BAC) through the Technical Working Group (TWG) verified, validated and ascertained all statements made and documents submitted by R.S Jardin and Associates with the Highest Rated Bid, such as but not limited to, Legal, Technical and Financial requirements;

WHEREAS, pursuant to Sec. 34.4 Rule X of the Revised IRR of R.A. 9184, upon confirmation and ascertainment of the Technical, Legal and Financial capability of R.S Jardin and Associates, to fulfill the obligation for Consulting Services for the conduct of Geotechnical Investigation for Various Infrastructure Projects, the Bids and Awards Committee (BAC) through the Technical Working Group (TWG) to declare R.S Jardin and Associates as the Highest Rated and Responsive Bid (HRRB) and award the contract to R.S Jardin and Associates for the consultancy service being bid out;

WHEREFORE, the Bids and Awards Committee (BAC), upon confirmation and ascertainment of the Technical, Legal and Financial capability of R.S Jardin and Associates to fulfill the obligation for Consulting Services for the conduct of Geotechnical Investigation for Various Infrastructure Projects, confirms and approves the recommendation of the Technical Working Group (TWG) to declare R.S Jardin and Associates as the Highest Rated and Responsive Bid (HRRB) for the consultancy service being bid out; **FURTHER**, the Bids and Awards Committee (BAC) also confirms and approves the recommendation of the Technical Working Group (TWG) for the award of contract to R.S Jardin and Associates for the consultancy service being bid out;
