ORDINANCE NO. SP- 3217 , S-2023

AN ORDINANCE ALLOWING ONE-SIDE STREET PARKING AND ONE-WAY TRAFFIC SCHEME IN SELECTED STREETS OF PANSOL PROPER, BARANGAY PANSOL, QUEZON CITY.

WHEREAS, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that:

"Every local government unit shall exercise the powers expressly granted those necessarily implied therefrom as well as powers necessary, appropriate, or incidental for its efficient governance, and those which are essential to the promotion of the general welfare. Within their respective jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among residents, maintain peace and order and preserve the comfort and convenience of these inhabitants."

WHEREAS, the Local Government Unit of Barangay Pansol, Quezon City passed Barangay Resolution No. 58, S-2018, entitled "A Resolution requesting the City Council to enact an Ordinance for Barangay Pansol for the direction of traffic flow along streets of Pansol Proper, Barangay Pansol, Quezon City";

WHEREAS, the Local Government Unit of Barangay Pansol, Quezon City passed Barangay Resolution No. 163, S-2019, entitled "A Resolution requesting the City Council to enact an Ordinance allowing one-side street parking at N. Perez Street, Barangay Pansol, District III, Quezon City";

WHEREAS, use of both sides of the streets for parking creates traffic bottlenecks, unnecessary delays, and loss of precious man-hours considering the width of the road and the volume of the vehicles passing through Pansol Avenue;

WHEREAS, residents of the area are affected by the irresponsible parking of vehicles on both sides of the streets even on driveways especially by non-residents of Barangay Pansol;

WHEREAS, the Sangguniang Barangay of Pansol enacted a resolution regulating the parking of vehicles along P. Bautista Street and N. Perez Street, and allowing one-side parking in answer to various complaints of residents who are affected by the irresponsible parking of motor vehicles on both sides of the streets, including driveways;

WHEREAS, the Secretary to the Sangguniang Panlungsod requested the Traffic and Transport Management Department (TTMD) of Quezon City for comments and suggestions, getting response in return with suggestions that one-side parking at P. Bautista Street and N. Perez Street is on left side of the road going to Pansol Avenue, and one-way also going to Pansol Avenue.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. This Ordinance shall be known as the "One-Side Street Parking and One-Way Traffic Scheme in P. Bautista and N. Perez Street of Barangay Pansol."

SECTION 2. IMPLEMENTING RULES AND REGULATIONS. - The Traffic and Transport Management Department (TTMD) of Quezon City shall formulate and issue the necessary rules and regulations for the effective implementation of this Ordinance.

SECTION 3. It is hereby prohibited to park on both sides in Barangay Pansol Avenue and declaring a one-way traffic scheme in P. Bautista Street and N. Perez Street.

SECTION 4. Violation of Section 3 of this Ordinance shall be penalized with the fines provided under Sections 11 and 24 of Ordinance No. SP-3172, S-2023 otherwise known as the Metro Manila Traffic Code of 2023.

SECTION 5. REPEALING CLAUSE. - All ordinances, resolutions, and rules and regulations inconsistent with the provisions of this Ordinance are hereby repealed, amended, or modified accordingly.

SECTION 6. EFFECTIVITY CLAUSE. - This Ordinance shall take effect immediately upon its approval.
