WHEREAS, the Quezon City Council enacted City Ordinance No. SP-2812, S-2019 entitled "An Ordinance Converting the Quezon City Polytechnic University to Quezon City University and Enhancing its Charter, Thereby Amending City Ordinances Nos. SP-1945, S-2009 and SP-1030, S-2001";

WHEREAS, in support of the aforementioned Ordinance, Ordinance No. SP-2971, S-2020 entitled "An Ordinance Creating New Plantilla Positions for Quezon City University and to Appropriate the Funds Needed Thereof," was enacted;

WHEREAS, to comply with the Local Budget Circular No. 137 and the Quality Standards issued by the Civil Service Commission, there is a need to amend Ordinance No. SP-2971, S-2020 to align the positions and qualifications with national rules and regulations.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. Section 3 of Ordinance No. SP-2971, S-2020 is hereby amended to revise the position titles, salary grade, and qualifications of the following positions:

- a. Librarian II
- b. Nurse II
- c. University Registrar III
- d. Guidance Counsellor I
- e. Guidance Counsellor II

The position titles, salary grade, and qualifications of the abovementioned positions shall be revised as follows:

Registrar III	18	 Bachelor's Degree Two (2)-year relevant experience Eight (8) hours of relevant training Career Service (Professional) Second Level Eligibility
Guidance Counsellor I	11	 Bachelor's Degree relevant to the job No required experience and training Career Service (Professional) Second Level Eligibility
Guidance Counsellor II	12	 Bachelor's Degree relevant to the job No required experience and training Career Service (Professional) Second Level Eligibility

SECTION 2. REPEALING CLAUSE. – All Quezon City ordinances, resolutions, executive orders, memorandum Circulars and Administrative regulations, or parts thereof which are inconsistent with any of the provisions of this Ordinance are hereby repealed or modified accordingly.

SECTION 3. SEPARABILITY CLAUSE. – If any part or provision of this Ordinance shall be held unconstitutional or invalid, other parts or provisions hereof which are not affected thereby shall continue to be in full force and effect.

SECTION 4. EFFECTIVITY CLAUSE. – This Ordinance shall take effect fifteen (15) days after publication in at least one (1) newspaper of general circulation.
