CONTRACT AGREEMENT

THIS AGREEMENT, made and entered in City, Metro Manila, this day of JAN 05 2024 , by and between:

QUEZON CITY, a public corporation duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with principal office at City Hall, Diliman, Quezon City, Metro Manila and herein represented by MA. JOSEFINA G. BELMONTE, in her capacity as City Mayor, herein after referred to as the QUEZON CITY GOVERNMENT;

- and -

GUILLAND CONSTRUCTION & TRADING a domestic company duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with principal Office at *Blk. 5 lot 44 Amarilyo Crest, Havila, Taytay, Rizal* and herein represented by MS. RUBY D. BUENAVENTURA in her capacity as GENERAL MANAGER hereinafter referred to as the CONTRACTOR;

WHEREAS, the QUEZON CITY GOVERNMENT is desirous that the Contractor execute for the *PROPOSED UPGRADING OF ELECTRICAL SYSTEM AND REHABILITATION OF INSIDE GUTTER AND CEILING OF PAGCOR BUILDING AT CUBAO ELEMENTARY SCHOOL, BARANGAY E. RODRIGUEZ & PROJECT NO. 23-00155* and the City has accepted the Bid for *FIVE MILLION EIGHT HUNDRED EIGHTEEN THOUSAND SEVEN HUNDRED THIRTY TWO PESOS & 45/100 CTVS.* (\$\mathcal{P}\$ 5,818,732.45) by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
- 2. The following documents as required by the 2016 revised implementing Rules and Regulations of the Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, to wit:
 - a. Philippine Bidding Documents (PBDs);
 - i. Drawings/Plans;
 - ii. Specifications;
 - iii. Bill of Quantities;
 - iv. General and Special Conditions of Contract;
 - v. Supplemental of Bid Bulletins, if any;

b. Winning bidder's bid, including the Eligibility requirements, Technical and Finacial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (Bidder's response to request for clarification on the bid), including corrections to the bid, if any, resulting from the Entity's bid evaluation;

- c. Performance Security;
- d. Notice of Award and Contract and the Bidder's conforme thereto and
- e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.
- 4. The Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
- 5. That the Contractor hereby certifies that the site was regularly inspected and verified
- 6. The Contractor further undertakes to implement the awarded project in accordance with the approved plans, specifications and cost of contract.
