- (j) Notice of Award of Contract and the Bidder's conforme;
- (k) Other contract documents that may be required by existing laws and/or the Entity.

In consideration of the payments to be made by **TUV RHEINLAND PHILIPPINES, INC.** as hereinafter mentioned, the Consultant hereby covenants with the Entity to execute and complete the Consulting Services and remedy any defects therein in conformity with the provisions of this Consultant in all respects.

The QUEZON CITY GOVERNMENT hereby covenants to pay the TUV RHEINLAND PHILIPPINES, INC. in consideration of the execution and completion of the Consulting Services, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
