



CONTRACT AGREEMENT

THIS AGREEMENT, made this DEC 13 2023 day of _____, 2023 between **QUEZON CITY** with principal office at City Hall, Diliman, Quezon City, Metro Manila, represented herein by its City Mayor, **MA. JOSEFINA G. BELMONTE** (hereafter referred to as "**QUEZON CITY GOVERNMENT**")

WOODFIELDS CONSULTANTS, INC. with office address at Unit 2B, No. 10 Apo St., Metro Montaña Village, Burgos Rodriguez Rizal represented herein by President and CEO, **ARNEL B. NACION** (hereafter called the "Consultant").

WHEREAS, the QUEZON CITY GOVERNMENT is desirous that the Consultant execute **CONSULTANCY SERVICES FOR WATER QUALITY TESTING AND ANALYSIS OF WATERWAYS AND TRIBUTARIES OF SAN JUAN RIVER** with project number **CONSUL-23-003**. (hereafter called "the Services") and the QUEZON CITY GOVERNMENT has accepted the bid for **NINE HUNDRED NINETY-EIGHT THOUSAND PESOS ONLY (PHP 998,000.00)** (hereafter called "the Contract Price") by the Consultant for the execution and completion of such Consulting Services and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

 - (g) Bid forms, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents/ statements submitted (e.g., bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

The **QUEZON CITY GOVERNMENT** hereby covenants to pay the **WOODFIELDS CONSULTANTS, INC.** in consideration of the execution and completion of the Consulting Services, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.


