CREATING AND CONSTITUTING THE QUEZON CITY'S 85TH FOUNDA FION DAY TECHNICAL WORKING GROUP

WHEREAS, Commonwealth Act 502, as amended, was signed into law by President Manuel Luis Quezon on October 12, 1939, creating a public corporation which thereafter bears his name - Quezon City;

WHEREAS, Quezon City annually celebrates its Founding Anniversary with meaningful and fitting ceremonies and celebration;

WHEREAS, to ensure a smooth and successful celebration of the 85th Founding Anniversary of the City, there is a need to constitute a technical working group that shall prepare, coordinate and initiate a synchronized series of events and activities in connection with this celebration;

NOW THEREFORE, I, MA. JOSEFINA G. BELMONTE, Mayor of Quezon City, by virtue of the power voted in me by law, do hereby order:

SECTION 1. CONSTITUTION AND COMPOSITION. The Technical Working Group is hereby created and organized to facilitate the preparation and execution of activities for the 85th Foundation Day of Quezon City, to be composed of the following;



The Secretariat shall be appointed by the City Mayor to work with the Technical Working Group and shall be composed of personnel from the Office of the City Mayor, Office of the City Administrator, and Quezon City Tourism Department.

The Chairperson may add or remove members of the TWG as may be necessary to accomplish the task of the TWG.

SECTION 2. MANDATE OF THE TECHNICAL WORKING GROUP. The Technical Working Group shall have the following mandate;

- a. Integrate all projects and programs of the City Government relative to the celebration of 85th Foundation Day of the City;
- b. Undertake all necessary action for the efficient and seamless implementation of the said projects and programs;
- c. Collaborate closely with the relevant departments and offices tasked to undertake the said projects and programs; and
- d. Perform such duties and responsibilities that the City Mayor may assign as need arises.

SECTION 3. OPERATIONAL FUND. The Operational Fund for the 85th Foundation Anniversary shall be charged against the 2024 appropriations under the Office of the City Mayor.

Funding for other activities of the different offices and department in celebration of the 85th Foundation Anniversary shall be charged to available funds under each Department/Office concerned.

SECTION 4. DISSEMINATION. A copy of this Executive Order shall be turnished to the Office of the President and Metropolitan Manila Development Authority (MMDA)for

information and guidance, pursuant to Section 455 (1) (xii) of RA 7l60, as amended, and shall be posed at the official website of the Quezon City Government.

SECTION 5. REPEALING CLAUSE. All orders and other issuances inconsistent herewith are hereby repealed or amended or modified accordingly.

SECTION 6. EFFECTIVITY. This Order shall take effect immediately.
