AN ORDINANCE CREATING PLANTILLA POSITIONS IN THE QUEZON CITY GENERAL HOSPITAL DRUG TESTING LABORATORY PURSUANT TO ORDINANCE NO. SP-2537, S-2016, ENTITLED "AN ORDINANCE MANDATING THE ESTABLISHMENT OF DRUG TESTING LABORATORIES IN THE QUEZON CITY GENERAL HOSPITAL, NOVALICHES DISTRICT HOSPITAL, QUEZON CITY HEALTH DEPARTMENT, AND THE QUEZON CITY DRUG TREATMENT AND REHABILITATION CENTER (TAHANAN), AND APPROPRIATING THE NECESSARY FUNDS FOR ITS OPERATION FOR THE YEAR 2017 WHICH SHALL BE INCLUDED IN THE ANNUAL BUDGET" AND FOR OTHER PURPOSES

WHEREAS, Quezon City Ordinance No. SP-2537, S-2016 entitled "An Ordinance Mandating the Establishment of Drug Testing Laboratories in the Quezon City General Hospital, Novaliches District Hospital, Quezon City Health Department, and the Quezon City Drug Treatment and Rehabilitation Center (TAHANAN), and Appropriating the Necessary Funds for its Operation for the Year 2017 which shall be included in the Annual Budget" approved on December 5, 2016, establishes the Drug Testing Laboratories in the Quezon City General Hospital and other Quezon City hospitals which shall be responsible for all requirements for drug testing that will be required by the Quezon City Government;

WHEREAS, pursuant to the said Ordinance, the Quezon City General Hospital allocated in its budget, Php4,638,971.30 for the establishment of the drug testing laboratory which is now located at the Out-Patient Department with these available equipment: 1 biomedical refrigerator, 1 freezer and 3 laptops;

WHEREAS, the Quezon City General Hospital is currently in the process of completing the requirements for the approval of the Department of Health of the License to Operate for its Drug Testing Laboratory;

WHEREAS, there is a need to create plantilla positions in order to establish the necessary human resources needed in order to operate the said drug testing laboratory in QCGH;

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. It is hereby established the Quezon City General Hospital – Drug Testing Laboratory under the supervision of the Pathology Department of the Quezon City General Hospital which shall have the following functions:

- 1. Establish a program addressing the mandate of Republic Act No. 9165, otherwise known as the Comprehensive Dangerous Drugs Act of 2002;
- 2. Implement guidelines issued by the Hospital Director and the Quezon City Government on programs and strategies to combat the narco problems;
- 3. Safeguard the integrity of the specimen that is collected from a person for testing; and
- 4. Comply with the guidelines of Department of Health and Dangerous Drugs Board.

SECTION 2. The Quezon City General Hospital Drug Testing Laboratory shall be composed of health personnel trained to perform drug analysis and management for the efficient operation of the laboratory, as follows:

SECTION 3. The aforementioned health personnel shall perform duties as follows:

- 1. Medical Technologist II (with drug analysis proficiency)
 - Verify the completeness of Custody and Control Form.
 - Prepare specimen for analysis.
 - Examine, process and analyze specimen for drug testing.
 - Interpret, record, release and sign out laboratory results.
 - Assist in the evaluation of reagents, supplies and equipment.
 - Refer to the head of the laboratory when needed.
 - Perform National External Quality Assessment Scheme (NEQAS).

2. Laboratory Technician II (B)

- Ensure the security of the specimen at the collection site.
- Restrict unauthorized personnel to enter the collection site.
- Verify identity of the client.
- Provide security to specimen supplies, records and documents at the collection site.
- Assist in maintaining the laboratory supplies and equipment.
- Inform the client of the specimen collection procedure preferable to the process.
- Perform only one specimen collection at a time.
- Accept and seal the specimen container in the presence of the client.
- Accomplish accurately all the steps of Control and Custody Form.

3. Administrative Aide IV (Clerk II)

- Collect data of clients.
- Encode data and biometrics in IDTOMIS for verification.
- Ensure the accuracy and correctness of the data to be encoded.
- Advice client of the date and time of releasing of results.

SECTION 4. For 2022, the Quezon City General Hospital is hereby authorized to utilize any available unappropriated funds for the hiring of the health personnel necessary to operate the Drug Testing Laboratory. For the succeeding years, the Quezon City General Hospital shall include the funds needed for its operation in its annual budget proposal.

SECTION 7. This Ordinance shall take effect immediately upon its approval.
