



RESOLUTION NO. B004; S - 2024

DECLARING THE LOWEST CALCULATED AND RESPONSIVE BIDS AND RECOMMENDING APPROVAL FOR CONTRACT AWARDS

WHEREAS, the Quezon City Government, through the Bids and Awards Committee for Infrastructure (QC-BAC-Infra) downloaded an Invitation to Bid (ITB) dated March 21, 2024 in the Phil-GEPS and at conspicuous places in Quezon City Hall for the public bidding to be held on May 09, 2024, for nine (9) infrastructure projects of the City Government;

WHEREAS, a total of twenty three (23) Document Request List (DRL) to participate were received from prospective contractors and were issued bid documents;

WHEREAS, the QC-BAC Infra & Consultancy issued Notice of Postponement dated May 07, 2024 re-scheduling the date and submission and opening of bidding documents;

WHEREAS, during the scheduled public bidding held on May 16, 2024, twenty three (23) bid proposals were received and opened and, after examination of said documents, twenty two (22) were declared passed and their corresponding bid price read while four (4) were declared failed and for the Proposed Installation of Solar Power System at Quezon City General Hospital (Project No. 24-00055) was deferred;

WHEREAS, no motion/request for reconsideration was received by the QC-BAC-Infra from bidders whose bid were declared failed;

WHEREAS, by virtue of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184, otherwise known as the Government Procurement Reform Act, the BAC determines that the bidder with the Lowest Calculated Bid/Highest Rated Bid fails the criteria for post-qualification, it shall immediately notify the said bidder in writing of its post-disqualification and the grounds for it;

WHEREAS, evaluation of all bids received and rated passed and post-qualification of bidders with the lowest calculated bid submitted for each specific project have been conducted as prescribed in the Revised IRR of RA 9184;

NOW THEREFORE RESOLVED by the QC-BAC-Infra & Consultancy to declare the following bidders as having the lowest calculated and responsive bids submitted for the corresponding projects bid out by the QC-BAC-Infra & Consultancy on May 16, 2024:
