TERMS OF REFERENCE (TOR) PAMASKONG HANDOG 2024 AND GROCERY BAGS PROJECT NO. SSDD-24-GI2-1009

I. RATIONALE AND BACKGROUND

The Social Services Development Department is the welfare arm of the Quezon City Government that implements various program and services that respond to the issues and concerns of different disadvantaged sectors at the individual, group and community level. The primary concern of the Social Services Development Department, as the welfare arm of the City Government, is the improvement of the quality of life of the City's disadvantaged and vulnerable sector, through the provision of a timely, responsive, proactive and relevant social welfare programs and services. The City Mayor introduced her 14-point agenda which focuses on human and social services, economic development, environment and climate change, infrastructure and institutional development. One of the agenda of the Belmonte Administration under the Human and Social Services is to deliver responsive, efficient and cost-effective social services.

II. PROJECT DESCRIPTION

The Primary Needs Assistance for Underprivileged Families Program under the Social Services Development Department of Quezon City therefore propose to procure Pamaskong Handog and Grocery Bags as a government response to deliver cost-effective social services.

III. PROJECT SCOPE OF WORK

Supply and delivery of Pamaskong Handog and Grocery Bags for distribution to marginalized constituents of the various barangays and offices of the Quezon City Local Government.

IV. PROJECT STANDARD AND REQUIREMENTS

- A. As part of the requirement in the 2016 Revised Implementing Rules and Regulations of RA 9184 (updated as of 15 April 2024), the bidder must have completed within the last three (3) years a Single Largest Completed Contract (SLCC) that is similar to the project to be bid, and whose value, adjusted to current prices using the Philippine Statistics Authority (PSA) consumer price indices, must be at least fifty percent (50%) of the Approved Budget for the Contract (ABC).

- > CHEESE BALL Pasteurized Processed Cheese Food. Net weight of at least five hundred (500) grams
 - ➤ Product must be composed of natural cheddar cheese, water, milk solids (Buttermilk and Skimmed Milk Powder), milk Protein, Vegetable oil (may contain Coconut and/or Palm Oil), Disodium Phosphate (as Emulsifier), modified Food starches, Cornstarch, lodized salt, sugar, natural or nature identical cheese flavors, Nisin and Natamycin, paprika (as natural colorant) and acetic acid.
 - ▶ Product must be Halal certified by the Islamic Da'Wah Council of the Philippines or the Ulama Conference of the Philippines or a similar Halal accreditation body. The governing body's accreditation stamp must be evident on the label.
 - Actual product must be wrapped packed using PET/LLDPE pillow pouch to further protect the quality of cheese ball due to multiple handling and to maintain freshness of product.
 - Packed in a UV laminated claycote box with insert pad and tamperevident sticker seal.

 - Must be available in the Philippine Market. The manufacturer must have its name and address printed on the outer label.

- 6. PORK AND POULTRY MEAT SAUSAGE, 100% young pork Net weight of at least two hundred forty (240) grams
 - Product must be composed of pork and poultry fat, poultry meat, sugar, water, Vegetable protein, garlic, iodized salt, modified starch, spices and seasoning, skim milk, monosodium glutamate (flavor enhancer), carrageenan, phosphate (binder), and sodium nitrite (preservative)
 - Product must have edible casing (no need to peel off casing)

 - Product must be composed of natural cheddar cheese, water, milk solids (Buttermilk and Skimmed Milk Powder), milk Protein, Vegetable oil (may contain Coconut and/or Palm Oil), Disodium Phosphate (as Emulsifier), modified Food starches, Cornstarch, lodized salt, sugar, natural or nature identical cheese flavors, Nisin and Natamycin, paprika (as natural colorant) and acetic acid.

- **C.** The bidder shall submit an Authority to Sell from the Manufacturer of the frozen goods being offered for the Pamaskong Handog.
- **D.** The bidder shall be responsible for the repacking of all items to be delivered as individual Pamaskong Handog and Grocery Bags.
- E. The bidder must deliver to multiple delivery points one hundred percent (100%) of all the items in ninety (90) calendar days upon the issuance of the Notice to Proceed.
- **F.** The bidder must have at least one hundred fifty (150) pickers and packers for the project. This should be supported by Identification cards or proof of employment or engagement.
- **G.** The bidder must have one or more warehouse with a total of at least two thousand four hundred fifty-one square meters (2,451 sq.m.) floor space to be used for picking and packing of Grocery bags. This should be supported by a proof of ownership or lease of agreement for the place.
- **H.** The bidder must have at least twelve (12) units of dry trucks to be used for deliveries of Grocery Bags to multiple delivery points in Quezon City. This should be supported by proof of ownership or lease agreement(s).
- I. The bidder must have at least twenty-one (21) units of reefer vans to be used for deliveries of Pamaskong Handog to multiple delivery points in Quezon City. This should be supported by proof of ownership or lease agreement(s).

V. PROJECT DURATION

The project duration is within ninety (90) calendar days upon the issuance of the Notice to Proceed to the winning bidder.

VI. APPROVED BUDGET FOR THE CONTRACT

The approved budget for the contract (ABC) is **ONE BILLION THREE HUNDRED NINETY-NINE MILLION**, **NINE HUNDRED NINETY-EIGHT THOUSAND**, **TWO HUNDRED FORTY-ONE PESOS AND 98/100 ONLY (Php1,399,998,241.98)**.

The Project cost shall be fixed and there shall be no price adjustments applicable for the duration of the contract except when the operations costs are increased by 10% as a result of any extraordinary circumstances as determined by the National Economic Development Authority (NEDA). Pursuant to the provisions of RA 9184 and its RIRR on contract price escalation, all contract price escalation shall be approved by the Government Procurement Policy Board (GPPB).

V. BASIS OF PAYMENT

In consideration for the Supply and Delivery of Pamaskong Handog 2024 and Grocery Bags as provided herein, the City shall pay the winning bidder the contract price upon delivery of all the items.

VI. PENALTIES FOR BREACH OF CONTRACT

Failure to deliver the goods according to the standards and requirements set by the City shall constitute an offense and shall subject the supplier to penalties and/or liquidated damages pursuant to RA 9184 and its Revised Implementing Rules and Regulations (RIRR).

VII. CANCELLATION OR TERMINATION OF CONTRACT

The guidelines contained in RA 9184 and its Revised Implementing Rules and Regulations (RIRR) shall be followed in the termination of any contract. In the event the City terminated the Contract due to default insolvency, or for cause, it may enter into negotiated procurement pursuant to Section 53 (d) of RA 9184 and RIRR.
