## **Preface**

These Philippine Bidding Documents (PBDs) for the procurement of Infrastructure Projects (hereinafter referred to also as the "Works") through Competitive Bidding have been prepared by the Government of the Philippines for use by all branches, agencies, departments, bureaus, offices, or instrumentalities of the government, including government-owned and/or -controlled corporations, government financial institutions, state universities and colleges, local government units, and autonomous regional government. The procedures and practices presented in this document have been developed through broad experience, and are for mandatory use in projects that are financed in whole or in part by the Government of the Philippines or any foreign government/foreign or international financing institution in accordance with the provisions of the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

The PBDs are intended as a model for admeasurements (unit prices or unit rates in a bill of quantities) types of contract, which are the most common in Works contracting.

The Bidding Documents shall clearly and adequately define, among others: (i) the objectives, scope, and expected outputs and/or results of the proposed contract; (ii) the eligibility requirements of Bidders; (iii) the expected contract duration; and (iv)the obligations, duties, and/or functions of the winning Bidder.

Care should be taken to check the relevance of the provisions of the PBDs against the requirements of the specific Works to be procured. If duplication of a subject is inevitable in other sections of the document prepared by the Procuring Entity, care must be exercised to avoid contradictions between clauses dealing with the same matter.

Moreover, each section is prepared with notes intended only as information for the Procuring Entity or the person drafting the Bidding Documents. They shall not be included in the final documents. The following general directions should be observed when using the documents:

- a. All the documents listed in the Table of Contents are normally required for the procurement of Infrastructure Projects. However, they should be adapted as necessary to the circumstances of the particular Project.
- b. Specific details, such as the "name of the Procuring Entity" and "address for bid submission," should be furnished in the Instructions to Bidders, Bid Data Sheet, and Special Conditions of Contract. The final documents should contain neither blank spaces nor options.
- c. This Preface and the footnotes or notes in italics included in the Invitation to Bid, BDS, General Conditions of Contract, Special Conditions of Contract, Specifications, Drawings, and Bill of Quantities are not part of the text of the final document, although they contain instructions that the Procuring Entity should strictly follow.
- d. The cover should be modified as required to identify the Bidding Documents as to the names of the Project, Contract, and Procuring Entity, in addition to date of issue.

- e. Modifications for specific Procurement Project details should be provided in the Special Conditions of Contract as amendments to the Conditions of Contract. For easy completion, whenever reference has to be made to specific clauses in the Bid Data Sheet or Special Conditions of Contract, these terms shall be printed in bold typeface on Sections I (Instructions to Bidders) and III (General Conditions of Contract), respectively.
- f. For guidelines on the use of Bidding Forms and the procurement of Foreign-Assisted Projects, these will be covered by a separate issuance of the Government Procurement Policy Board.

# Glossary of Terms, Abbreviations, and Acronyms

**ABC** – Approved Budget for the Contract.

**ARCC** – Allowable Range of Contract Cost.

**BAC** – Bids and Awards Committee.

**Bid** – A signed offer or proposal to undertake a contract submitted by a bidder in response to and in consonance with the requirements of the bidding documents. Also referred to as *Proposal* and *Tender*. (2016 revised IRR, Section 5[c])

**Bidder** – Refers to a contractor, manufacturer, supplier, distributor and/or consultant who submits a bid in response to the requirements of the Bidding Documents. (2016 revised IRR, Section 5[d])

**Bidding Documents** – The documents issued by the Procuring Entity as the bases for bids, furnishing all information necessary for a prospective bidder to prepare a bid for the Goods, Infrastructure Projects, and/or Consulting Services required by the Procuring Entity. (2016 revised IRR, Section 5[e])

**BIR** – Bureau of Internal Revenue.

**BSP** – Bangko Sentral ng Pilipinas.

**CDA** – Cooperative Development Authority.

Consulting Services – Refer to services for Infrastructure Projects and other types of projects or activities of the GOP requiring adequate external technical and professional expertise that are beyond the capability and/or capacity of the GOP to undertake such as, but not limited to: (i) advisory and review services; (ii) pre-investment or feasibility studies; (iii) design; (iv) construction supervision; (v) management and related services; and (vi) other technical services or special studies. (2016 revised IRR, Section 5[i])

Contract – Refers to the agreement entered into between the Procuring Entity and the Supplier or Manufacturer or Distributor or Service Provider for procurement of Goods and Services; Contractor for Procurement of Infrastructure Projects; or Consultant or Consulting Firm for Procurement of Consulting Services; as the case may be, as recorded in the Contract Form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.

**Contractor** – is a natural or juridical entity whose proposal was accepted by the Procuring Entity and to whom the Contract to execute the Work was awarded. Contractor as used in these Bidding Documents may likewise refer to a supplier, distributor, manufacturer, or consultant.

**CPI** – Consumer Price Index.

**DOLE** – Department of Labor and Employment.

**DTI** – Department of Trade and Industry.

**Foreign-funded Procurement or Foreign-Assisted Project** – Refers to procurement whose funding source is from a foreign government, foreign or international financing institution as specified in the Treaty or International or Executive Agreement. (2016 revised IRR, Section 5[b]).

**GFI** – Government Financial Institution.

**GOCC** – Government-owned and/or –controlled corporation.

Goods – Refer to all items, supplies, materials and general support services, except Consulting Services and Infrastructure Projects, which may be needed in the transaction of public businesses or in the pursuit of any government undertaking, project or activity, whether in the nature of equipment, furniture, stationery, materials for construction, or personal property of any kind, including non-personal or contractual services such as the repair and maintenance of equipment and furniture, as well as trucking, hauling, janitorial, security, and related or analogous services, as well as procurement of materials and supplies provided by the Procuring Entity for such services. The term "related" or "analogous services" shall include, but is not limited to, lease or purchase of office space, media advertisements, health maintenance services, and other services essential to the operation of the Procuring Entity. (2016 revised IRR, Section 5[r])

**GOP** – Government of the Philippines.

**Infrastructure Projects** – Include the construction, improvement, rehabilitation, demolition, repair, restoration or maintenance of roads and bridges, railways, airports, seaports, communication facilities, civil works components of information technology projects, irrigation, flood control and drainage, water supply, sanitation, sewerage and solid waste management systems, shore protection, energy/power and electrification facilities, national buildings, school buildings, hospital buildings, and other related construction projects of the government. Also referred to as *civil works or works*. (2016 revised IRR, Section 5[u])

**LGUs** – Local Government Units.

**NFCC** – Net Financial Contracting Capacity.

**NGA** – National Government Agency.

**PCAB** – Philippine Contractors Accreditation Board.

**PhilGEPS** - Philippine Government Electronic Procurement System.

**Procurement Project** – refers to a specific or identified procurement covering goods, infrastructure project or consulting services. A Procurement Project shall be described, detailed, and scheduled in the Project Procurement Management Plan prepared by the agency which shall be consolidated in the procuring entity's Annual Procurement Plan. (GPPB Circular No. 06-2019 dated 17 July 2019)

**PSA** – Philippine Statistics Authority.

**SEC** – Securities and Exchange Commission.

**SLCC** – Single Largest Completed Contract.

**UN** – United Nations.

## Section I. Invitation to Bid

#### **Notes on the Invitation to Bid**

The Invitation to Bid (IB) provides information that enables potential Bidders to decide whether to participate in the procurement at hand. The IB shall be posted in accordance with Section 21.2 of the 2016 revised IRR of RA No. 9184.

Apart from the essential items listed in the Bidding Documents, the IB should also indicate the following:

- a. The date of availability of the Bidding Documents, which shall be from the time the IB is first advertised/posted until the deadline for the submission and receipt of bids;
- b. The place where the Bidding Documents may be acquired or the website where it may be downloaded;
- c. The deadline for the submission and receipt of bids; and
- d. Any important bid evaluation criteria.

The IB should be incorporated into the Bidding Documents. The information contained in the IB must conform to the Bidding Documents and in particular to the relevant information in the Bid Data Sheet.

## Section II. Instructions to Bidders

#### **Notes on the Instructions to Bidders**

This Section on the Instruction to Bidders (ITB) provides the information necessary for bidders to prepare responsive bids, in accordance with the requirements of the Procuring Entity. It also provides information on bid submission, eligibility check, opening and evaluation of bids, post-qualification, and on the award of contract.

#### 1. Scope of Bid

The Procuring Entity, Quezon City Government invites Bids for the PROPOSED INSTALLATION OF SOLAR POWER SYSTEM AT QUEZON CITY GENERAL HOSPITAL, with Project Identification Number 24-00092.

[Note: The Project Identification Number is assigned by the Procuring Entity based on its own coding scheme and is not the same as the PhilGEPS reference number, which is generated after the posting of the bid opportunity on the PhilGEPS website.]

The Procurement Project (referred to herein as "Project") is for the construction of Works, as described in Section VI (Specifications).

#### 2. Funding Information

- 2.1. The GOP through the source of funding as indicated below for 2024 in the amount of Twenty-One Million Eight Hundred Seven Thousand Three Hundred Thirty-Four Pesos and 21/100 Ctvs. (P 21,807,334.21).
- 2.2. The source of funding is:
  - a. LGUs, the Annual or Supplemental Budget, as approved by the Sanggunian.

#### 3. Bidding Requirements

The Bidding for the Project shall be governed by all the provisions of RA No. 9184 and its 2016 revised IRR, including its Generic Procurement Manual and associated policies, rules and regulations as the primary source thereof, while the herein clauses shall serve as the secondary source thereof.

Any amendments made to the IRR and other GPPB issuances shall be applicable only to the ongoing posting, advertisement, or invitation to bid by the BAC through the issuance of a supplemental or bid bulletin.

The Bidder, by the act of submitting its Bid, shall be deemed to have inspected the site, determined the general characteristics of the contracted Works and the conditions for this Project, such as the location and the nature of the work; (b) climatic conditions; (c) transportation facilities; (c) nature and condition of the terrain, geological conditions at the site communication facilities, requirements, location and availability of construction aggregates and other materials, labor, water, electric power and access roads; and (d) other factors that may affect the cost, duration and execution or implementation of the contract, project, or work and examine all instructions, forms, terms, and project requirements in the Bidding Documents.

#### 4. Corrupt, Fraudulent, Collusive, Coercive, and Obstructive Practices

The Procuring Entity, as well as the Bidders and Contractors, shall observe the highest standard of ethics during the procurement and execution of the contract. They or through an agent shall not engage in corrupt, fraudulent, collusive, coercive, and obstructive practices defined under Annex "I" of the 2016 revised IRR of RA No. 9184 or other integrity violations in competing for the Project.

#### 5. Eligible Bidders

- 5.1. Only Bids of Bidders found to be legally, technically, and financially capable will be evaluated.
- 5.2. The Bidder must have an experience of having completed a Single Largest Completed Contract (SLCC) that is similar to this Project, equivalent to at least fifty percent (50%) of the ABC adjusted, if necessary, by the Bidder to current prices using the PSA's CPI, except under conditions provided for in Section 23.4.2.4 of the 2016 revised IRR of RA No. 9184.

A contract is considered to be "similar" to the contract to be bid if it has the major categories of work stated in the **BDS**.

- 5.3. For Foreign-funded Procurement, the Procuring Entity and the foreign government/foreign or international financing institution may agree on another track record requirement, as specified in the Bidding Document prepared for this purpose.
- 5.4. The Bidders shall comply with the eligibility criteria under Section 23.4.2 of the 2016 IRR of RA No. 9184.

#### 6. Origin of Associated Goods

There is no restriction on the origin of Goods other than those prohibited by a decision of the UN Security Council taken under Chapter VII of the Charter of the UN.

#### 7. Subcontracts

7.1. The Bidder may subcontract portions of the Project to the extent allowed by the Procuring Entity as stated herein, but in no case more than fifty percent (50%) of the Project.

The Procuring Entity has prescribed that:

#### a. Subcontracting is not allowed.

- 7.1. [If Procuring Entity has determined that subcontracting is allowed during the bidding, state:] The Bidder must submit together with its Bid the documentary requirements of the subcontractor(s) complying with the eligibility criterial stated in **ITB** Clause 5 in accordance with Section 23.4 of the 2016 revised IRR of RA No. 9184 pursuant to Section 23.1 thereof.
- 7.2. [If subcontracting is allowed during the contract implementation stage, state:] The Supplier may identify its subcontractor during the contract implementation stage. Subcontractors identified during the bidding may be changed during the implementation of this Contract. Subcontractors must submit the documentary

requirements under Section 23.1 of the 2016 revised IRR of RA No. 9184 and comply with the eligibility criteria specified in **ITB** Clause 5 to the implementing or end-user unit.

7.3. Subcontracting of any portion of the Project does not relieve the Contractor of any liability or obligation under the Contract. The Supplier will be responsible for the acts, defaults, and negligence of any subcontractor, its agents, servants, or workmen as fully as if these were the Contractor's own acts, defaults, or negligence, or those of its agents, servants, or workmen.

#### 8. Pre-Bid Conference

The Procuring Entity will hold a pre-bid conference for this Project on the specified date and time and either at its physical address on August 02, 2024 at 10:00 AM at 2nd Floor, Procurement Department-Bidding Room, Finance Building, Quezon City Hall Compound and/or we encourage the prospective bidders to join through our Virtual Conference (ZOOM APP) Meeting ID: 854 9489 0133 Password: 273320

#### 9. Clarification and Amendment of Bidding Documents

Prospective bidders may request for clarification on and/or interpretation of any part of the Bidding Documents. Such requests must be in writing and received by the Procuring Entity, either at its given address or through electronic mail indicated in the **IB**, at least ten (10) calendar days before the deadline set for the submission and receipt of Bids.

# 10. Documents Comprising the Bid: Eligibility and Technical Components

- 10.1. The first envelope shall contain the eligibility and technical documents of the Bid as specified in **Section IX. Checklist of Technical and Financial Documents**.
- 10.2. If the eligibility requirements or statements, the bids, and all other documents for submission to the BAC are in foreign language other than English, it must be accompanied by a translation in English, which shall be authenticated by the appropriate Philippine foreign service establishment, post, or the equivalent office having jurisdiction over the foreign bidder's affairs in the Philippines. For Contracting Parties to the Apostille Convention, only the translated documents shall be authenticated through an apostille pursuant to GPPB Resolution No. 13-2019 dated 23 May 2019. The English translation shall govern, for purposes of interpretation of the bid.
- 10.3. A valid PCAB License is required, and in case of joint ventures, a valid special PCAB License, and registration for the type and cost of the contract for this Project. Any additional type of Contractor license or permit shall be indicated in the **BDS**.
- 10.4. A List of Contractor's key personnel (e.g., Project Manager, Project Engineers, Materials Engineers, and Foremen) assigned to the contract to be bid, with their

- complete qualification and experience data shall be provided. These key personnel must meet the required minimum years of experience set in the **BDS**.
- 10.5. A List of Contractor's major equipment units, which are owned, leased, and/or under purchase agreements, supported by proof of ownership, certification of availability of equipment from the equipment lessor/vendor for the duration of the project, as the case may be, must meet the minimum requirements for the contract set in the **BDS**.

#### 11. Documents Comprising the Bid: Financial Component

- 11.1. The second bid envelope shall contain the financial documents for the Bid as specified in **Section IX. Checklist of Technical and Financial Documents**.
- 11.2. Any bid exceeding the ABC indicated in paragraph 1 of the **IB** shall not be accepted.
- 11.3. For Foreign-funded procurement, a ceiling may be applied to bid prices provided the conditions are met under Section 31.2 of the 2016 revised IRR of RA No. 9184.

#### 12. Alternative Bids

Bidders shall submit offers that comply with the requirements of the Bidding Documents, including the basic technical design as indicated in the drawings and specifications. Unless there is a value engineering clause in the **BDS**, alternative Bids shall not be accepted.

#### 13. Bid Prices

All bid prices for the given scope of work in the Project as awarded shall be considered as fixed prices, and therefore not subject to price escalation during contract implementation, except under extraordinary circumstances as determined by the NEDA and approved by the GPPB pursuant to the revised Guidelines for Contract Price Escalation guidelines.

#### 14. Bid and Payment Currencies

- 14.1. Bid prices may be quoted in the local currency or tradeable currency accepted by the BSP at the discretion of the Bidder. However, for purposes of bid evaluation, Bids denominated in foreign currencies shall be converted to Philippine currency based on the exchange rate as published in the BSP reference rate bulletin on the day of the bid opening.
- 14.2. Payment of the contract price shall be made in:
  - a. Philippine Pesos.

#### 15. Bid Security

- 15.1. The Bidder shall submit a Bid Securing Declaration or any form of Bid Security in the amount indicated in the **BDS**, which shall be not less than the percentage of the ABC in accordance with the schedule in the **BDS**.
- 15.2. The Bid and bid security in no case shall exceed One Hundred Twenty (120) calendar days from the date of opening of bids, unless duly extended by the bidder upon the request of the Head of the Procuring Entity (HoPE) of the Quezon City Local Government. Any bid not accompanied by an acceptable bid security shall be rejected by the Procuring Entity as non-responsive.

#### 16. Sealing and Marking of Bids

Each Bidder shall submit one copy of the first and second components of its Bid.

The Procuring Entity may request additional hard copies and/or electronic copies of the Bid. However, failure of the Bidders to comply with the said request shall not be a ground for disqualification.

If the Procuring Entity allows the submission of bids through online submission to the given website or any other electronic means, the Bidder shall submit an electronic copy of its Bid, which must be digitally signed. An electronic copy that cannot be opened or is corrupted shall be considered non-responsive and, thus, automatically disqualified.

#### 17. Deadline for Submission of Bids

The Bidders shall submit on the specified date and time and either at its physical address or through online submission as indicated in paragraph 5 of the IB.

#### 18. Opening and Preliminary Examination of Bids

18.1. The BAC shall open the Bids in public at the time, on the date, and at the place specified in paragraph 9 of the **IB**. The Bidders' representatives who are present shall sign a register evidencing their attendance. In case videoconferencing, webcasting or other similar technologies will be used, attendance of participants shall likewise be recorded by the BAC Secretariat.

In case the Bids cannot be opened as scheduled due to justifiable reasons, the rescheduling requirements under Section 29 of the 2016 revised IRR of RA No. 9184 shall prevail.

18.2. The preliminary examination of Bids shall be governed by Section 30 of the 2016 revised IRR of RA No. 9184.

#### 19. Detailed Evaluation and Comparison of Bids

19.1. The Procuring Entity's BAC shall immediately conduct a detailed evaluation of all Bids rated "passed" using non-discretionary pass/fail criteria. The BAC shall consider the conditions in the evaluation of Bids under Section 32.2 of 2016 revised IRR of RA No. 9184.

- 19.2. If the Project allows partial bids, all Bids and combinations of Bids as indicated in the **BDS** shall be received by the same deadline and opened and evaluated simultaneously so as to determine the Bid or combination of Bids offering the lowest calculated cost to the Procuring Entity. Bid Security as required by **ITB** Clause 15 shall be submitted for each contract (lot) separately.
- 19.3. In all cases, the NFCC computation pursuant to Section 23.4.2.6 of the 2016 revised IRR of RA No. 9184 must be sufficient for the total of the ABCs for all the lots participated in by the prospective Bidder.

#### 20. Post Qualification

Within a non-extendible period of five (5) calendar days from receipt by the Bidder of the notice from the BAC that it submitted the Lowest Calculated Bid, the Bidder shall submit its latest income and business tax returns filed and paid through the BIR Electronic Filing and Payment System (eFPS), and other appropriate licenses and permits required by law and stated in the **BDS**.

#### 21. Signing of the Contract

The documents required in Section 37.2 of the 2016 revised IRR of RA No. 9184 shall form part of the Contract. Additional Contract documents are indicated in the **BDS**.

## Section III. Bid Data Sheet

#### **Notes on the Bid Data Sheet (BDS)**

The Bid Data Sheet (BDS) consists of provisions that supplement, amend, or specify in detail, information, or requirements included in the ITB found in Section II, which are specific to each procurement.

This Section is intended to assist the Procuring Entity in providing the specific information in relation to corresponding clauses in the ITB and has to be prepared for each specific procurement.

The Procuring Entity should specify in the BDS information and requirements specific to the circumstances of the Procuring Entity, the processing of the procurement, and the bid evaluation criteria that will apply to the Bids. In preparing the BDS, the following aspects should be checked:

- a. Information that specifies and complements provisions of the ITB must be incorporated.
- b. Amendments and/or supplements, if any, to provisions of the ITB as necessitated by the circumstances of the specific procurement, must also be incorporated.

# Section IV. General Conditions of Contract

#### **Notes on the General Conditions of Contract**

The General Conditions of Contract (GCC) in this Section, read in conjunction with the Special Conditions of Contract in Section V and other documents listed therein, should be a complete document expressing all the rights and obligations of the parties.

Matters governing performance of the Contractor, payments under the contract, or matters affecting the risks, rights, and obligations of the parties under the contract are included in the GCC and Special Conditions of Contract.

Any complementary information, which may be needed, shall be introduced only through the Special Conditions of Contract.

#### 1. Scope of Contract

This Contract shall include all such items, although not specifically mentioned, that can be reasonably inferred as being required for its completion as if such items were expressly mentioned herein. All the provisions of RA No. 9184 and its 2016 revised IRR, including the Generic Procurement Manual, and associated issuances, constitute the primary source for the terms and conditions of the Contract, and thus, applicable in contract implementation. Herein clauses shall serve as the secondary source for the terms and conditions of the Contract.

This is without prejudice to Sections 74.1 and 74.2 of the 2016 revised IRR of RA No. 9184 allowing the GPPB to amend the IRR, which shall be applied to all procurement activities, the advertisement, posting, or invitation of which were issued after the effectivity of the said amendment.

#### 2. Sectional Completion of Works

If sectional completion is specified in the **Special Conditions of Contract** (SCC), references in the Conditions of Contract to the Works, the Completion Date, and the Intended Completion Date shall apply to any Section of the Works (other than references to the Completion Date and Intended Completion Date for the whole of the Works).

#### 3. Possession of Site

- 3.1 The Procuring Entity shall give possession of all or parts of the Site to the Contractor based on the schedule of delivery indicated in the SCC, which corresponds to the execution of the Works. If the Contractor suffers delay or incurs cost from failure on the part of the Procuring Entity to give possession in accordance with the terms of this clause, the Procuring Entity's Representative shall give the Contractor a Contract Time Extension and certify such sum as fair to cover the cost incurred, which sum shall be paid by Procuring Entity.
  - 3.2 If possession of a portion is not given by the above date, the Procuring Entity will be deemed to have delayed the start of the relevant activities. The resulting adjustments in contract time to address such delay may be addressed through contract extension provided under Annex "E" of the 2016 revised IRR of RA No. 9184.

#### 4. The Contractor's Obligations

The Contractor shall employ the key personnel named in the Schedule of Key Personnel indicating their designation, in accordance with **ITB** Clause 10.3 and specified in the **BDS**, to carry out the supervision of the Works.

The Procuring Entity will approve any proposed replacement of key personnel only if their relevant qualifications and abilities are equal to or better than those of the personnel listed in the Schedule.

#### 5. Performance Security

- 5.1. Within ten (10) calendar days from receipt of the Notice of Award from the Procuring Entity but in no case later than the signing of the contract by both parties, the successful Bidder shall furnish the performance security in any of the forms prescribed in Section 39 of the 2016 revised IRR.
- 5.2. The Contractor, by entering into the Contract with the Procuring Entity, acknowledges the right of the Procuring Entity to institute action pursuant to RA No. 3688 against any subcontractor be they an individual, firm, partnership, corporation, or association supplying the Contractor with labor, materials and/or equipment for the performance of this Contract.

#### **6.** Site Investigation Reports

The Contractor, in preparing the Bid, shall rely on any Site Investigation Reports referred to in the SCC supplemented by any information obtained by the Contractor.

#### 7. Warranty

- 7.1. In case the Contractor fails to undertake the repair works under Section 62.2.2 of the 2016 revised IRR, the Procuring Entity shall forfeit its performance security, subject its property(ies) to attachment or garnishment proceedings, and perpetually disqualify it from participating in any public bidding. All payables of the GOP in his favor shall be offset to recover the costs.
- 7.2. The warranty against Structural Defects/Failures, except that occasioned-on force majeure, shall cover the period from the date of issuance of the Certificate of Final Acceptance by the Procuring Entity. Specific duration of the warranty is found in the **SCC**.

#### 8. Liability of the Contractor

Subject to additional provisions, if any, set forth in the SCC, the Contractor's liability under this Contract shall be as provided by the laws of the Republic of the Philippines.

If the Contractor is a joint venture, all partners to the joint venture shall be jointly and severally liable to the Procuring Entity.

#### 9. Termination for Other Causes

Contract termination shall be initiated in case it is determined *prima facie* by the Procuring Entity that the Contractor has engaged, before, or during the implementation of the contract, in unlawful deeds and behaviors relative to contract acquisition and implementation, such as, but not limited to corrupt, fraudulent, collusive, coercive, and obstructive practices as stated in **ITB** Clause 4.

#### 10. Dayworks

Subject to the guidelines on Variation Order in Annex "E" of the 2016 revised IRR of RA No. 9184, and if applicable as indicated in the SCC, the Dayworks rates in the Contractor's Bid shall be used for small additional amounts of work only when the Procuring Entity's Representative has given written instructions in advance for additional work to be paid for in that way.

#### 11. Program of Work

- 11.1. The Contractor shall submit to the Procuring Entity's Representative for approval the said Program of Work showing the general methods, arrangements, order, and timing for all the activities in the Works. The submissions of the Program of Work are indicated in the **SCC**.
- 11.2. The Contractor shall submit to the Procuring Entity's Representative for approval an updated Program of Work at intervals no longer than the period stated in the SCC. If the Contractor does not submit an updated Program of Work within this period, the Procuring Entity's Representative may withhold the amount stated in the SCC from the next payment certificate and continue to withhold this amount until the next payment after the date on which the overdue Program of Work has been submitted.

#### 12. Instructions, Inspections and Audits

The Contractor shall permit the GOP or the Procuring Entity to inspect the Contractor's accounts and records relating to the performance of the Contractor and to have them audited by auditors of the GOP or the Procuring Entity, as may be required.

#### 13. Advance Payment

The Procuring Entity shall, upon a written request of the Contractor which shall be submitted as a Contract document, make an advance payment to the Contractor in an amount not exceeding fifteen percent (15%) of the total contract price, to be made in lump sum, or at the most two installments according to a schedule specified in the **SCC**, subject to the requirements in Annex "E" of the 2016 revised IRR of RA No. 9184.

#### 14. Progress Payments

The Contractor may submit a request for payment for Work accomplished. Such requests for payment shall be verified and certified by the Procuring Entity's Representative/Project Engineer. Except as otherwise stipulated in the SCC, materials and equipment delivered on the site but not completely put in place shall not be included for payment.

#### 15. Operating and Maintenance Manuals

15.1. If required, the Contractor will provide "as built" Drawings and/or operating and maintenance manuals as specified in the **SCC**.

15.2. If the Contractor does not provide the Drawings and/or manuals by the dates stated above, or they do not receive the Procuring Entity's Representative's approval, the Procuring Entity's Representative may withhold the amount stated in the **SCC** from payments due to the Contractor.

# Section V. Special Conditions of Contract

#### **Notes on the Special Conditions of Contract**

Similar to the BDS, the clauses in this Section are intended to assist the Procuring Entity in providing contract-specific information in relation to corresponding clauses in the GCC found in Section IV.

The Special Conditions of Contract (SCC) complement the GCC, specifying contractual requirements linked to the special circumstances of the Procuring Entity, the Procuring Entity's country, the sector, and the Works procured. In preparing this Section, the following aspects should be checked:

- a. Information that complements provisions of the GCC must be incorporated.
- b. Amendments and/or supplements to provisions of the GCC as necessitated by the circumstances of the specific purchase, must also be incorporated.

However, no special condition which defeats or negates the general intent and purpose of the provisions of the GCC should be incorporated herein.

# Section VI. Specifications

### **Notes on Specifications**

A set of precise and clear specifications is a prerequisite for Bidders to respond realistically and competitively to the requirements of the Procuring Entity without qualifying or conditioning their Bids. In the context of international competitive bidding, the specifications must be drafted to permit the widest possible competition and, at the same time, present a clear statement of the required standards of workmanship, materials, and performance of the goods and services to be procured. Only if this is done will the objectives of economy, efficiency, and fairness in procurement be realized, responsiveness of Bids be ensured, and the subsequent task of bid evaluation facilitated. The specifications should require that all goods and materials to be incorporated in the Works be new, unused, of the most recent or current models, and incorporate all recent improvements in design and materials unless provided otherwise in the Contract.

Samples of specifications from previous similar projects are useful in this respect. The use of metric units is mandatory. Most specifications are normally written specially by the Procuring Entity or its representative to suit the Works at hand. There is no standard set of Specifications for universal application in all sectors in all regions, but there are established principles and practices, which are reflected in these PBDs.

There are considerable advantages in standardizing General Specifications for repetitive Works in recognized public sectors, such as highways, ports, railways, urban housing, irrigation, and water supply, in the same country or region where similar conditions prevail. The General Specifications should cover all classes of workmanship, materials, and equipment commonly involved in construction, although not necessarily to be used in a particular Works Contract. Deletions or addenda should then adapt the General Specifications to the particular Works.

Care must be taken in drafting specifications to ensure that they are not restrictive. In the specification of standards for goods, materials, and workmanship, recognized international standards should be used as much as possible. Where other particular standards are used, whether national standards or other standards, the specifications should state that goods, materials, and workmanship that meet other authoritative standards, and which ensure substantially equal or higher quality than the standards mentioned, will also be acceptable. The following clause may be inserted in the SCC.

#### Sample Clause: Equivalency of Standards and Codes

Wherever reference is made in the Contract to specific standards and codes to be met by the goods and materials to be furnished, and work performed or tested, the provisions of the latest current edition or revision of the relevant standards and codes in effect shall apply, unless otherwise expressly stated in the Contract. Where such standards and codes are national, or relate to a particular country or region, other authoritative standards that ensure a substantially equal or higher quality than the standards and codes specified will be accepted

subject to the Procuring Entity's Representative's prior review and written consent. Differences between the standards specified and the proposed alternative standards shall be fully described in writing by the Contractor and submitted to the Procuring Entity's Representative at least twenty-eight (28) days prior to the date when the Contractor desires the Procuring Entity's Representative's consent. In the event the Procuring Entity's Representative determines that such proposed deviations do not ensure substantially equal or higher quality, the Contractor shall comply with the standards specified in the documents.

These notes are intended only as information for the Procuring Entity or the person drafting the Bidding Documents. They should not be included in the final Bidding Documents.

# TECHNICAL SPECIFICATIONS

#### I. GENERAL REQUIREMENTS

- A Comply with the current and existing laws, ordinances and applicable codes, rules and regulations, and standards. Any works performed contrary to the existing laws, rules and regulations, ordinances and standards without notice shall bear all cost arising therefrom.
- B. Drawings, specifications, codes and standards are minimum requirements. Where
  requirements differ, the more stringent apply
- C Should there be any change(s) in drawings or specifications, it is required to comply with the governing regulations, notify the implementing agency.
- D. On behalf of the City Government shall secure and seek approval of necessary documentary requirements from MERALCO including the Distribution Asset Study
- E. Certification of Structural Stability of the Hospital where the Solar Panels have to be installed prior to the delivery and installation of solar power system on the project shall be provided.
- F. Site verification / inspection shall be conducted to varidate the scope of works. No extra compensation and extension of time shall be given due to negligence or inadvertence. In cases where creation of new rooms for inverters is required to complete the Project, all necessary cost of materials and labor shall be shouldered by the Contractor.
- G. The quality of materials shall be of the best grade of their respective kinds for the purpose. The work shall also be performed in the best and most capable manner in strict accordance with requirements of the plans and details. All materials not conforming to the requirements of these specifications shall be considered as defective.
- H. All equipment and installations shall meet or exceed minimum requirements of the standards and codes.
- Upon completion of the installation of the Solar Power System, the Contractor shall perform
  testing as well as pre-commissioning and commissioning tests in the presence of the City
  Department of Engineering and other concerned offices to validate compliance with the Bid
  Documents, Latest Philippine Electrical Code and other related and existing codes and
  regulations
- J. Roof buildings where the Solar Power System were installed must ensure to be free of leaks.
- K. Photographs shall be taken as, when and where directed at intervals of not more than one month. The photographs shall be sufficient in number and location, to record the exact progress of the works. The photographs shall be retained and will become the property of the Government.

- Mobilization and Demobilization (if applicable)
  - 1 Mobilization shall include all activities and related costs for transportation of personnel, equipment, and operating supplies to the site: establishment of offices, buildings, and other necessary general facilities for the operations at the site.
  - 2 Demobilization shall include all activities and costs for transportation of personnel, equipment, and supplies not anymore required within the construction site including the disassembly, removal and site clean-up of offices and other facilities assembled on the site specifically for this contract.
- M Execute work in strict accordance with the best practices of the trades in a thorough, substantial workmanlike manner by competent workmen. Provide a competent experienced, full-time supervisor who is authorized to make decisions on behalf of the Contractor.
- N. Temporary Facilities and Utilities
  - 1 All facilities shall be near the job site, where necessary and shall conform to the best standard for the required types.
  - Temporary facilities shall be provided and maintained including sanitary facilities and first aid stations
  - Temporary utilities shall be sufficiently provided until the completion of the project such as water, power and communication.
  - Temporary enclosure shall be provided around the construction site with adequate guard lights, railings and proper signage.
  - Temporary roadways shall be constructed and maintained to sustein loads to be carried on them during the entire construction period.
  - Upon completion of the work, the temporary facilities shall be demotished, hauled-out and disposed property.
- Adequate construction safety and health protection shall be provided at all times during the execution of work to both workers and property
  - A fully-trained Medical Aide shall be employed permanently on the site who shall be engaged solely to medical duties.
  - The medical room shall be provided with waterproofing, it could be a building or room designated and used exclusively for the purpose and have a floor area of at least 15 square meters and a glazed window area of at least 2 square meters.
  - The location of the medical room and any other arrangements shall be made known to all employees by posting on prominent locations and suitable notices in the site.
  - 4 Additional safety precautions shall be provided in the event of a pandemic. Protocols set forth by the government shall be strictly followed
  - Construction safety shall consist of construction canopy and safety net
- P. Necessary protections to the adjacent property shall be provided to avoid untoward incidents? accidents.
- Q. A systematic approach for managing vehicular and pedestrian traffic within the project area shall be provided adhering to relevant regulations and standards, prioritizing the safety of workers, motorists, and pedestrians while maintaining the flow of traffic during construction activities. It shall delineates designated traffic routes, temporary signage, and traffic control measures such as flagging operations or temporary traffic signals.
- R. Final cleaning of the work shall be employed prior to the final inspection for the cartification of final acceptance. Final cleaning shall be applied on each surface or unit of work and shall be of condition expected for a building cleaning and maintenance program.

#### **ELECTRICAL WORKS** II.

#### A. Photovoltaic Modules.

The PV Modules shall be of the crystalline silicon terrestrial type and conform to PNS IEC 61215-1-1-2018 - Terrestrial photovoltaic (PV) modules - Design qualification and type approval, PNS IEC 61730-1:2018 - Photovoltaic (PV) module safety qualification, PNS IEC 62790:2016 - Junction boxes for photovoltaic modules - Safety requirements and tests. The PV module shall be supported by a specific qualification certificate issued by an Internationally recognized test facility in accordance with the abovementioned standard. Only PV modules from manufacturers classified as Tier 1 are acceptable (latest BloombergNEF PV Module Tier 1 List)

For each module delivered a flash protocol shall be furnished. The flash test of the individual module shall be submitted showing the t-V (current vs. voltage) curve with positive power tolerance. The final electro luminescence test of the individual module shall be submitted showing the absence of any mechanical or electrical defects of the cells in the module

#### B. Rapid Shuldown Switch (RSS)

The PV system circuits installed in the schools shall include a rapid shutdown function in accordance with PEC 2017 article 6.90.2.6(A) through (D). Power optimizers used in the PV strings must have RSS functionality.

#### C. DC Combiner Box

Each string of the PV Modules shall be connected to a junction box with a cedicated cable. Combiner baxes integrated with the inverter car, be used. The Supplier shall prepare the detailed plans and methods of connection of cables. The output voltage of each string shall be consistent with the input of the power conditioner.

#### D. Support Structures

The support structures that will hold the solar PV modules in place will be roof mounted with fixed titt Flush mount will be used for pitched roofs. Ballasted mounting will be adapted on flat concrete slab roofs with the optimum tilt as recommended by solar design tools for maximum generation, soiling considerations, and ventilation.

Mounting materials and clamps should be manufactured from anodized aluminum with stainless steel bolts and nuts and must meet the installation guidelines and requirements of the solar PV module manufacturer. Spacers for dissimilar metals shall be used to prevent galvanic corresion.

The design of the mechanical systems shall take into consideration the design of the support structure adopting the JISIC 8955:2017 "Load design guide on structures for PV array" with wind loads specific for Quezon City as defined in the latest Philippine Building Code

## E. <u>Grid-tied Inverter/Power Conditioning Unit (PCU)</u>

The Inverters used for this project are intended to be grid connected without batteries. These shall be compliant to PNS IEC 61727:2016 - Photovoltaic (PV) systems - Characteristics of the utility interface and meet the requirements of the Philippine Distribution Code 2017

The inverters shall be three phase with frequency of 60 Hz and tapped on the electrical system of the schools. A matching transformer can be used to match the grid form of the inverter output and the tapping point of the electrical system. This transformer must be compliant to IEC 60076-1, 2, 3, 10, 18 for Power Transformers. The total output of the PV system shall be measured by the REC meter to be supplied by the Supplier. The Supplier shall also provide all other components necessary mounting structure and components necessary on the output side of the PV System

The specifications of the Inverter shall meet the following minimum requirements:

- Nominal AC Output Voltage range of 230/400/480V, 3-Phase  $\pm$  6%, 60 Hz (as per the grid
- Equipped with a DC switch which safely isolates DC circuits,
- Ambient temperature of -10oC to 50oC;
- IP65 protection class on sensitive components (Overall IP54 with forced ventilation will also be acceptable)
- Compatible communication protocol with the selected monitoring system.

- Harmonic distortion which shall not exceed limits set by the DU; and
- Accepted and approved by the DOE and ERC, and must be approved or inspected by the Department of Trade and Industry (DTI).

The grid-connected inverters shall be equipped with an enti-standing function to disconnect from the grid in the event of a grid failure within the stipulated time frame primarity defined by the DU and by locat/international standards

#### F. AC Collection System

AC Distribution Boards shall be installed as a collection system from the grid-connected inverters and shall achieve the following as a minimum:

- Overcurrent protection on the Inverters and the mains of appropriate trip rating and shortcircuit (kA) rating of the circuit breakers;
- Residual or leakage current protection such as earth leakage relay (ELR) or earth fault relay (EFR);
- Surge protection devices with appropriate rated voltage and surge current.
- Suitable enclosure pertaining to site conditions; and
- For indeer installations, the enclosure shall have a minimum protection class of IP42. For outdoor installations, the enclosure shall be designed to weatherproof conditions with a minimum protection class of IP54.

Circuit Breakers shall be of fixed type and equipped with a trip unit that offers the appropriate level of protection performance to fit to the application and shall comply with IEC 60947-1 and 2 on the following:

- Operation and behavior in normal service; and
- Operation and behavior in case of overload and operation and behavior in case of short-circuit, including co-ordination in service (discrimination and back-up protection)

The design of the AC Distribution Boards shall be capable of Lock-Out, Tag-Out protocols. Color codes of phase circuits applicable to the internal components shall conform to local standards

Any AC switchboards installed outdoor shall be made of materials stable against UV for mechanical strength and discoloring by UV.

#### G. Onlyne Monitoring and Control

The Solar PV System shall be equipped with a high-level online monitoring system via the WIFInetwork of the respective school buildings as mentioned under III E. The system should allow QC LGU to have real-time 24/7 access to the software through mobile phones and computers. A synchronized LED display will be installed at one public area in each of the hospital. Information on the system status, output power, voltage, current shall be available in real time as the minimum parameters. Storage of 15-minute data with cumulative daily, monthly, annual, and total operating time shall be available for viewing and download in CSV to text software format. The Supplier shall provide secured online access to authorized personnel of the City Government.

Environmental monitoring instruments and sensors shall be integrated into the online monitoring and control systems. Instruments include among others, irradiance sensors installed for plane of the array and GHI measurements; and temperature sensors (such as RTOs or thermocouples) for ambient and solar PV module temperatures. The sensor mounting location shall be prearranged and approved with the City Government.

#### H. DC and AC Wires and Cables

Selection of cable type, sizing and use of connectors shall be in exportance to the Philippine Electrical Code 2017 particularly Article 6.90 on photovoltaic systems.

For DC Cables, the following are the standards and requirements:

- Solar Cables shall be Uffraviolet (UV) resistant for outdoor application and with a minimum insulation rating of 1kV (core to earth) and shall be cenified to H1Z2Z2-K according to EN50618;
- Positively charged cables shall be colored red, negatively charged cables shall be colored black.
- Solar Cables selected shall be appropriately sized according to the full short-circuit current of the Solar Modules:
- DC cable design shall not exceed a voltage drop of 1.5%.
- DC cable installation must be free from physical damage and from the possibility of damages caused by vermin.

- Only single core, double insulated cables shall be used; and
- Minimum cable cross-section of 6mm2 or equivalent

AC Cables selected shall conform to local standards and appropriately sized according to the full load. current it is designed to operate at, not exceeding a voltage drop limit of 1% at full load current.

#### Metal Enclosures Conduits, Cable Trays

Design, selection, lay-out and mounting metal enclosures, conduits, and cable trays shall be in accordance with the latest Philippine Electrical Code.

The design of the enclosures shall be capable of Lock-Out, Tay-Out protocols. Color codes of phase circuits applicable to the internal components shall conform to local standards.

Appropriate AC and DC cable conduits, cable trays, and supports shall be selected and sized appropriately to cater for the corresponding number of AC and DC cables. The selected material shall be resistant to effects of corrosion during the 25-year lifespan of the solar PV system.

#### J. Protective Devices (DC and AC)

Protection System - Philippine Electrical Code 2017 Article 6.90.2.6 Reput Shutdown, Over Current Protection, Surge Protective Devices, Lightning Protection, Grounding and Bonding

#### K. Ancitlary Materials

Other ancillary materials necessary to facilitate a complete installation shall be deemed to be included in the scope of the Supplier. These items may include, but are not limited to

- Cable glands, bushings, terminations, and lugs.
- Flexible conduits and cable ties:
- Support brackets and mounting accessories;
- Labels and tags, and
- Safety equipment and signages

Not all anothery materials may be required, the necessity of the materials shall be determined in accordance to the assessment of the Supplier. All materials shall be specified based on external conditions and intended use (e.g., UV resistant for exposure to sun and others) and must comply with relevant international or local standards.

#### Installation

#### A General Installation Activities

The Contractor shall undertake the following scope of installation works in accordance to the approved design drawings, site conditions, and relevant local standards, generally as stipulated below.

- All site preliminaries and establishment such as site offices, work areas, and appropriate signages. The implementation plan must include the operational requirements and work instructions of the City Government:
- Compliance to safety regulations for site work as per requirement
- Installation of all supplied equipment necessary for the fully operational solar PV system in accordance to the approved design, recommended manufacturer installation parameters, as well as relevant local and international standards and codes;
- Earthing and grounding of all metal structures and equipment to the building earth, including design and installation of a lightning protection system in accordance with IEC 62305 with Class III protection (Philippine Electrical Code 2017, Articles 2.5 and 2.9) as a minimum and in compliance to local standards:
- Provide fire extinguishers and sand buckets for fire protection:
- Restoration and repair of any structures or building components damaged during project execution (such as wall and ceiling penetration repairs, including fire sealant materials - for cable routing, repainting, cleaning of concrete chippings and other debria, roof leaks, water proofing, and others);
- Proper housekeeping practices which include cleaming of site, debris removal, and strict enforcement of Health, Safety, and Environmental (HSE) plans and policies;
- Adhere to the planned timeline of the construction phase and arrange for milestone meetings when necessary; and

Overall testing, commissioning and final inspection of the system, including the attendance of the necessary parties for each part.

#### B Cabling

Physical separation of AC and DC cables shall be achieved. All data or control cables shall be installed in separate cable containments from normal power cables to minimize signal interference

Conduits, trunking, trays and ladders are acceptable methods of a cable support system in areas not exposed to the sun. In areas exposed to the sun the cable support system shall be HDG metal trunking. Earth conductors shall be sized in accordance with local electrical codes. Where multiple cables are installed, proper cable management system shall be used to bundle them in a neet fashion. The cable management systems installed outdoors shall be made of stainless steel. UV rated cable ties are not permissible

Points of entry and exit of cables into enclosures and support systems shall be secured with watertight and flame-resistant cable glands or cable connectors.

#### C. Access

All associated equipment and components of the system shall be accessible for future servicing and maintenance. The Supplier shall provide permanent methods of access to areas where parts of the system are inaccessible. For example, vertical high walls without a caged ladder or confined areas. where the parts of the system will be installed in are considered inaccessible.

#### D. Coxing Work

When coring is necessary, all openings to areas prone to fire shall be sealed with firestop protection with proper fire-protection labels and certification. Rectification and recertification may be necessary if penetration will be done through existing fire-sealant boards or fire-stop material

For openings with exposure to outdoor environment or areas subjected to water ingress, openings shall be properly sealed with waterproof sealant material to prevent any seepage of water

#### E Lightging Protection

Solar PV roof-top installations do not pase an additional risk for lightning strike. On buildings which due to their exposure are equipped with lightning protection, the PV installation must be integrated into the system in compliance IEC 62305, EN 50539-11, and Philippine Electrical Code 2017, Article 2.90, Equipotential bonding of the modules and mounting structure shall be performed and connected into the lightning protection system. Cable sizing for such shall comply with local codes and standards

#### F Corrosion Management

The Supplier shall take into consideration the effect of corrosion for any related works on site which involve metal objects. All joints and cultings shall be of quality standards. Dents, fractures or incompatible joints which will lead to water seepage into the cable support system or cable enclosure which can cause rust, corrosion or retention of water will not be acceptable

Practice of selection of metals for permanent installation of associated materials shall consider, but not amited to, the following pointers as guidelines:

- Stainless steel fasteners will be required to prevent galvanic corrosion,
- Use one material to fabricate electrically isolated systems or components where practical; and
- Cutting and modification must be minimized. Materials of galvanized steel that undergomodification or cutting process shall be re-coated with zinc spray or equivalent anticograsion agent.

The Supplier shall provide a Corrosion Management Plan containing detailed strategies towards managing the occurrence of corrosion and enhancing the resistence of the support structure against corrosion. The Corrosion Management Plan shall be integrated as part of operations and maintenance. procedures for the soler PV system structures and buildings on site, considering the designed lifetime of the facility.

#### G. Housékégping

During the progress of the instaltation phase, the Supplier shall ensure that housekeeping activities, which includes proper disposal of waste material and debris will be performed on a daily basis

The Contractor must strictly enforce HSE Plans and Policies, including among others, fall protection materials handling, electrical safety, use of PPE, emergency response, and appropriate signages, during the Installation phase of the project

#### H. Montonna System.

The monitoring system will utilize data loggers and a communication system to receive and log the transmitted signals from the sensors, inveriers, panels and meters. The Supplier shall ensure that all communication channels from the various devices to the data logger shall be without interference to the signal transmissions. The Supplier shall have suitably qualified personnel present during commissioning to establish connection of the logger to the relevant system parts/sections.

#### Labelling

As a minimum, labelling shall be done for all the associated cabling for future service and maintenance of the system, equipment labels shall be engraved traffolyte labels colour coded to comply with AS1319. Labeling requirements and guidelines shall consider, but not limited to, the following:

- Module string numbers for each individual string on the rooffop,
- Module string numbers for each individual pair of solar or DC cables at the Module strings. Combiner Boxes, and at the DC inputs of the inverters;
- inverter numbers and string numbers on DC Surge Protection devices, DC isolators, DC circuit breakers or fuses where applicable;
- Inverter numbers on each individual Inverter, associated AC cables, AC circuit breakers and AC isolators where applicable,
- Designated tag labels for monitoring equipment, metering and sensors,
- Designated tag labels for essociated enclosures i.e., Array Junction Boxes, AC Switchboards, Mondoning Accessories; and
- Designated tag labels for DC Cable Support System, AC Cable Support System and Data or Control Cable Support System at 3 m intervals.

At areas where live conductors may be exposed, labels to caution users to danger of electric shock. shall be implemented, including the exterior of enclosure cubicles or boxes and protective screens where applicable.

Labels to warn users of a dual supply network shall likewise be implemented on all AC Equipment installed as a collection system for the solar PV system

The same label designations for the above shall be consistent with the labels as indicated in as-outlidrawings and assigned designation labels for any monitoring matters.

All labels installed mutdoors shall be made of materials stable against UV for mechanical strength and discoloring by UV.

#### Egypment Weather Profession

If inverters or monitoring panels will be installed outdoors or in areas with direct sunshme, the Supplier shall provide a canopy to provide cover from rain and direct sunshine. The canopy should include proper spacing and design for air circulation to the inverters as per manufacturer manuals.

#### CIVIL / STRUCTURAL WORKS III.

#### A. ROOFING WORKS

- 1 Corrugated galvanized iron (G1) sheets including plain aluminum sheets for roofing accessories shall be cold-rolled meeting ASTM A-153 and with spetter coating of zinc of not less than0.381 kg/sq.m. (1.25 ounce/sq.ft.) conforming to ASTM A-525 or pris 67.1985. Unless otherwise specified or shown on Plans, roofing sheets shall be gauge 26 (0.48mm thick) and provided in long span sizes to minimize end laps. Sheets shall weigh not less than 3.74 kg/sq.m. and shall be marked or stamped showing the gauge, size amount of zinc coating, brand and name of manufacturer. Tast specimens shall stand being bent through 180 degrees flat on itself without fracture of the base metal and without flaking of the zinc coafing.
- 2 Ridge/hip rolls, valleys, fleshing and counter flashings, gutters and downspouts. whenever required, shall be fabricated from plain G I sheets. Ridge/hip rolls. Rashings and counter flashings shall be gauge 26. Valleys, gutters and downspouts shall be gauge

24 unless otherwise specified on Plans. Wire basket strainers shall be galvanized, gauge

- Roof ventilators, whenever required shall be labricated from gauge 26 plain G.1 sheets and constructed to the dimensions and details shown on Plans.
- 4. The roofing shall be secured to the purios with min. 2 ½" max. 3" long Tek screws. Provide all-purpose sealant under the fasteners. Ridge rolls, hip rolls and valleys to be used shall be those compatible with the Ga 24 pre-painted G.I rib-type roofing sheets They shall lap the roofing sheets at least 250mm. The ridge rolls, hip rolls and valleys shall be riveted to the roofing sheets.
- Polycarbonate roofing and sunbreakers shall be covered with 6mm thick Rib-type. polycarbonate sheets as shown on the plans. The roofing shall be secured to the purlins with min. 2 1/2" max. 3" long Tek screws. Provide all-purpose sealant under the fasteners. Ridge rolls, hip rolls and valleys to be used shall be those compatible with the 6mm thick solid polycarbonate sheets. They shall lap the roofing sheets at least 250mm. The ridge rolls, hip rolls and valleys shall be riveted to the rooting sheets.
- All roofing sheets adjacent to concrete hollow block and other masonry walls such as property line firewalls, shall be provided with Gauge 26 pre-painted plain G.I. Flashing to extend to the top and over to the other side of the wall. All fasteners shall be placed at the top of the corrugations of the roofing sheets to prevent water from standing around the fasteners.
- 7 Provide 6mm thick thermal insulation with single-side aluminum foil prior to fastening of roofing sheets to serve as thermal protection.

#### B. METAL FABRICATION

#### Materials:

- Steel and Iron. If not specified otherwise, use standard mill-hnished structural steel shapes or bar iron in compliance with AISC Specifications for Design, Fabrication and Erection of Structural Steel for buildings.
- Bolts, Nuts, Studs and Rivers, ASTM A 307 and A 325.
- Screws, Fed. Spec FF-S-85, Fed. Spec FF-S-92, and Fed. Spec. FF-S-111.
- d. Metal Purins. High grade galvanized steel with minimum tensile strength of 275. MPa, 1 4mm in thickness or approved equal.

#### Patrication.

By mechanics skilled in the trade and in accordance with the manufacturer's directions. Metalwork shall be labricated to allow for expansion and contraction of materials. Provide welding and bracing of adequate strength and durability with tight, flush joints, dressed smooth and clean. Complete with bolts and outs

#### Metal Surfaces:

Surfaces shall be clean and free from all scale, flake, rust and rust pitting; well-formed and finished to snape and size with sharp lines, angle and smooth surface. Shearing and punching shall leave clean true lines and surfaces. We'd or rivet permanent connections. Weld and flush rivers shall be used and finished flush smooth on surfaces that will be exposed after installation. No not use screws or bolts where they can be avoided, when used, heads shall be countersunk, acrewed up tight and threads nacked to prevent loosening.

#### 4. Construction:

Thickness of metals and details of assembly and supports shall give ample strength and stiffness for the minimum loads specified or indicated. Joints exposed to weather shall be formed to exclude water.

#### 5 Welding.

Use welding electrode E70xx and perform welding, welding inspection and corrective welding in accordance with AWS 011. Weld in a manner to prevent permanent distortion of the connected parts. Weld continuously along the entire area of contact (except where tack welding is permitted. Do not tack weld exposed to connections). Grind smooth visible weld in finished installation.

#### C. MOISTURE PROTECTION

#### 1. WATERPROOFING

- a. Cementitious waterproofing powder mix shall be cement-based, aggregate-type, heavy duty, waterproof coating for reinforced concrete surface and masonry exposed to water. Additive binders shall be of special formulation of acrysic polymers and modifiers in liquid form used as additive with cement-based powder mix that improves adhesion and mechanical properties. Water shall be clean, clear and potable.
- Concrete surface to be applied with waterproofing shall be structurally sound, clean and free of dirt, goes mortar particles, paint frims, oil, protective costs, efflorescence, taitance, etc. All defects shall be properly corrected and carefully formed to provide a smooth surface that is tree of marks and properly cured prior to application works.
- c. Furnish all labor, materials, equipment, plant and other facilities required to complete all waterproofing work as shown on the drawings and herein specified. All applications shall be strictly performed by an approved waterproofing Contractor.
- d. Test waterproofed area by seventy-two (72) hours and check for any seepages.

Note. Thickness should be as per Manufacturer's Specifications and Installation depending on the areas to be applied with.

#### IV. ARCHITECTURAL WORKS

#### A. PAINTING WORKS

- 1 Paint Materials. All types of paint material and other related products shall be subject to test as to material composition by the Bureau of Research and Standard, DPWH or the National Institute of Science and Technology.
- Tinting Colors. Tinting colors shall be first grade quality pigment ground in alkyd resin
  that disperses and mixes easily with paint to produce the color desired. Use the same
  brand of paint and tinting color to effect good paint body.
- 3 Skim coat Skim coat shall be fine powder type material like kalsomine that can be mixed into putty consistency, with oil-based primers and paints to fill minor surface dants and imperfections.

#### Pant Schedule.

- Exterior Masonry Wall (plain cement plastered finish to be painted)
  - 1 coat skim coating, 1 coat primer, 2 coats elastomeric paint finish.
- Interior Masonry Wall (plain cement plastered finish to be painted)
  - i 1 coat skim coating 1 coat primer 2 coats latex paint finish.
- d. Interior Dry Wall
  - i. 1 cost primer, 2 costs latex paint finish
- d. Ceiting Boards
  - i. 1 coat primer, 2 coats latex paint linish
- e. Slab Soffit
  - j 1 coat primer, 2 coats latex paint finish.
- Metal / Steel Surfaces
  - 1 coat primer, 2 coats epoxy enamel fmish
- Surface Preparation, All surfaces shall be in proper condition to receive the finish.
   Woodworks shall be hand-sanded smooth and dusted clean. All knot-holes pitch

pockets or sappy portions shall be sealed with natural wood filler. Nail holes, cracks or defects shall be carefully puttied after the first coat, matching the octor of paint

Interior woodworks shall be sandpapered between coats. Cracks, holes of imperfections in plaster shall be filled with patching compound and smoothed off to match adjoining surfaces.

Concrete and masonry surfaces shall be coated with concrete neutralizer and allowed to dry before any painting primer coat is applied. When surface is dried apply first coating. Hairline cracks and unevenness shall be patched and sealed with approved putty or patching compound. After all defects are corrected apply the finish coats as specified on the Plans (color scheme approved).

Metal shall be cleen dry and free from mill scale and rual. Remove all greats and oil from surfaces. Wash, unprimed galvanized metal with etching solution and allow it to dry. Where required to prime coat surface with Red Lead Primer same shall be approved by the Engineer.

in addition, the Contractor shall undertake the following:

- Voids, cracks, nick etc. will be repaired with proper patching material and finished flushed with surrounding surfaces.
- Merred or damaged shop costs on metal shall be spot primed with appropriate metal primer.
- Panting and varnishing works shall not be commenced when it is too hot or cold.
- Allow appropriate ventilation during application and drying period.
- All hardware will be fitted and removed or protected prior to painting and varnishing works.
- 6. Application. Paints when applied by brush shall become non-fluid, thick enough to lay down as adequate film of wet paint. Brush marks shall have flawed out after application of paint.

Paints made for application by roller must be similar to brushing paint. It must be nonsticky when thinned to spraying viscosity so that it will break up easily into droplets

Paint is atomized by high pressure pumping rather than broken up by the large volume of air mixed with it. This procedure changes the required properties of the paint.

- Application shall be as per paint Manufacturer's specification and recommendation.
- Provide all drop cloth and other covering requisite for protection of floors, walls, aluminum, glass, finishes and other works
- All applications and methods used shall strictly follow the Manufacturer's Instructions and Specifications.
- All surfaces including mesonry wall shall be thoroughly cleaned, puttled, sandpapered, rubbed and polished, masonry wall shall be treated with Neutralizer.
- 11. All exposed finish hardware, lighting fixtures and accessories, glass and the like shall be acceptately protected so that these are not stained with paint and other painting materials prior to painting works.
- All other surfaces endangered by stains and paint marks should be taped and covered with craft paper.

## Section VIII. Bill of Quantities

#### **Notes on the Bill of Quantities**

#### **Objectives**

The objectives of the Bill of Quantities are:

- a. to provide sufficient information on the quantities of Works to be performed to enable Bids to be prepared efficiently and accurately; and
- b. when a Contract has been entered into, to provide a priced Bill of Quantities for use in the periodic valuation of Works executed.

In order to attain these objectives, Works should be itemized in the Bill of Quantities in sufficient detail to distinguish between the different classes of Works, or between Works of the same nature carried out in different locations or in other circumstances which may give rise to different considerations of cost. Consistent with these requirements, the layout and content of the Bill of Quantities should be as simple and brief as possible.

#### **Daywork Schedule**

A Daywork Schedule should be included only if the probability of unforeseen work, outside the items included in the Bill of Quantities, is high. To facilitate checking by the Entity of the realism of rates quoted by the Bidders, the Daywork Schedule should normally comprise the following:

- a. A list of the various classes of labor, materials, and Constructional Plant for which basic daywork rates or prices are to be inserted by the Bidder, together with a statement of the conditions under which the Contractor will be paid for work executed on a daywork basis.
- b. Nominal quantities for each item of Daywork, to be priced by each Bidder at Daywork rates as Bid. The rate to be entered by the Bidder against each basic Daywork item should include the Contractor's profit, overheads, supervision, and other charges.

#### **Provisional Sums**

A general provision for physical contingencies (quantity overruns) may be made by including a provisional sum in the Summary Bill of Quantities. Similarly, a contingency allowance for possible price increases should be provided as a provisional sum in the Summary Bill of Quantities. The inclusion of such provisional sums often facilitates budgetary approval by avoiding the need to request periodic supplementary approvals as the future need arises. Where such provisional sums or contingency allowances are used, the SCC should state the manner in which they will be used, and under whose authority (usually the Procuring Entity's Representative's).

The estimated cost of specialized work to be carried out, or of special goods to be supplied, by other contractors should be indicated in the relevant part of the Bill of Quantities as a particular provisional sum with an appropriate brief description. A separate procurement procedure is normally carried out by the Procuring Entity to select such specialized contractors. To provide an element of competition among the Bidders in respect of any facilities, amenities, attendance, etc., to be provided by the successful Bidder as prime Contractor for the use and convenience of the specialist contractors, each related provisional sum should be followed by an item in the Bill of Quantities inviting the Bidder to quote a sum for such amenities, facilities, attendance, etc.

#### **Signature Box**

A signature box shall be added at the bottom of each page of the Bill of Quantities where the authorized representative of the Bidder shall affix his signature. Failure of the authorized representative to sign each and every page of the Bill of Quantities shall be a cause for rejection of his bid.

These Notes for Preparing a Bill of Quantities are intended only as information for the Procuring Entity or the person drafting the Bidding Documents. They should not be included in the final documents.
