Preface

These Philippine Bidding Documents (PBDs) for the procurement of Infrastructure Projects (hereinafter referred to also as the "Works") through Competitive Bidding have been prepared by the Government of the Philippines for use by all branches, agencies, departments, bureaus, offices, or instrumentalities of the government, including government-owned and/or -controlled corporations, government financial institutions, state universities and colleges, local government units, and autonomous regional government. The procedures and practices presented in this document have been developed through broad experience, and are for mandatory use in projects that are financed in whole or in part by the Government of the Philippines or any foreign government/foreign or international financing institution in accordance with the provisions of the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

The PBDs are intended as a model for admeasurements (unit prices or unit rates in a bill of quantities) types of contract, which are the most common in Works contracting.

The Bidding Documents shall clearly and adequately define, among others: (i) the objectives, scope, and expected outputs and/or results of the proposed contract; (ii) the eligibility requirements of Bidders; (iii) the expected contract duration; and (iv)the obligations, duties, and/or functions of the winning Bidder.

Care should be taken to check the relevance of the provisions of the PBDs against the requirements of the specific Works to be procured. If duplication of a subject is inevitable in other sections of the document prepared by the Procuring Entity, care must be exercised to avoid contradictions between clauses dealing with the same matter.

Moreover, each section is prepared with notes intended only as information for the Procuring Entity or the person drafting the Bidding Documents. They shall not be included in the final documents. The following general directions should be observed when using the documents:

- a. All the documents listed in the Table of Contents are normally required for the procurement of Infrastructure Projects. However, they should be adapted as necessary to the circumstances of the particular Project.
- b. Specific details, such as the "name of the Procuring Entity" and "address for bid submission," should be furnished in the Instructions to Bidders, Bid Data Sheet, and Special Conditions of Contract. The final documents should contain neither blank spaces nor options.
- c. This Preface and the footnotes or notes in italics included in the Invitation to Bid, BDS, General Conditions of Contract, Special Conditions of Contract, Specifications, Drawings, and Bill of Quantities are not part of the text of the final document, although they contain instructions that the Procuring Entity should strictly follow.
- d. The cover should be modified as required to identify the Bidding Documents as to the names of the Project, Contract, and Procuring Entity, in addition to date of issue.

- e. Modifications for specific Procurement Project details should be provided in the Special Conditions of Contract as amendments to the Conditions of Contract. For easy completion, whenever reference has to be made to specific clauses in the Bid Data Sheet or Special Conditions of Contract, these terms shall be printed in bold typeface on Sections I (Instructions to Bidders) and III (General Conditions of Contract), respectively.
- f. For guidelines on the use of Bidding Forms and the procurement of Foreign-Assisted Projects, these will be covered by a separate issuance of the Government Procurement Policy Board.

Glossary of Terms, Abbreviations, and Acronyms

ABC – Approved Budget for the Contract.

ARCC – Allowable Range of Contract Cost.

BAC – Bids and Awards Committee.

Bid – A signed offer or proposal to undertake a contract submitted by a bidder in response to and in consonance with the requirements of the bidding documents. Also referred to as *Proposal* and *Tender*. (2016 revised IRR, Section 5[c])

Bidder – Refers to a contractor, manufacturer, supplier, distributor and/or consultant who submits a bid in response to the requirements of the Bidding Documents. (2016 revised IRR, Section 5[d])

Bidding Documents – The documents issued by the Procuring Entity as the bases for bids, furnishing all information necessary for a prospective bidder to prepare a bid for the Goods, Infrastructure Projects, and/or Consulting Services required by the Procuring Entity. (2016 revised IRR, Section 5[e])

BIR – Bureau of Internal Revenue.

BSP – Bangko Sentral ng Pilipinas.

CDA – Cooperative Development Authority.

Consulting Services – Refer to services for Infrastructure Projects and other types of projects or activities of the GOP requiring adequate external technical and professional expertise that are beyond the capability and/or capacity of the GOP to undertake such as, but not limited to: (i) advisory and review services; (ii) pre-investment or feasibility studies; (iii) design; (iv) construction supervision; (v) management and related services; and (vi) other technical services or special studies. (2016 revised IRR, Section 5[i])

Contract – Refers to the agreement entered into between the Procuring Entity and the Supplier or Manufacturer or Distributor or Service Provider for procurement of Goods and Services; Contractor for Procurement of Infrastructure Projects; or Consultant or Consulting Firm for Procurement of Consulting Services; as the case may be, as recorded in the Contract Form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.

Contractor – is a natural or juridical entity whose proposal was accepted by the Procuring Entity and to whom the Contract to execute the Work was awarded. Contractor as used in these Bidding Documents may likewise refer to a supplier, distributor, manufacturer, or consultant.

CPI – Consumer Price Index.

DOLE – Department of Labor and Employment.

DTI – Department of Trade and Industry.

Foreign-funded Procurement or Foreign-Assisted Project – Refers to procurement whose funding source is from a foreign government, foreign or international financing institution as specified in the Treaty or International or Executive Agreement. (2016 revised IRR, Section 5[b]).

GFI – Government Financial Institution.

GOCC – Government-owned and/or –controlled corporation.

Goods – Refer to all items, supplies, materials and general support services, except Consulting Services and Infrastructure Projects, which may be needed in the transaction of public businesses or in the pursuit of any government undertaking, project or activity, whether in the nature of equipment, furniture, stationery, materials for construction, or personal property of any kind, including non-personal or contractual services such as the repair and maintenance of equipment and furniture, as well as trucking, hauling, janitorial, security, and related or analogous services, as well as procurement of materials and supplies provided by the Procuring Entity for such services. The term "related" or "analogous services" shall include, but is not limited to, lease or purchase of office space, media advertisements, health maintenance services, and other services essential to the operation of the Procuring Entity. (2016 revised IRR, Section 5[r])

GOP – Government of the Philippines.

Infrastructure Projects – Include the construction, improvement, rehabilitation, demolition, repair, restoration or maintenance of roads and bridges, railways, airports, seaports, communication facilities, civil works components of information technology projects, irrigation, flood control and drainage, water supply, sanitation, sewerage and solid waste management systems, shore protection, energy/power and electrification facilities, national buildings, school buildings, hospital buildings, and other related construction projects of the government. Also referred to as *civil works or works*. (2016 revised IRR, Section 5[u])

LGUs – Local Government Units.

NFCC – Net Financial Contracting Capacity.

NGA – National Government Agency.

PCAB – Philippine Contractors Accreditation Board.

PhilGEPS - Philippine Government Electronic Procurement System.

Procurement Project – refers to a specific or identified procurement covering goods, infrastructure project or consulting services. A Procurement Project shall be described, detailed, and scheduled in the Project Procurement Management Plan prepared by the agency which shall be consolidated in the procuring entity's Annual Procurement Plan. (GPPB Circular No. 06-2019 dated 17 July 2019)

PSA – Philippine Statistics Authority.

SEC – Securities and Exchange Commission.

SLCC – Single Largest Completed Contract.

UN – United Nations.

Section I. Invitation to Bid

Notes on the Invitation to Bid

The Invitation to Bid (IB) provides information that enables potential Bidders to decide whether to participate in the procurement at hand. The IB shall be posted in accordance with Section 21.2 of the 2016 revised IRR of RA No. 9184.

Apart from the essential items listed in the Bidding Documents, the IB should also indicate the following:

- a. The date of availability of the Bidding Documents, which shall be from the time the IB is first advertised/posted until the deadline for the submission and receipt of bids;
- b. The place where the Bidding Documents may be acquired or the website where it may be downloaded;
- c. The deadline for the submission and receipt of bids; and
- d. Any important bid evaluation criteria.

The IB should be incorporated into the Bidding Documents. The information contained in the IB must conform to the Bidding Documents and in particular to the relevant information in the Bid Data Sheet.

Section II. Instructions to Bidders

Notes on the Instructions to Bidders

This Section on the Instruction to Bidders (ITB) provides the information necessary for bidders to prepare responsive bids, in accordance with the requirements of the Procuring Entity. It also provides information on bid submission, eligibility check, opening and evaluation of bids, post-qualification, and on the award of contract.

1. Scope of Bid

The Procuring Entity, Quezon City Government invites Bids for the PROPOSED INSTALLATION OF STREETLIGHTS IN BARANGAY KRUS NA LIGAS, PINYAHAN AND KAMUNING, with Project Identification Number 24-00093.

[Note: The Project Identification Number is assigned by the Procuring Entity based on its own coding scheme and is not the same as the PhilGEPS reference number, which is generated after the posting of the bid opportunity on the PhilGEPS website.]

The Procurement Project (referred to herein as "Project") is for the construction of Works, as described in Section VI (Specifications).

2. Funding Information

- 2.1. The GOP through the source of funding as indicated below for 2024 in the amount of Twenty-Four Million Eight Hundred Forty-Two Thousand Two Hundred Eighty-Seven Pesos and 46/100 Ctvs. (P 24,842,287.46).
- 2.2. The source of funding is:
 - a. LGUs, the Annual or Supplemental Budget, as approved by the Sanggunian.

3. Bidding Requirements

The Bidding for the Project shall be governed by all the provisions of RA No. 9184 and its 2016 revised IRR, including its Generic Procurement Manual and associated policies, rules and regulations as the primary source thereof, while the herein clauses shall serve as the secondary source thereof.

Any amendments made to the IRR and other GPPB issuances shall be applicable only to the ongoing posting, advertisement, or invitation to bid by the BAC through the issuance of a supplemental or bid bulletin.

The Bidder, by the act of submitting its Bid, shall be deemed to have inspected the site, determined the general characteristics of the contracted Works and the conditions for this Project, such as the location and the nature of the work; (b) climatic conditions; (c) transportation facilities; (c) nature and condition of the terrain, geological conditions at the site communication facilities, requirements, location and availability of construction aggregates and other materials, labor, water, electric power and access roads; and (d) other factors that may affect the cost, duration and execution or implementation of the contract, project, or work and examine all instructions, forms, terms, and project requirements in the Bidding Documents.

4. Corrupt, Fraudulent, Collusive, Coercive, and Obstructive Practices

The Procuring Entity, as well as the Bidders and Contractors, shall observe the highest standard of ethics during the procurement and execution of the contract. They or through an agent shall not engage in corrupt, fraudulent, collusive, coercive, and obstructive practices defined under Annex "I" of the 2016 revised IRR of RA No. 9184 or other integrity violations in competing for the Project.

5. Eligible Bidders

- 5.1. Only Bids of Bidders found to be legally, technically, and financially capable will be evaluated.
- 5.2. The Bidder must have an experience of having completed a Single Largest Completed Contract (SLCC) that is similar to this Project, equivalent to at least fifty percent (50%) of the ABC adjusted, if necessary, by the Bidder to current prices using the PSA's CPI, except under conditions provided for in Section 23.4.2.4 of the 2016 revised IRR of RA No. 9184.

A contract is considered to be "similar" to the contract to be bid if it has the major categories of work stated in the **BDS**.

- 5.3. For Foreign-funded Procurement, the Procuring Entity and the foreign government/foreign or international financing institution may agree on another track record requirement, as specified in the Bidding Document prepared for this purpose.
- 5.4. The Bidders shall comply with the eligibility criteria under Section 23.4.2 of the 2016 IRR of RA No. 9184.

6. Origin of Associated Goods

There is no restriction on the origin of Goods other than those prohibited by a decision of the UN Security Council taken under Chapter VII of the Charter of the UN.

7. Subcontracts

7.1. The Bidder may subcontract portions of the Project to the extent allowed by the Procuring Entity as stated herein, but in no case more than fifty percent (50%) of the Project.

The Procuring Entity has prescribed that:

a. Subcontracting is not allowed.

- 7.1. [If Procuring Entity has determined that subcontracting is allowed during the bidding, state:] The Bidder must submit together with its Bid the documentary requirements of the subcontractor(s) complying with the eligibility criterial stated in **ITB** Clause 5 in accordance with Section 23.4 of the 2016 revised IRR of RA No. 9184 pursuant to Section 23.1 thereof.
- 7.2. [If subcontracting is allowed during the contract implementation stage, state:] The Supplier may identify its subcontractor during the contract implementation stage. Subcontractors identified during the bidding may be changed during the implementation of this Contract. Subcontractors must submit the documentary

requirements under Section 23.1 of the 2016 revised IRR of RA No. 9184 and comply with the eligibility criteria specified in **ITB** Clause 5 to the implementing or end-user unit.

7.3. Subcontracting of any portion of the Project does not relieve the Contractor of any liability or obligation under the Contract. The Supplier will be responsible for the acts, defaults, and negligence of any subcontractor, its agents, servants, or workmen as fully as if these were the Contractor's own acts, defaults, or negligence, or those of its agents, servants, or workmen.

8. Pre-Bid Conference

The Procuring Entity will hold a pre-bid conference for this Project on the specified date and time and either at its physical address on August 02, 2024 at 10:00 AM at 2nd Floor, Procurement Department-Bidding Room, Finance Building, Quezon City Hall Compound and/or we encourage the prospective bidders to join through our Virtual Conference (ZOOM APP) Meeting ID: 854 9489 0133 Password: 273320

9. Clarification and Amendment of Bidding Documents

Prospective bidders may request for clarification on and/or interpretation of any part of the Bidding Documents. Such requests must be in writing and received by the Procuring Entity, either at its given address or through electronic mail indicated in the **IB**, at least ten (10) calendar days before the deadline set for the submission and receipt of Bids.

10. Documents Comprising the Bid: Eligibility and Technical Components

- 10.1. The first envelope shall contain the eligibility and technical documents of the Bid as specified in **Section IX. Checklist of Technical and Financial Documents**.
- 10.2. If the eligibility requirements or statements, the bids, and all other documents for submission to the BAC are in foreign language other than English, it must be accompanied by a translation in English, which shall be authenticated by the appropriate Philippine foreign service establishment, post, or the equivalent office having jurisdiction over the foreign bidder's affairs in the Philippines. For Contracting Parties to the Apostille Convention, only the translated documents shall be authenticated through an apostille pursuant to GPPB Resolution No. 13-2019 dated 23 May 2019. The English translation shall govern, for purposes of interpretation of the bid.
- 10.3. A valid PCAB License is required, and in case of joint ventures, a valid special PCAB License, and registration for the type and cost of the contract for this Project. Any additional type of Contractor license or permit shall be indicated in the **BDS**.
- 10.4. A List of Contractor's key personnel (e.g., Project Manager, Project Engineers, Materials Engineers, and Foremen) assigned to the contract to be bid, with their

- complete qualification and experience data shall be provided. These key personnel must meet the required minimum years of experience set in the **BDS**.
- 10.5. A List of Contractor's major equipment units, which are owned, leased, and/or under purchase agreements, supported by proof of ownership, certification of availability of equipment from the equipment lessor/vendor for the duration of the project, as the case may be, must meet the minimum requirements for the contract set in the **BDS**.

11. Documents Comprising the Bid: Financial Component

- 11.1. The second bid envelope shall contain the financial documents for the Bid as specified in **Section IX. Checklist of Technical and Financial Documents**.
- 11.2. Any bid exceeding the ABC indicated in paragraph 1 of the **IB** shall not be accepted.
- 11.3. For Foreign-funded procurement, a ceiling may be applied to bid prices provided the conditions are met under Section 31.2 of the 2016 revised IRR of RA No. 9184.

12. Alternative Bids

Bidders shall submit offers that comply with the requirements of the Bidding Documents, including the basic technical design as indicated in the drawings and specifications. Unless there is a value engineering clause in the **BDS**, alternative Bids shall not be accepted.

13. Bid Prices

All bid prices for the given scope of work in the Project as awarded shall be considered as fixed prices, and therefore not subject to price escalation during contract implementation, except under extraordinary circumstances as determined by the NEDA and approved by the GPPB pursuant to the revised Guidelines for Contract Price Escalation guidelines.

14. Bid and Payment Currencies

- 14.1. Bid prices may be quoted in the local currency or tradeable currency accepted by the BSP at the discretion of the Bidder. However, for purposes of bid evaluation, Bids denominated in foreign currencies shall be converted to Philippine currency based on the exchange rate as published in the BSP reference rate bulletin on the day of the bid opening.
- 14.2. Payment of the contract price shall be made in:
 - a. Philippine Pesos.

15. Bid Security

- 15.1. The Bidder shall submit a Bid Securing Declaration or any form of Bid Security in the amount indicated in the **BDS**, which shall be not less than the percentage of the ABC in accordance with the schedule in the **BDS**.
- 15.2. The Bid and bid security in no case shall exceed One Hundred Twenty (120) calendar days from the date of opening of bids, unless duly extended by the bidder upon the request of the Head of the Procuring Entity (HoPE) of the Quezon City Local Government. Any bid not accompanied by an acceptable bid security shall be rejected by the Procuring Entity as non-responsive.

16. Sealing and Marking of Bids

Each Bidder shall submit one copy of the first and second components of its Bid.

The Procuring Entity may request additional hard copies and/or electronic copies of the Bid. However, failure of the Bidders to comply with the said request shall not be a ground for disqualification.

If the Procuring Entity allows the submission of bids through online submission to the given website or any other electronic means, the Bidder shall submit an electronic copy of its Bid, which must be digitally signed. An electronic copy that cannot be opened or is corrupted shall be considered non-responsive and, thus, automatically disqualified.

17. Deadline for Submission of Bids

The Bidders shall submit on the specified date and time and either at its physical address or through online submission as indicated in paragraph 5 of the IB.

18. Opening and Preliminary Examination of Bids

18.1. The BAC shall open the Bids in public at the time, on the date, and at the place specified in paragraph 9 of the **IB**. The Bidders' representatives who are present shall sign a register evidencing their attendance. In case videoconferencing, webcasting or other similar technologies will be used, attendance of participants shall likewise be recorded by the BAC Secretariat.

In case the Bids cannot be opened as scheduled due to justifiable reasons, the rescheduling requirements under Section 29 of the 2016 revised IRR of RA No. 9184 shall prevail.

18.2. The preliminary examination of Bids shall be governed by Section 30 of the 2016 revised IRR of RA No. 9184.

19. Detailed Evaluation and Comparison of Bids

19.1. The Procuring Entity's BAC shall immediately conduct a detailed evaluation of all Bids rated "passed" using non-discretionary pass/fail criteria. The BAC shall consider the conditions in the evaluation of Bids under Section 32.2 of 2016 revised IRR of RA No. 9184.

- 19.2. If the Project allows partial bids, all Bids and combinations of Bids as indicated in the **BDS** shall be received by the same deadline and opened and evaluated simultaneously so as to determine the Bid or combination of Bids offering the lowest calculated cost to the Procuring Entity. Bid Security as required by **ITB** Clause 15 shall be submitted for each contract (lot) separately.
- 19.3. In all cases, the NFCC computation pursuant to Section 23.4.2.6 of the 2016 revised IRR of RA No. 9184 must be sufficient for the total of the ABCs for all the lots participated in by the prospective Bidder.

20. Post Qualification

Within a non-extendible period of five (5) calendar days from receipt by the Bidder of the notice from the BAC that it submitted the Lowest Calculated Bid, the Bidder shall submit its latest income and business tax returns filed and paid through the BIR Electronic Filing and Payment System (eFPS), and other appropriate licenses and permits required by law and stated in the **BDS**.

21. Signing of the Contract

The documents required in Section 37.2 of the 2016 revised IRR of RA No. 9184 shall form part of the Contract. Additional Contract documents are indicated in the **BDS**.

Section III. Bid Data Sheet

Notes on the Bid Data Sheet (BDS)

The Bid Data Sheet (BDS) consists of provisions that supplement, amend, or specify in detail, information, or requirements included in the ITB found in Section II, which are specific to each procurement.

This Section is intended to assist the Procuring Entity in providing the specific information in relation to corresponding clauses in the ITB and has to be prepared for each specific procurement.

The Procuring Entity should specify in the BDS information and requirements specific to the circumstances of the Procuring Entity, the processing of the procurement, and the bid evaluation criteria that will apply to the Bids. In preparing the BDS, the following aspects should be checked:

Section IV. General Conditions of Contract

Notes on the General Conditions of Contract

The General Conditions of Contract (GCC) in this Section, read in conjunction with the Special Conditions of Contract in Section V and other documents listed therein, should be a complete document expressing all the rights and obligations of the parties.

Matters governing performance of the Contractor, payments under the contract, or matters affecting the risks, rights, and obligations of the parties under the contract are included in the GCC and Special Conditions of Contract.

Any complementary information, which may be needed, shall be introduced only through the Special Conditions of Contract.

1. Scope of Contract

This Contract shall include all such items, although not specifically mentioned, that can be reasonably inferred as being required for its completion as if such items were expressly mentioned herein. All the provisions of RA No. 9184 and its 2016 revised IRR, including the Generic Procurement Manual, and associated issuances, constitute the primary source for the terms and conditions of the Contract, and thus, applicable in contract implementation. Herein clauses shall serve as the secondary source for the terms and conditions of the Contract.

This is without prejudice to Sections 74.1 and 74.2 of the 2016 revised IRR of RA No. 9184 allowing the GPPB to amend the IRR, which shall be applied to all procurement activities, the advertisement, posting, or invitation of which were issued after the effectivity of the said amendment.

2. Sectional Completion of Works

If sectional completion is specified in the **Special Conditions of Contract** (SCC), references in the Conditions of Contract to the Works, the Completion Date, and the Intended Completion Date shall apply to any Section of the Works (other than references to the Completion Date and Intended Completion Date for the whole of the Works).

3. Possession of Site

- 3.1 The Procuring Entity shall give possession of all or parts of the Site to the Contractor based on the schedule of delivery indicated in the SCC, which corresponds to the execution of the Works. If the Contractor suffers delay or incurs cost from failure on the part of the Procuring Entity to give possession in accordance with the terms of this clause, the Procuring Entity's Representative shall give the Contractor a Contract Time Extension and certify such sum as fair to cover the cost incurred, which sum shall be paid by Procuring Entity.
 - 3.2 If possession of a portion is not given by the above date, the Procuring Entity will be deemed to have delayed the start of the relevant activities. The resulting adjustments in contract time to address such delay may be addressed through contract extension provided under Annex "E" of the 2016 revised IRR of RA No. 9184.

4. The Contractor's Obligations

The Contractor shall employ the key personnel named in the Schedule of Key Personnel indicating their designation, in accordance with **ITB** Clause 10.3 and specified in the **BDS**, to carry out the supervision of the Works.

The Procuring Entity will approve any proposed replacement of key personnel only if their relevant qualifications and abilities are equal to or better than those of the personnel listed in the Schedule.

5. Performance Security

- 5.1. Within ten (10) calendar days from receipt of the Notice of Award from the Procuring Entity but in no case later than the signing of the contract by both parties, the successful Bidder shall furnish the performance security in any of the forms prescribed in Section 39 of the 2016 revised IRR.
- 5.2. The Contractor, by entering into the Contract with the Procuring Entity, acknowledges the right of the Procuring Entity to institute action pursuant to RA No. 3688 against any subcontractor be they an individual, firm, partnership, corporation, or association supplying the Contractor with labor, materials and/or equipment for the performance of this Contract.

6. Site Investigation Reports

The Contractor, in preparing the Bid, shall rely on any Site Investigation Reports referred to in the SCC supplemented by any information obtained by the Contractor.

7. Warranty

- 7.1. In case the Contractor fails to undertake the repair works under Section 62.2.2 of the 2016 revised IRR, the Procuring Entity shall forfeit its performance security, subject its property(ies) to attachment or garnishment proceedings, and perpetually disqualify it from participating in any public bidding. All payables of the GOP in his favor shall be offset to recover the costs.
- 7.2. The warranty against Structural Defects/Failures, except that occasioned-on force majeure, shall cover the period from the date of issuance of the Certificate of Final Acceptance by the Procuring Entity. Specific duration of the warranty is found in the **SCC**.

8. Liability of the Contractor

Subject to additional provisions, if any, set forth in the SCC, the Contractor's liability under this Contract shall be as provided by the laws of the Republic of the Philippines.

If the Contractor is a joint venture, all partners to the joint venture shall be jointly and severally liable to the Procuring Entity.

9. Termination for Other Causes

Contract termination shall be initiated in case it is determined *prima facie* by the Procuring Entity that the Contractor has engaged, before, or during the implementation of the contract, in unlawful deeds and behaviors relative to contract acquisition and implementation, such as, but not limited to corrupt, fraudulent, collusive, coercive, and obstructive practices as stated in **ITB** Clause 4.

10. Dayworks

Subject to the guidelines on Variation Order in Annex "E" of the 2016 revised IRR of RA No. 9184, and if applicable as indicated in the SCC, the Dayworks rates in the Contractor's Bid shall be used for small additional amounts of work only when the Procuring Entity's Representative has given written instructions in advance for additional work to be paid for in that way.

11. Program of Work

- 11.1. The Contractor shall submit to the Procuring Entity's Representative for approval the said Program of Work showing the general methods, arrangements, order, and timing for all the activities in the Works. The submissions of the Program of Work are indicated in the **SCC**.
- 11.2. The Contractor shall submit to the Procuring Entity's Representative for approval an updated Program of Work at intervals no longer than the period stated in the SCC. If the Contractor does not submit an updated Program of Work within this period, the Procuring Entity's Representative may withhold the amount stated in the SCC from the next payment certificate and continue to withhold this amount until the next payment after the date on which the overdue Program of Work has been submitted.

12. Instructions, Inspections and Audits

The Contractor shall permit the GOP or the Procuring Entity to inspect the Contractor's accounts and records relating to the performance of the Contractor and to have them audited by auditors of the GOP or the Procuring Entity, as may be required.

13. Advance Payment

The Procuring Entity shall, upon a written request of the Contractor which shall be submitted as a Contract document, make an advance payment to the Contractor in an amount not exceeding fifteen percent (15%) of the total contract price, to be made in lump sum, or at the most two installments according to a schedule specified in the **SCC**, subject to the requirements in Annex "E" of the 2016 revised IRR of RA No. 9184.

14. Progress Payments

The Contractor may submit a request for payment for Work accomplished. Such requests for payment shall be verified and certified by the Procuring Entity's Representative/Project Engineer. Except as otherwise stipulated in the SCC, materials and equipment delivered on the site but not completely put in place shall not be included for payment.

15. Operating and Maintenance Manuals

15.1. If required, the Contractor will provide "as built" Drawings and/or operating and maintenance manuals as specified in the **SCC**.

15.2. If the Contractor does not provide the Drawings and/or manuals by the dates stated above, or they do not receive the Procuring Entity's Representative's approval, the Procuring Entity's Representative may withhold the amount stated in the **SCC** from payments due to the Contractor.

Section V. Special Conditions of Contract

Notes on the Special Conditions of Contract

Similar to the BDS, the clauses in this Section are intended to assist the Procuring Entity in providing contract-specific information in relation to corresponding clauses in the GCC found in Section IV.

The Special Conditions of Contract (SCC) complement the GCC, specifying contractual requirements linked to the special circumstances of the Procuring Entity, the Procuring Entity's country, the sector, and the Works procured. In preparing this Section, the following aspects should be checked:

- a. Information that complements provisions of the GCC must be incorporated.
- b. Amendments and/or supplements to provisions of the GCC as necessitated by the circumstances of the specific purchase, must also be incorporated.

However, no special condition which defeats or negates the general intent and purpose of the provisions of the GCC should be incorporated herein.

Section VI. Specifications

Notes on Specifications

A set of precise and clear specifications is a prerequisite for Bidders to respond realistically and competitively to the requirements of the Procuring Entity without qualifying or conditioning their Bids. In the context of international competitive bidding, the specifications must be drafted to permit the widest possible competition and, at the same time, present a clear statement of the required standards of workmanship, materials, and performance of the goods and services to be procured. Only if this is done will the objectives of economy, efficiency, and fairness in procurement be realized, responsiveness of Bids be ensured, and the subsequent task of bid evaluation facilitated. The specifications should require that all goods and materials to be incorporated in the Works be new, unused, of the most recent or current models, and incorporate all recent improvements in design and materials unless provided otherwise in the Contract.

Samples of specifications from previous similar projects are useful in this respect. The use of metric units is mandatory. Most specifications are normally written specially by the Procuring Entity or its representative to suit the Works at hand. There is no standard set of Specifications for universal application in all sectors in all regions, but there are established principles and practices, which are reflected in these PBDs.

There are considerable advantages in standardizing General Specifications for repetitive Works in recognized public sectors, such as highways, ports, railways, urban housing, irrigation, and water supply, in the same country or region where similar conditions prevail. The General Specifications should cover all classes of workmanship, materials, and equipment commonly involved in construction, although not necessarily to be used in a particular Works Contract. Deletions or addenda should then adapt the General Specifications to the particular Works.

Care must be taken in drafting specifications to ensure that they are not restrictive. In the specification of standards for goods, materials, and workmanship, recognized international standards should be used as much as possible. Where other particular standards are used, whether national standards or other standards, the specifications should state that goods, materials, and workmanship that meet other authoritative standards, and which ensure substantially equal or higher quality than the standards mentioned, will also be acceptable. The following clause may be inserted in the SCC.

Sample Clause: Equivalency of Standards and Codes

Wherever reference is made in the Contract to specific standards and codes to be met by the goods and materials to be furnished, and work performed or tested, the provisions of the latest current edition or revision of the relevant standards and codes in effect shall apply, unless otherwise expressly stated in the Contract. Where such standards and codes are national, or relate to a particular country or region, other authoritative standards that ensure a substantially equal or higher quality than the standards and codes specified will be accepted

subject to the Procuring Entity's Representative's prior review and written consent. Differences between the standards specified and the proposed alternative standards shall be fully described in writing by the Contractor and submitted to the Procuring Entity's Representative at least twenty-eight (28) days prior to the date when the Contractor desires the Procuring Entity's Representative's consent. In the event the Procuring Entity's Representative determines that such proposed deviations do not ensure substantially equal or higher quality, the Contractor shall comply with the standards specified in the documents.

These notes are intended only as information for the Procuring Entity or the person drafting the Bidding Documents. They should not be included in the final Bidding Documents.

- E. Site verification / inspection shall be conducted to validate the scope of works. No extra correpressation and extension of time shall be given due to negligence or tradivertence.
- F. The quality of materials shall be of the best grade of their respective kinds for the purpose. The work shall also be performed in the best and most capable manner in strict accordance with requirements of the plans and details. All materials not conforming to the requirements of these specifications shall be considered as defective.
- G. All equipment and installations shall meet or exceed minimum requirements of the standards and codes.
- Mobilization and Demobilization (if applicable)
 - Mobilization shall include all activities and related costs for transportation of personnel, equipment, and operating supplies to the site; establishment of offices, buildings, and other necessary general facilities for the operations at the site.
 - Demobilization shall include all activities and costs for transportation of personnel, equipment, and supplies not anymore required within the construction site including the disassembly, removal and site clean-up of offices and other facilities assembled on the site specifically for this central?
- Execute work in strict accordance with the hest practices of the trades in a thorough, substantial, workmanlike manner by competent workmen. Provide a competent, experienced, full-time supervisor who is outhorized to make decisions on hehalf of the Contractor.
- Adequate construction safety and health protection shall be provided at all times during the execution of work to both workers and property.

- A fully-trained Medical Aide shall be employed permanently on the site who shall be engaged solely to medical duties.
- The medical room shall be provided with waterproofing: it could be a building or soom designated and used exclusively for the purpose and have a floor area of at least 15 square meters and a glazed window area of at least 2 square meters.
- The locution of the medical room and any other arrangements shall be made known to all employees by posting on prominent locations and suitable notices in the site.
- Additional safety precautions shall be provided in the event of a pandemic. Protocols set fortiby the government shall be strictly followed.
- Construction safety shall consist of construction canopy and safety net.
- K. Necessary protections to the adjacent property shall be provided to avoid untoward incidents.
 A accidents.
- L. A systematic approach for managing vehicular and pedestrian traffic within the project area shall be provided adhering to relevant regulations and standards, prioritizing the safety of workers, motorists, and pedestrians while maintaining the flow of traffic during construction activities. It shall delineate designated traffic routes, temporary signage, and traffic control measures such as flagging operations or temporary traffic signals.
- M. Final cleaning of the work shall be employed prior to the final inspection for the certification of final acceptance. Final cleaning shall be applied on each surface or unit of work and shall be of condition expected for a building cleaning and maintenance program.

SITE WORKS

- A. Al. grades, lines, levels and dimensions shall be verified as indicated in the plans and details. Any discrepancies or inconsistencies shall be reported before commencing work.
- B. This tient shall consist of the removal wholly or in part, and satisfactory disposal of all buildings, fences, structures, old pavements, abandoned pipe lines, and any other observations which are not designated or permitted to remain, except for the obstructions to be removed and disposed of under other items in the Contract.

Removal and/or demutation of existing structures shall be done in accordance to safety procedures.

C. All excavations shall be made to grade as indicated in the plans. Whenever water is encountered in the excavation process, it shall be removed by pumping, care being taken that the surrounding soil particles are not disturbed or removed.

The Contractor shall notify the Engineer sufficiently in advance of the beginning of any excavation so that cross-sectional elevations and measurements may be taken on the undisturbed ground. The natural ground adjacent to the structure shall not be disturbed without permission of the Engineer.


Trenches or foundation pits for structures or structure footings shall be excavated to the lines and grades or elevations shown on the Plans or as staked by the Engineer. They shall be of sufficient size to permit the placing of structures or structure footings of the full width and length shown. The elevations of the buttoms of footings, as shown on the Plans, shall be considered as approximate only and the Engineer may order, in writing, such changes in dimensions or elevations of footings as may be deemed necessary, to secure a satisfactory foundation.

Pouldars, logs, and other objectionable materials encountered in excavation shall be removed.

After each expanation is completed, the Contractor shall notify the Engineer to that effect and no forming, bedding material or pipe culvert shall be placed until the Engineer has approved the depth of excavation and the character of the foundation material

D. All excavated materials, so far as suitable, shall be utilized as backfull. The surplus materials shall be disposed of in such manner as not to obstruct the stream or otherwise impair the efficiency or appearance of the structure. No excavated materials shall be deposited at any time so as to endanger the partly finished structure.

All backfills shall be placed in layers not exceeding to 150mm in thickness and each layer shall be thoroughly compacted by wetting, tomping and follows.



II. CIVIL/STRUCTERAL WORKS

A. CONCRETE WORKS

- Delivery, Storage, and Handling. All materials shall be so delivered, stored, and handled as to
 prevent the inclusion of foreign materials and the damage of materials by water or breakage.
 Package materials shall be delivered and stored in original packages until ready to be used.
 Packages or materials showing evidence of water or other damage shall be rejected.
- 2. Unless otherwise specified herein, concrete works shall conform to the sequirements of the ACI Building Code. Full cooperation shall be given on trades to install embedded items. Provisions shall be made for setting items not placed in the forms. Before concrete is placed, embedded items shall have been inspected and tested for concrete aggregates and other materials shall have been done.

Materials

- Coment for concrete shall conform to the requirements of specifications for Purtland Cement (ASTM C = 150).
- b. Water used in mixing concrete shall be clean and free from other injurious amounts of oils, acids, alkaline, organic materials or other substances that may be deleterious to concrete or steel.
- c. Fine aggregates shall be beach or river sand conforming to ASTM C33, "Specification for Concrete Aggregates". Sand particle shall be course, shalp, clean free from salt, dust, loam, dirt and all foreign matters.
- Coarse aggregates shall be either natural gravel or crushed rock conforming to the "Specifications for Concrete Aggregates (ASTM C33). The minimum size of aggregates shall be larger than one fifth (1/5) of the narrowest dimensions between sides of the forms within which the concrete is to be cast nor larger than three fourths (3/4) of the minimum clear spacing between reinforcing bars and forms.

4. Proportioning and Mixing

a. Proportioning and mixing of concrete shall conform to the requirements for Items 495 of the standard specification with the following proportions:

Cement: Sand: Grave! Class "A" - 1: 2: 3 Class "B" - 1: 2: 4 Class "C" - 1: 2 %

- Concrete mixture to be used for concrete shall conform with the structural requirements
- c. Mixing concrete shall be machine mixed. Mixing shall begin within 30 minutes after the cement has been added to the aggregates.

5. Forms

- a. General Forms shall be used whatever accessary to confine the concrete and shape it to the required lines, or to insure the concrete of contamination with materials caving from adjacent, excavated surfaces. Forms shall have sufficient strength to withstand the pressure resulting from placement and vibration of the concrete, and shall be maintained rigidly in correct position. Forms shall be sufficiently tight to prevent loss or morear from the concrete. Forms shall be W** (fintin) thick ordinary plywood and form lumber.
- Cleaning of Forms before placing the concrete, the contact surfaces of the tormed half be cleaned of encrustations of morear, the grout or other foreign material
- e. Removal of Forms forms shall be removed in a manner which will prevent damage to the concrete. Forms shall not be removed without approval. Any repairs of surface imperfections shall be formed at once and biring shall be started as suom as the surface is sufficiently hard to permit it without further damage.

Placing Reinforcement.

Steel reinforcement shall be provided as indicated, together with all necessary tie wates, chairs, spacers, supports and other devices necessary to install and secure the reinforcement properly. All reinforcement, when placed, shall be free from loose, flaky rust and scale, oil, grease, clay and other ceating and foreign substances that would reduce or destroy its bond with concrete. Reinforcement shall be placed accurately and secured in place by use of metal or concrete supports, spacers and ties. Such supports shall be used in such manner that they will not be exposed or contribute in any way, to the discoloration or deterioration of the concrete.

Conveying and Placing Concrete:

- a. Conveying concrete shall be conveyed from mixer to forms as rapidly as applicable, by methods which will prevent segregation, or loss of ingredients. There will be no vertical drop greater than 1.5 meters except where suitable equipment is provided to prevent segregation and where specifically authorized.
- Placing concrete shall be worked readily into the corners and angles of the forms and around all reinforcement and imbedded dams without permitting the material to segregate, concrete shall be deposited as close as possible to its final position in the forms so that flow within the mass dues not exceed two (2) meters and consequently segregation is reduced to a minimum near forms or embedded items, or elsewhere as directed, the discharge shall be so controlled that the concrete may be effectively compacted into horizontal layers not exceeding 30 centimeters in depth within the maximum lateral movement specified.
- c. Time interval between mixing and placing. Concrete shall be placed before initial set has occurred and before it has contained its water content for more than 45 minutes. No concrete mix shall be placed before 60 complete revolution of the machine mixer.
- d. Consulidation of Concrete concrete shall be consolidated with the aid of mechanical vibrating equipment and supplemented by the hand spading and tamping. Vibrators shall not be inserted into lower cursed that have commenced initial set; and reinforcement embedded in concepts beginning to set or already set shall not be disturbed by vibrators. Consolidation around major embedded parts shall by hand spading and tamping and vibrators shall not be used.
- e. Placing Concrete through reinforcement. In placing concrete through reinforcement, core shall be taken that no segregation of the coarse aggregate occurs. On the bottom of hearts and slabs, where the congestion of steel near the forms makes placing difficult, a layer of morear of the same conjent-sand ratios as used in concrete shall be first deposited to cover the surfaces.

Curing

- B. General All concrete shall be moist cured for a period not less than seven (7) consecutive days by an approved method or combination applicable to local conditions.
- b. Moist Curing. The surface of the concrete shall be kept continuously wer by covering with burlay plastic or other approved materials thoroughly saturated with water and keeping the covering spraying or intermittent hesing.

Finishing

- a. Concrete surfaces shall not be plastered unless otherwise indicated. Exposed concrete surfaces shall be formed with plywhold, and other removal of forms, the surfaces shall be smooth, true to line and shall present or finished appearance except for minor defects which can be easily repaired with patching with cement mortar, or can be grounded to a smooth surface to remove all joint marks of the form works.
- Concrete Slabs on Fift. The concrete slabs on fift shall be laid on a prepared foundation consisting of sub-grade and granulus fift with thickness equal to the thickness of the overlaying slab except when indicated

B. METAL FABRICATION

Materials:

- Steel and from If not specified otherwise, use standard mith finished structural steet shapes or but rrun in compliance with AISC Specifications for Design, Fabrication and Frection of Structural Steel for buildings.
- Bolts, Nots, Study and Rivets, ASTM A 307 and A 325.
- Screws, Fed. Spec FF-S-85, Fed. Spec FF-S-92, and Fed. Spec 197-5-111.
- Meta's Partins. High grade galvanized steel with minimum tensile strength of 275 MPa, L4mm in thickness or approved equal.

Fabrication:

By mechanics skilled in the trade and in accordance with the manufacturer's directions. Metalwork shall be fabricated to allow for expansion and contraction of materials. Provide welding and bracing of adequate strength and durability, with tight, flush joints, dressed smooth and clean. Complete with bolts and nots.

3. Metal Surfaces:

Surfaces that be clean and free from all scale, flake, rust and rust pitting; well-formed and finished to shape and size, with sharp lines, angle and smooth surface. Shearing and punching shall leave clean true lines and surfaces. Weld or river permanent connections. Weld and flush rivers shall be used and finished flush smooth on surfaces that will be exposed after installation. Do not use screws or bolts where they can be avoided; when used, heads shall be counterstank, screwed up right and threads nicked to prevent loosening.

Construction:

Thickness of metals and details of assembly and supports shall give ample strength and stiffness for the minimum loads specified or indicated. Joints exposed to weather shall be formed to exclude water.

Welding:

Use welding electrode E70xx and perform welding, welding inspection and corrective welding in accordance with AWS D1.1. Weld in a manner to prevent permanent distortion of the connected parts. Weld continuously along the entire area of contact (except where tack welding is permitted. Do not tack weld exposed to connections). Grind smooth visible weld in finished installation.

III. ARCHITECTURAL WORKS

A. WALL FINISHES

Coment Plaster Finish. Mortar mixture for brown cost shall be freshly prepared and uniformly
mixed in the proportion by volume of one part Portland coment, three (3) parts sand and one
fourth (1/4) part hydrated time.

Finish coat shall be pure Portland coment properly graded conforming to the requirements and nexted with water to approved consistency and plasticity.

B. PAINTING WORKS

- Paint Materials, All tyges of paint material and other related products shall be subject to test as to material composition by the Bureau of Research and Standard, DPWH or the National Institute of Science and Technology.
- Tinting Colors. Tinting colors shall be first grade quality pigment ground in alkyd resin that
 disperses and mixes easily with paint to produce the color desired. Use the same brand of paint
 and tinting color to effect good paint body.

- Panting and varnishing works shall not be commenced when it is too hot or colo.
- Allow appropriate ventilation during application and drying period
- All hardware will be fitted and removed or protected prior to painting and varnishing works.
- Application. Points when applied by brush shall become non-fluid, thick enough to lay down
 as adequate film of wet paint. Brush marks shall have flowed out after application of paint.

Pairus made for application by soller most be similar to brushing paint. It must be non-sticky when thinned to spraying viscosity so that it will break up easily into droplets.

Paint is atomized by high pressure pumping rather than broken up by the large volume of air mixed with it. This procedure changes the required properties of the paint.

IV. ELECTRICAL WORKS

DESCRIPTION

This Item shall consist of the famishing of materials, equipment and labor for the installation of roudway lighting works which includes the street light posts and concrete footings/ foundations, panel board (Lighting Contactor/Control Panel), electrical services including all conduits, pull boxes and junction boxes, wires and cables, photocell control concrete pedestal and meter base, luminaires and its accessories, emergency tunnel lightings, programmable logic controller (PLC) and built-in advertising display (other installed accessories).

The location of street lighting posts shown on the Drawings are approximate and the exact location shall be determined established by the Engineer in the field.

MATERIAL REQUIREMENTS

All materials shall be brand new and shall be of the approved type. It shall conform to the requirements of the Philippine Electrical Code and the products locally manufactured shall bear a Philippine Standard (PS) mark, while imported products shall bear Import Commodity Clearance (ICC) certification marks duly issued by the Bureau of Philippine Standards (BPS).

CORROSION PROTECTION

Ferrous metal raceways, cable armor, boxes, cable sheathing, cabinets, elbows, couplings, nipples, fittings, supports, and support hardware shall be permitted to be installed in concrete or in direct contact with soil. Corresion protection shall be provided in areas subject to severe corresive influences were made of material approved for the condition or were provided with corresion protection approved for the condition as indicated in the Plans or as approved by the Engineer.

SYSTEM PROTECTION

All street lighting systems shall be protected by an overcurrent device. The overcurrent device shall be sized rated or setting not higher than the allowable ampacity of the conductor. The circuit breakers shall be of the thermal magnetic type having inverse-time tripping characteristics on overload and instantaneous trip on short circuits, shall be equipped with are quenches, shall have quick-make and quick-break toggle mechanism, and shall have trip-free operating with are quenches, shall have quick-make and quick-break toggle mechanism, and shall have trip-free operating handles. Each multi-pole breaker shall have a common trip so that an overload on one pule will automatically cause all poles of the breakers to open.

STREET LIGHTING POST AND CONCRETE FOOTING

STREET LIGHTING POST

Street Lighting Posts shall adhere to the details as indicated on the Plans. For Single-Arm and Double-Arm Post, rising a minimum of 8.0 meters above finished ground with a maximum of 3 meters overhang.

All posts shall be designed to withstand, with the associated luminaires, a wind velocity of 250 kilometers per hour determined in accordance with AASHTO LTS-6, Standard Specifications for Structural Supports for Highway Signs, Luminaires, and Traffic Signals while supporting luminaires having effective projected area indicated. Poles shall be anchore; based types designed for use with underground supply conductors.

All posts shall have an inspection door or hand hole and shall have a suitable gasketed screw cover. After the post has been erected, scaled and fixed in the foundation block, a coal of finishing aluminum paint shall be applied. Posts shall be provided with galvanized steel anchor bolts threated top end and with a hooked bent at an angle end at the buttom. Size of the anchor bolts shall be as Indicated on the Plans.

Pote shaft shall be made in accordance with ASTM ASSM, Standard Specification for Pipe, Steel, Black and Hol-Dipped, Zinc Coated, Welded and Seamless.

Anchor bases shall be provided with hos-dipped, galvanized steel anchor bolts with double nots and washers, threaded at the top end and bended at 90° at the bottom and. Galvanized nots, washer, and ornamental covers shall also be provided for anchor bolts. Galvanizing shall be in accordance with the requirements of ASTM A153, Standard Specification for Zinc Coating (Hos-Dip) on Iron and Steel Hardware or AASHTO MITT, Standard Specification for Zinc (Hos-Dip Galvanized) Coatings on Iron and Steel Products (ASTM A123) for the fittings.

LUMINAIRE AND HOUSING

All lighting fixtures and lamps are as specified and listed on the lighting fixture schedule.

Luminaires shall be made of heated die cast aluminum and alloy and painted with an electrocoat gray paint finish or shall be designed, equipped and gasketed to preclude any entry of water or dust into the interior surfaces under high wind conditions.

The Contractor shall supply, install, and replace defective lamp in the first 12 months of defect liability period. The luminaire shall be designed to operate at 230 volts. A.C., 60 hertz, single-phase and shall be in compliance with UL 1598, and an IEC 529 lagress protection 55 (IPSS) construction. Luminaires with complete lamps of the number, type and wattage indicated shall be provided. Luminaires for roadway lighting shall be the shallow glass "cobra head" style, "venical" head style, or 'brigh mast' style or as indicated on the Plans.

The acceptable levels of luminance shall be achieved under normal operation.

Light Emining Diode (LED) luminaire Requirements:

- 1. Housing shall be primarily constructed of corrosion-resistant cast aluminum with a powder coaled thrish of a neutral culor.
- All mounting hardware shall be of non-corrusive or suitably protected metal.
- 3. Driver and 1.F.D modules shall be replaceable as separate units with tool-less plug-in electrical connections.
- Luminaire housing shall be UL listed for wet locations. Optical assembly shall be minimum IP-66 rated per IEC.

BALLAST

Ballasts shall operate within the range of voltage-current characteristic parameters that are compatible with the lamp used. Ballasts shall be capable of lamp starting at ambient

Temperatures down to minus 29 rc.

CONDUIT

Conduit shall be provided in the size as indicated on the Drawings. Conduits shall be standard rigid steet, zinc conted or galvanized. Intermediate metal conduit shall be used if shown or specified on the Plans.

Finings such as locknuts and bushings shall be galvanized. Exposed conduits for service entrance shall be galvanized intermediate inetallic conduit and fittings and shall conform to ANSI C 80.1, Galvanized Rigid Conduit. Tapped conduit hub shall be provided for the panel board.

STREET LIGHTING POST CONCRETE FOOTINGS

Street lighting post concrete footing shall be Class A and shall conform with Subsection 405.2,

Material Requirements of from 405, Structural Concrete.

All electrical lighting post factings with dimensions indicated in the Plans shall be reinforced concrete and shall conform with the requirements for concrete structures of this Specification. Excavation and backfill for foundation including disposal of surplus material shall be provided. Excavated holes for concrete feetings shall be neat or properly formed and free from loose materials when the concrete is placed

When placed, the concrete shall be wall consolidated to completely fill and devoid in the hole and around the post when embedded. Concrete shall be major wired for not less than 4 days.

ELECTRICAL CONDUCTORS AND GROUNDING

Wires and cables shall be of the approved type meeting all the requirements of the Philippine Electrical Code and the products locally manufactured shall bear a Philippine Standard (PS) mark, while imported products must bear Import Commodity Clearance (ICC) certification marks duly assued by the BPS.

All wires shall be copper, soft drawn, annealed smooth and of cylindrical form and shall be centrally located uside the insulation. Conductor sizes shall be not less than the indicated sizes on the Drawings.

All non-current carrying metallic parts like conduits, cabinets, and equipment frames shall be properly grounded in accordance with the Philippine Electrical Code, latest edition

The size of the ground cods and ground wells shall be as shown on the Plans. The resistance shall not be more than 5 olims. Grounding wire shall be made of bare copper stranded, soft; drawn wire and shall be installed in one continuous length without splice or joint. Ground rods shall be made of copper-clad steel of not less than 20 mm diameter x 3. meters in length driven in full length into earth.

LIGHTING CONTROL PANEL/PANELBOARD

All panelboards shall conform to the schedule of panelboards as shown on the Plans with respect to supply characteristics, ratings of main lugs or main circuit breaker, number, ratings, and capacities of branch circuit breakers. Panelhoard cabinets shall be designed and fabricated for pole surface mounted. Enclosures shall be fabricated to be watertight, dustlight, temper proof, dead front suitable for outdoor installation, and for 230 volts, single-phase, 60 Hertz application in accordance with National Electrical Manufacturers Association (NEMA) requirements.

The interior and exterior of cabinot shall be given two coats of the manufacturer's standard point which is high gray in color. Conduit entry shall be at the top and bottom. A directory holder shall be provided inside the panel and ground lug for ground wire connection. Nameplate of laminated plassic shall be attached by means of stainless-steel rivets or permanent adhesive showing panelboard number.

CIRCUIT BREAKERS

All circuit breakers shall be plug in and thermal magnetic type, manually or electrically operated as required with ratings and capacity as shown on the Plans.

All circuit breakers shall have inverse-time tripping characteristics on overload and instantoneous trip on short einmits. It shall have quick make or break toggle mechanism, trip-free operating handle, and shall be equipped with are quenches. Each multi-pole breaker shall be designed to have a common trip so that an overload or short on one pole will automatically cause all poles of the breakers to open.

All circuit breakers shall be amblicat compensated to 50 °C to carry full cated current with uniform tripping. characteristics throughout the temperature range from 25 °C. The circuit shall have an interrupting rating of not less than 14,000 symmetrical amperes of 230 volts. AC.

TERMINAL CONNECTOR

Connectors for wiring shall be rated at least 600 volts and shall be of the following types:

For 5.5 mm/2 and smaller conductors/cables: Rugged material, such as phenolic, shall be mounted end-to-end without spacing. The pressure type tin place copper connectors shall have non-flammable and self-extinguishing insulation. with temperature rating equal to that of the conductor insulation.

For \$.0 mm2 and above conductors/cables: Type of construction shall be one-piece and material shall be phenolic. Terminal configuration shall be done by binding screw terminals. Sulderless type connector made of compact, high strength, high copper alloy, split-bolt, free tunning threads and highly resistant to corresion and cracking shall be used. Maximum pressure and assure/sequre connection on all combinations of run and rap conductors shall be provided.

MAIN FEEDER DISTRIBUTION SYSTEM

The Main Feeder Distribution System in madway lighting works is composed of the following:

1. Conduit

CONSTRUCTION REQUIREMENTS

All works shall be executed in the best practice as a workmanlike manner by qualified and experienced electricians under the immediate supervision of a duly Registered Electrical Engineer.

STREET LIGHTING POST

All street lighting posts shall be constructed of cold rolled mild steel of a sufficient gauge having yield strength of not less than 248.2 MPa and shall be followed with a prime cost of paint within 24 hours. The prime cost of paint shall be companishe with the finish cost of paint.

The pole shall be provided with a hand hole and grounding tug attachment at the elevation and a cable entry slot sized and located as slown on the standard drawings. The slot shall be free of borns and sharp edges.

LUMINAIRES AND HOUSING

Luminaires shall be rebustly constructed, weatherpoort, had proof, insect proof, corresion proof, solar (including ultra-violet) resistant, and vandal resistant

The construction of the housing shall be such that crucking cannot occur during the process of fixing the luminaire to the pole or bracket. The housing shall be made of heat-treated, the- cast aluminum or aluminum alloy and shall be painted with an electro coat gray paint finish. It shall have readily accessible internal parts and easy to open when properly mounted. The furnitable surfaces, joints, and rim shall be smoothed and freed of burns and sharp edges that could cause injury to the workman.

Hardware such as hinges, latches, springs, nuts, screws, washers, pins, among others, shall be made of materials compatible to the housing material and shall be inherently corresion- proof or have been protected by finishes approved for corrosion resistance. However, those expused to the elements shall be made of high-grade stainless steel.

BALLAST

Ballasts shall be of the encapsulated or vacuum impregnated type. The process of vacuum impregnation shall be such that the interstices of the windings are completely filled with the impregnating material. Connections shall be brought out to a suitable brack screw terminal block mounted on the ballast housing. Terminal blocks with steel screws will not be acceptable.

CONDUIT

All electrical conduits and fittings shall be installed in their correct positions and locations as shown on the Plans. The conduits shall be directly buried in earth, except under paved areas and roadways, the conduit shall be enuased in concrete and end of conduits shall be plugged with patching compounds at all outlets, or boxes, to keep the conduits dry. Trenches in which the PVC conduits are taid shall follow the alignment as indicated on the Drawings. In trenches and sidewalks, the PVC conduit shall be laid on 10 cm sand bed and covered by a layer of sand, 20 cm on thick measured from the upper level of the bed. For trenches under paved areas the same procedures shall be followed. except the concrete shall be used in the place of sand. After placing the concrete, the remaining part of the treach shall be backfilled up to the sub-grade level with soil compacted. Cables shall be installed in one length from point to point and no joints shall be permitted. Before the cables are pulled, the Contractor shall see to it that the conduits are continuous and clear of debris, stone, and sand, Sharp bends shall not be permitted. A minimum covering of 0.45 meter under the pavement shall be required for the conduits under the roadway

STREET LIGHTING POST CONCRETE FOOTINGS

Street lighting posts concrete (notings shall be square in shape or as shown on the Plans. Anchor bolt circle dimensions shall be furnished and rigid template shall be used to center the anchor holts in the foundation. Unless otherwise specified, the template shall be oriented so that the mast arm of the lighting standard is perpendicular to the cemerline of the roadway. The top of the concrete foundation shall be constructed in level and only shims used to take the lighting standard shall be permitted. Shims with break-away couplings shall not be permitted. Each foundation shall have an Imprinted arrows on the top of the foundation to indicate the direction of the cable duct run.

ELECTRICAL CONDUCTORS AND GROUNDING

All electrical conductors and grounding shall be famished and installed by the Contractor with the sizes as indicated on the Plans. All connection shall be mechanically and electrically sound and secured by insulating tape. Solderless connectors of approved type shall be used for making connections of power cables. The insulations in then shall be built up again to normal thickness with rubber and vinyl plastic tapes. Splices in conductors shall only be made at pull boxes, hand holes or cabinets. No kicks or abrasions in the insulation or protection covering shall be found in installed conductors.

All grounding system installation shall be executed in accordance with the Plans. Grounding system shall include ground rods and ground wire taps as shown in the approved design. The ground wire is connected to the top or side of the ground rod. The ground rod, ground wire connection is made by a thermo-wold process. The wire and ground rod is required to be free of needized materials, moisture, and other contumnates prior to inserting the wire and the ground rad into the properly sized mold. Too welding insternal is required to sufficiently cover and secure the conductor to the rod. The completed connection is required to be nonporous. This connection includes a quickdisconnect type connector kit so that in the event of a pole knockdown the connection readily breaks without damage. to the buried conductor.

CIRCUIT BREAKERS

Circuit breakers shall be mounted so that any individual branch breakers can be removed without disturbing adjacent units or without loosening or removing supplement insulation.

TEST AND GUARANTEE

Upon completion of the electrical construction work, the Contractor shall provide all test equipment. The Contractor shall then submit copies of all test results to the largineer.

After the installation of all cables, the Contractor shall test the insulation resistance of all feeders and connected equipment with a 600 volts negger for grounds and short circuits. Vesting shall include measuring of insulation resistance. These measurements shall be recorded by feeder and branch circuit number indicating the resistance values hetween phases and ground.

All effective and calibrated apparatus, materials and labor required for conducting tests shall be supplied and made available by the Contractor

The Contractor shall guarantee that the electrical installation is done and in accordance with the Plans and Specifications. The Contractor shall guarantee that the electrical systems are free from all grounds and from all defective workmanship and materials and will remain so for a period of one (1) year from date and acceptance of works. Any defect shall be remedied by the Contractor at his own expense.

METHOD OF MEASUREMENT

The work under this item shall be measured either by lengths, pieces, pairs, lot, and set actually placed and installed as shown on the Plans.

The quantity of street lighting and electrical work to be paid for shall be the number of lighting posts of single and double luminaires to include all conduits, huminaires, all witings, panelboard, nots, washer, concrete footing, fasteners, conduit clamps, bolts, capacitors, coils and others including all necessary materials and accessories needed for musture and fungus control, correction protections and all other incidentals needed to make the system operational and accepted to comply with the requirements of the latest edition of the Philippine Electrical Code. Part 2 and any other ordinances including payment of necessary permus from local enfercing authorities.

Notes on the Bill of Quantities

Objectives

The objectives of the Bill of Quantities are:

- a. to provide sufficient information on the quantities of Works to be performed to enable Bids to be prepared efficiently and accurately; and
- b. when a Contract has been entered into, to provide a priced Bill of Quantities for use in the periodic valuation of Works executed.

In order to attain these objectives, Works should be itemized in the Bill of Quantities in sufficient detail to distinguish between the different classes of Works, or between Works of the same nature carried out in different locations or in other circumstances which may give rise to different considerations of cost. Consistent with these requirements, the layout and content of the Bill of Quantities should be as simple and brief as possible.

Daywork Schedule

A Daywork Schedule should be included only if the probability of unforeseen work, outside the items included in the Bill of Quantities, is high. To facilitate checking by the Entity of the realism of rates quoted by the Bidders, the Daywork Schedule should normally comprise the following:

- a. A list of the various classes of labor, materials, and Constructional Plant for which basic daywork rates or prices are to be inserted by the Bidder, together with a statement of the conditions under which the Contractor will be paid for work executed on a daywork basis.
- b. Nominal quantities for each item of Daywork, to be priced by each Bidder at Daywork rates as Bid. The rate to be entered by the Bidder against each basic Daywork item should include the Contractor's profit, overheads, supervision, and other charges.

Provisional Sums

A general provision for physical contingencies (quantity overruns) may be made by including a provisional sum in the Summary Bill of Quantities. Similarly, a contingency allowance for possible price increases should be provided as a provisional sum in the Summary Bill of Quantities. The inclusion of such provisional sums often facilitates budgetary approval by avoiding the need to request periodic supplementary approvals as the future need arises. Where such provisional sums or contingency allowances are used, the SCC should state the manner in which they will be used, and under whose authority (usually the Procuring Entity's Representative's).

The estimated cost of specialized work to be carried out, or of special goods to be supplied, by other contractors should be indicated in the relevant part of the Bill of Quantities as a particular provisional sum with an appropriate brief description. A separate procurement procedure is normally carried out by the Procuring Entity to select such specialized contractors. To provide an element of competition among the Bidders in respect of any facilities, amenities, attendance, etc., to be provided by the successful Bidder as prime Contractor for the use and convenience of the specialist contractors, each related provisional sum should be followed by an item in the Bill of Quantities inviting the Bidder to quote a sum for such amenities, facilities, attendance, etc.

Signature Box

A signature box shall be added at the bottom of each page of the Bill of Quantities where the authorized representative of the Bidder shall affix his signature. Failure of the authorized representative to sign each and every page of the Bill of Quantities shall be a cause for rejection of his bid.

These Notes for Preparing a Bill of Quantities are intended only as information for the Procuring Entity or the person drafting the Bidding Documents. They should not be included in the final documents.
