AWARDING THE CONTRACT FOR THE ACQUISITION OF GOODS AND SERVICES THROUGH ALTERNATIVE METHOD OF PROCUREMENT

WHEREAS, in its Resolution No. 07-112, Series of 2024 duly approved by the City Mayor, the Bids and Awards Committee on Goods and Services (the "Committee") recommended the use of negotiated mode as an alternative method of procurement pursuant to Section 53.1 of the Revised Implementing Rules and Regulations of RA 9184, which pertinently provides that negotiated procurement may be resorted to where there has been failure of competitive bidding for the second time; and

WHEREAS, CD GROUP OF COMPANIES CORPORATION participated in and submitted its quotations on the project for evaluation and passed the post-qualification process and may now be considered and declared as the Single Calculated and Responsive Offer, to wit:
