RESOLUTION **AUTHORIZING** THE CITYMAYOR, **HONORABLE** MA. JOSEFINA G. BELMONTE, TO EXTEND FINANCIAL ASSISTANCE **DONATE** THE**AMOUNT** OFPHP10,000,000.00 ANDTO9 SUBSTANTIALLY AFFECTED BY SEVERE TROPICAL STORM KRISTINE, TO BE TAKEN FROM THE CITY'S ACCUMULATED LOCAL DISASTER RISK REDUCTION AND MANAGEMENT (LDRRM) TRUST FUND

WHEREAS, under Section 458(a)(1)(iv) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the City Government is empowered to "adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities, and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood following said events";

WHEREAS, at 2:00 A.M. of 22 October 2024, "Kristine" intensified into a Tropical Storm. At 5:00 P.M. of the same date, "Kristine" slightly intensified over the Philippine Sea, East of Bicol. At 11:00 P.M. of the same date, "Kristine" maintained its strength as it moved northwestward over the sea of East of Bicol Region;

WHEREAS, Severe Tropical Storm Kristine has caused extensive damage across the Province of Camarines Sur and Albay, affecting numerous municipalities, displacing residents, and significantly impacting local infrastructure and livelihoods;

WHEREAS, the National Disaster Risk Reduction and Management Council (NDRRMC) Situation Report No. 13 for Severe Tropical Storm Kristine, as of October 28, 2024 (0800H), provided the data on affected municipalities, barangays, families and individuals in the Province of Camarines Sur and Albay, to wit:

WHEREAS, financial assistance in the amount of Php10,000,000.00 will aid the provision of essential relief, rehabilitation, and rebuilding efforts led by the Provincial Governments of Camarines Sur and Albay.

Belmonte, to extend financial assistance and donate the amount of Php10,000,000.00 to 9 LGUs substantially affected by Severe Tropical Storm Kristine, to be taken from the City's accumulated Local Disaster Risk Reduction and Management (LDRRM) Trust Fund.

RESOLVED FURTHER, that a copy of this Resolution be furnished to the relevant Local Government Units, members of the Quezon City Disaster Risk Reduction and Management Council, and other offices/departments concerned for their information, guidance, and reference.
