- Bidding will be conducted through open competitive bidding procedures using a non-discretionary 3. "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
- Prospective Bidders may obtain further information from QUEZON CITY GOVERNMENT Bids and 4. Awards Committee (BAC) Secretariat and inspect the Bidding Documents at the address given below during weekdays from 7:00 a.m. - 5:00 p.m.
