post the Performance Security and sign the contract within the same ten (10) day period shall result in the following:

1. Forfeiture of the bid security;
2. Disqualification from participating in the bidding at hand;
3. Upon conviction, the relevant officers or individuals will suffer the penalty of imprisonment of not less than six years and 1  
day and not more than fifteen years; and
4. Upon determination of administrative liability, through blacklisting proceedings. it will suffer corresponding penalty of  
suspension.
