



CONTRACT AGREEMENT

PROPOSED UPGRADING OF PLUMBING SYSTEM AND REHABILITATION OF COMFORT ROOMS AT TOMAS MORATO ELEMENTARY SCHOOL IN BARANGAY KAMUNING

QUEZON CITY, a local government unit existing under the laws of the Republic of the Philippines, represented herein by the **HONORABLE MA. JOSEFINA G. BELMONTE**, in her capacity as City Mayor, with office at Quezon City Hall Compound, Elliptical Road, Diliman, Quezon City, Metro Manila, and hereinafter referred to as the "**QUEZON CITY GOVERNMENT**";

- and -

NVDL BUILDERS, a sole proprietorship duly organized and existing under and by virtue of the laws of the Republic of the Philippines with office address at *Block 1 Lot 115 F. Chioco Street, Granwood Villas, Holy Spirit, District 2, Quezon City* herein represented by its **PROPRIETRESS, MS. GENEVIEVE P. DE LEON** hereinafter referred to as the "**CONTRACTOR**";

WHEREAS, the **QUEZON CITY GOVERNMENT** is desirous that the Contractor execute for the **PROPOSED UPGRADING OF PLUMBING SYSTEM AND REHABILITATION OF COMFORT ROOMS AT TOMAS MORATO ELEMENTARY SCHOOL IN BARANGAY KAMUNING** with **PROJECT NO. 24-00129**, hereinafter referred to as the "**PROJECT**", and the **QUEZON CITY GOVERNMENT** has accepted the Bid amounting to **EIGHT MILLION NINE HUNDRED FOUR THOUSAND SIX HUNDRED EIGHTY-SIX PESOS AND 49/100 ONLY (₱ 8,904,686.49)** by the **CONTRACTOR** for the execution and completion of such works and the remedy of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents as required by the 2016 Revised Implementing Rules and Regulations of the Republic Act No. 9184 shall be read and construed as part of this Agreement, to wit:
 - a. Philippine Bidding Documents (PBDs);
 - i. Drawings/Plans;
 - ii. Specifications;
 - iii. Bill of Quantities;
 - iv. General and Special Conditions of Contract;
 - v. Supplemental of Bid Bulletins, if any;
 - b. Winning bidder's bid, including the Eligibility Requirements, Technical and Financial Proposals, and all other documents or statements submitted;
 - c. Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g. Bidder's response to





request for clarification on the bid), including corrections to the bid, if any, resulting from the **QUEZON CITY GOVERNMENT**'s bid evaluation;

- d. Performance Security;
 - e. Notice of Award and Contract and the Bidder's conforme thereto; and
 - f. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
3. In consideration of the payments to be made by the **QUEZON CITY GOVERNMENT** to the **CONTRACTOR** as hereinafter mentioned, the **CONTRACTOR** hereby covenants with the **QUEZON CITY GOVERNMENT** to execute and complete the works and remedy any defects therein in conformity with the provisions of this Contract in all respects.
 4. The **QUEZON CITY GOVERNMENT** hereby covenants to pay the **CONTRACTOR** in consideration of the execution and completion of the works and the remedy of any defects wherein, the Contract Price or such other sum as may become payable subject to applicable withholding tax under the provisions of this Contract at the time and in the manner prescribed by this Contract.
 5. That the **CONTRACTOR** hereby certifies that the site was regularly inspected and verified.
 6. The **CONTRACTOR** further undertakes to implement the awarded project in accordance with the approved plans, specifications, and cost of contract.

IN WITNESS WHEREOF the parties have hereunto set their hands to this Agreement on DEC 10 2024, at Quezon City, Philippines.




