RESOLUTION NO. B009; S - 2024

**DECLARING THE SINGLE/LOWEST CALCULATED AND RESPONSIVE BIDS
AND RECOMMENDING APPROVAL FOR CONTRACT AWARDS**

WHEREAS, the Quezon City Government, through the Bids and Awards Committee (BAC) for Infrastructure and Consultancy Services downloaded an Invitation to Bid (ITB) dated **October 15, 2024** in the PhilGEPS and at conspicuous places in Quezon City Hall for the public bidding to be held on **November 11, 2024**, for **forty-eight (48) infrastructure projects** of the City Government;

WHEREAS, a total of **one hundred thirty-eight (138)** were issued bid documents;

WHEREAS, the BAC for Infrastructure and Consultancy Services issued Notice of Postponement dated **October 24, 2024** rescheduling the deadline of submission of bids and date of Opening of Bids;

WHEREAS, during the scheduled public bidding held on **November 11, 2024**, **one hundred thirty-eight (138)** bid proposals were received and opened and, after examination of said documents, **one hundred twenty-one (121)** were declared passed and their corresponding bid price read while **seventeen (17)** were declared failed;

WHEREAS, no motion/request for reconsideration was received by the BAC for Infrastructure and Consultancy Services from bidders whose bid were declared failed;

WHEREAS, by virtue of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184, otherwise known as the Government Procurement Reform Act, the BAC determines that if the bidder with **Single/Lowest Calculated and Responsive Bid** fails the criteria for post-qualification, it shall immediately notify the said bidder in writing of its post-disqualification and the grounds for it;

WHEREAS, evaluation of all bids received and rated passed and post-qualification of bidders with the single/lowest calculated bid submitted for each specific project have been conducted as prescribed in the Revised IRR of RA 9184;

NOW THEREFORE RESOLVED by the BAC for Infrastructure and Consultancy Services to declare the following bidders as having the single/lowest calculated and responsive bids submitted for the corresponding projects bid out by the BAC for Infrastructure and Consultancy Services on **November 11, 2024**:
