BELMONTE, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) – NCR, FOR THE IMPLEMENTATION OF ITS PROGRAMS IN QUEZON CITY, SUBJECT TO COMPLIANCE WITH APPLICABLE LAWS, RULES AND REGULATIONS

WHEREAS, the Department of Social Welfare and Development (DSWD) is the government agency primarily responsible for the delivery of coordinated social protection services aimed at eradicating poverty;

WHEREAS, the DSWD envisions a society where the poor, vulnerable and disadvantaged individuals, families, and communities are empowered for an improved quality life;

WHEREAS, the Local Government Units (LGUs) are mandated by law to address the needs of their respective constituents, empower their people, and allow them to have the widest possible participation in government affairs;

WHEREAS, the Quezon City Government intends to address the poverty of its citizens through the implementation of programs locally generated or in coordination with National Government Agencies;

WHEREAS, the Quezon City Government recognizes that the projects being implemented by the DWSD are designed to deliver coordinated social protection services aimed at addressing poverty;

WHEREAS, the Quezon City Government also recognizes that a partnership with the DSWD will greatly contribute in the attainment of the program objectives and will bring forth reduced poverty among the citizens of the City;

WHEREAS, the Quezon City Government and the DSWD-NCR have previously entered into several Agreements for the implementation of Social Protection Programs, Cash-for-Work Program, and Pantawid Pamilyang Pilipino Program;

WHEREAS, pursuant to Section 455 (b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the City Mayor shall represent the City in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon the authority of the Sangguniang Panlungsod or pursuant to law or ordinance.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the City Mayor, Honorable Ma. Josefina G. Belmonte, to enter into and sign a Memorandum of Agreement with the Department of Social Welfare and Development (DSWD) – NCR, for the implementation of its programs in Quezon City, subject to compliance with applicable laws, rules and regulations.
