WHEREAS, Richard Ong is applying for a Certificate of Exception for the Proposed Four (4)-Storey Commercial (451 square meters) and Residential (8 Units) Building with Basement Parking located at Lot 16-A and 16-B, (No. 83) Scout Gandia Street, Barangay Laging Handa, District IV, Quezon City;


