**RESOLUTION NO. B011; S - 2024**

**DECLARING THE LOWEST CALCULATED AND RESPONSIVE BIDS  
AND RECOMMENDING APPROVAL FOR CONTRACT AWARDS**

WHEREAS, the Quezon City Government, through the Bids and Awards Committee (BAC) for Infrastructure and Consultancy Services posted an Invitation to Bid (ITB) dated **October 15, 2024** in PhilGEPS and at conspicuous places in Quezon City Hall for the public bidding to be held on **November 11, 2024**, for **forty-eight (48) infrastructure projects** of the City Government;

WHEREAS, a total of **one hundred thirty-eight (138)** prospective bidders were issued bid documents;

WHEREAS, the BAC for Infrastructure and Consultancy Services issued a Notice of Postponement dated **October 24, 2024**, rescheduling the deadline of submission of bids and the date of Opening of Bids;

WHEREAS, during the scheduled public bidding held on **November 11, 2024**, **one hundred thirty-eight (138)** bid proposals were received and opened and after examination of the said documents, **one hundred twenty-one (121)** were declared passed, and their corresponding bid price were read, while **seventeen (17)** were declared failed;

WHEREAS, no motion/request for reconsideration was received by the BAC for Infrastructure and Consultancy Services from bidders whose bid were declared failed;

WHEREAS, by virtue of the 2016 Revised Implementing Rules and Regulations (RIRR) of Republic Act No. 9184, otherwise known as the Government Procurement Reform Act, the BAC for Infrastructure and Consultancy Services determines that if the bidders with **Single/Lowest Calculated and Responsive Bid** fails the criteria for post-qualification, it shall immediately notify the said bidder in writing of its post-disqualification and the grounds for it;

WHEREAS, evaluation of all bids received, rated passed, and post-qualification of bidders with the single/lowest calculated bid submitted for each specific project have been conducted as prescribed in the RIRR of RA 9184;

NOW, THEREFORE, BE IT RESOLVED by the BAC for Infrastructure and Consultancy Services to declare the following bidders as having the lowest calculated and responsive bid submitted for the corresponding project bid out by the BAC for Infrastructure and Consultancy Services on **November 11, 2024**;
