RESOLUTION AUTHORIZING THE CITY MAYOR, **HONORABLE** MA. JOSEFINA G. BELMONTE, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE NATIONAL HOUSING AUTHORITY AND THE MUNICIPALITY OF BARAS, RIZAL FOR THE PROVISION OF ASSISTANCE TO THE MUNICIPALITY OF BARAS FOR THE BENEFIT OF RELOCATED INFORMAL SETTLER FAMILIES FROM QUEZON CITY

WHEREAS, it is the declared policy of the State to provide the people with adequate and decent housing facilities and to encourage various stakeholders to participate in the program of the government;

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, Republic Act No. 7279, otherwise known as the Urban Development and Housing Act of 1992, and Quezon City Ordinance No. SP- 2771, S-2018, otherwise known as the Quezon City Comprehensive Socialized Housing Code of 2018, the Quezon City Local Government (QC-LGU) is mandated to take a principal role in the provision of decent and affordable housing to underprivileged and homeless citizens;

WHEREAS, the QC-LGU relocated its Informal Settler Families (ISFs) to the resettlement site of the National Housing Authority (NHA) situated in the Municipality of Baras, Rizal;

WHEREAS, the Local Government of Baras, Rizal (BARAS-LGU) has agreed to accommodate the ISFs-relocatees from Quezon City to the NHA resettlement site within its jurisdiction; but due to its limited resources and budgetary constraints to provide and sustain the essential needs of the said relocatees, there is a need for support from the QC-LGU;

WHEREAS, the QC-LGU is well aware that to live a humane life at the relocation site, the resettled ISFs need to have an access to basic needs such as education, health, permanent utility services, affordable transportation, peace and order, and livelihood programs;

WHEREAS, the QC-LGU agrees to provide support services in the areas of education, health, permanent utility services, affordable transportation, peace and order, and livelihood programs to the Municipality of Baras, Rizal pending the availability and provision of post-relocation assistances and services mandated under the resettlement program of the national government;

WHEREAS, pursuant to Section 300 of the Local Government Code of 1991, provinces, cities, and municipalities may, upon approval of a majority of all members of the Sanggunian concerned and in amounts not exceeding their surplus funds, extend loans, grants or subsidies to other Local Government Units under such terms and conditions as may be agreed upon by the contracting parties;

WHEREAS, the QC-LGU shall provide assistance to the BARAS-LGU for the programs, projects and activities mutually agreed upon by both parties through a Work and Financial Plan;

WHEREAS, pursuant to Section 455(b)(1)(vi) of the Local Government Code of 1991, the City Mayor, shall represent the City in all its business transactions and sign in its behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.
