RESOLUTION NO. SP- **9939**, S-2024

A RESOLUTION AUTHORIZING THE RELEASE OF FINANCIAL ASSISTANCE AMOUNTING TO TEN MILLION PESOS (PHP10,000,000.00) TO THE LOCAL GOVERNMENT UNITS (LGUs) OF BATANES, QUIRINO AND AURORA WHICH WERE SUBSTANTIALLY AFFECTED BY SEVERE TROPICAL STORM JULIAN AND SUPER TYPHOON PEPITO, UPON THE RECOMMENDATION OF THE QUEZON CITY DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL (QCDRRMC)

WHEREAS, Republic Act No. 10121, otherwise known as the Philippine Disaster Risk Reduction and Management Act of 2010, mandates the local government units to provide necessary support to areas affected by disasters;

WHEREAS, the Quezon City Disaster Risk Reduction and Management Council (QCDRRMC), through Resolution No. 11, S-2024 adopted on November 14, 2024, recommended the provision of financial assistance to Local Government Units (LGUs) substantially affected by Severe Tropical Storm Julian and Super Typhoon Pepito;

WHEREAS, QCDRRMC Resolution No. 11, S-2024 emphasized the extensive damage and destruction caused by Severe Tropical Storm Julian on September 30, 2024 and Super Typhoon Pepito on November 16, 2024, as reported by Philippine Atmospheric, Geophysical, and Astronomical Services Administration (PAGASA) and the National Disaster Risk Reduction and Management Council (NDRRMC), affecting thousands of residents in the provinces of Batanes, Quirino and Aurora;

WHEREAS, the Quezon City Government recognizes the importance of extending solidarity and assistance to disaster-stricken areas and aims to contribute to their recovery and rehabilitation.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED, to authorize, as it does hereby authorize, the release of financial assistance amounting to Ten Million Pesos (Php10,000,000.00) to the Local Government Units (LGUs) of Batanes, Quirino and Aurora which were substantially affected by Severe Tropical Storm Julian and Super Typhoon Pepito, upon the recommendation of the Quezon City Disaster Risk Reduction and Management Council (QCDRRMC)

RESOLVED FURTHER, that the financial assistance shall be allocated as follows:

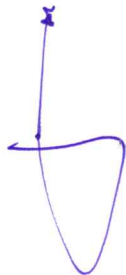
