ORDINANCE NO. SP- 3352 , S-2024

AN ORDINANCE PROVIDING FOR THE HEALTHCARE INSURANCE PROGRAM FOR ALL QUEZON CITY GOVERNMENT OFFICIALS AND EMPLOYEES AND APPROPRIATING THE NECESSARY FUNDS THEREFOR

WHEREAS, it is the policy of the State to protect and promote the right to health of the people and instill health consciousness among them;

WHEREAS, the Philippine Development Plan 2023-2028 and the Health Sector Strategy for 2023-2028 mandate the protection of Filipinos from health risks and financial risks to enable them to be healthy;

WHEREAS, according to the Philippine Statistics Authority, household out-of-pocket payments make up a share of at least 44.7 % in the Country's health expenditure by healthcare financing scheme in 2022;

WHEREAS, approximately 1.5 million Filipinos every year are pushed to poverty due to healthcare expenditures;

WHEREAS, Filipinos forego or delay healthcare due to prohibitive and unpredictable user fees or co-payments;

WHEREAS, the amount of Php4,000.00 per month of healthcare expenses is catastrophic for single income families;

WHEREAS, while the Universal Health Care Act of 2019 is still in the process of fully achieving its purpose, the Quezon City Government deems it appropriate to provide healthcare and insurance coverage to all Officials and Employees of the Quezon City Government to ensure financial risk protection.

NOW, THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF QUEZON CITY IN REGULAR SESSION ASSEMBLED:

SECTION 1. TITLE. – This Ordinance shall be known as the "Healthcare and Insurance Program for Officials and Employees of the Quezon City Government."

SECTION 2. DECLARATION OF POLICY. – It is the declared policy of the Quezon City Government to recognize the vital role and contribution of the Officials and Employees of the Quezon City Government and to provide immediate assistance to them in terms of health maintenance and life insurance.

SECTION 3. DEFINITION OF TERMS. – For purposes of this Ordinance, the following terms are defined as follows:

a. **Healthcare and Insurance Program** – refers to health maintenance and insurance coverage, to be provided to the Officials and Employees, which includes but not limited to:

- (1) Annual Physical Examination;
- (2) Out-patient services;
- (3) Pre-natal and post-natal care;
- (4) Emergency Care Services (Out-patient or In-patient);
- (5) Hospitalization/In-patient services;
- (6) Pre-existing and Critical illnesses;
- (7) Dental coverage; and
- (8) Life insurance.

Provided that, general exclusions as approved by the Insurance Commission shall apply;

b. **Premium** – refers to the amount of money allocated by the Quezon City Government and to be paid to the qualified insurance company (service provider) to cover the healthcare and insurance coverage of the Officials and Employees of the Quezon City Government.

SECTION 4. COVERAGE. - The healthcare and insurance coverage for the Officials and Employees of the Quezon City Government shall be valid from the issuance of the insurance policy.

SECTION 5. APPROPRIATION. - The annual fund necessary for the maintenance and operation of this Ordinance shall be included in the annual appropriation out of the funds of the Human Resource Management Department or from any available funds of the City, subject to the usual accounting and auditing rules and regulations.

SECTION 6. REPEALING CLAUSE. - All ordinances, executive orders, issuances, rules and regulations, or parts thereof, inconsistent with this Ordinance, are hereby repealed, amended, or modified accordingly.

SECTION 7. SEPARABILITY CLAUSE. - In the event that any provision of this Ordinance or any part hereof is declared invalid, illegal or unconstitutional, the provisions not thereby affected shall remain in full force and effect.
