The Quezon City Government shall likewise enter into Contract within the same non-extendable ten (10) day Period PROVID that the Performance Security and/ or other documentary requirements are complied with. Failure of your office to post the Performance Security and sign the contract within the same ten (10) day period shall result in the followin

1. Forfeiture of the bid security;
2. Disqualification from participating in the bidding at hand
3. Upon conviction, the relevant officers or individuals will suffer the penalty of imprisonment of not less than six (6) years a one (1) day and not more than fifteen (15) years; and
4. Upon determination of administrative liability, through blacklisting proceedings, it will suffer corresponding penalty of suspension.
