DECLARATION OF BIDDER WITH SINGLE/LOWEST CALCULATED RESPONSIVE BID AND RECOMMENDING THE AWARD OF THE PROJECT PROCURED THROUGH **PUBLIC BIDDING**

WHEREAS, Paragraph (v) of Section 261 of Batas Pambansa Bilang 881 or the Omnibus Election Code of the Philippines (OEC) proscribes the release, disbursement, or expenditure of public funds by any public official or employee, including barangay officials and those of government-owned and controlled corporations and their subsidiaries, subject to certain exceptions:

WHEREAS, Paragraph (b) of Section 94 of the OEC defines "expenditure" as payment or delivery of money or anything of value, or a contract, promise or agreement to make an expenditure, for the purpose of influencing the results of the election. It shall also include the use of facilities personally owned by the candidate, the money value of which can be assessed based on the rates prevailing in the area;

WHEREAS, Paragraph (w) of Section 261 of the OEC prohibits the construction of public works, delivery of materials for public works, and issuance of treasury warrants and similar devices forty-five (45) days before the date of the regular election, except for projects or works exempted under Section 261 (v) of the OEC:

WHEREAS, the COMELEC issued Resolution No. 11060 dated 13 September 2024, prescribing the Rules and Regulations on the Prohibition Against the Release, Disbursement, or Expenditure of Public Funds for Social Services and Housing Related Projects, and Issuance of Treasury Warrants and Similar Devices under Section 261(v) and (w) of the OEC in connection with the 12 May 2025 National and Local Elections and Bangsamoro Autonomous Region in Muslim Mindanao (BARMM) Parliamentary Elections;

WHEREAS, Section 31 of COMELEC Resolution No. 11060 provides that the conduct of procurement activities during election period shall be subject to the guidelines of the GPPB;

WHEREAS, on December 18, 2024, the GPPB issued Circular No 01-2024 to guide PEs on the conduct of procurement activities during the election period for the 2025 National and Local Elections;

WHEREAS, Section 4.1 of GPPB Circular No. 01-2024 ("Circular") prohibits the release, disbursement, and expenditure of public funds by Procuring Entities, specifically the issuance of a Notice of Award, for the following Procurement Projects (Prohibited Projects) starting 28 March 2025 (Friday) until 11 May 2025 (Sunday), unless among the exceptions provided in the Circular:

- a. All kinds of Public Works and Housing-related Projects, except those provided in Section 4.2.1 and Section 4.2.3 of the Circular respectively;
- b. Social Welfare and Services Projects of national, regional, provincial, and local government units and those of government-owned or controlled corporations and their subsidiaries, except for Assistance to Individuals in Crisis Situations, the distribution of which is prohibited from 2 May 2025 to 12 May 2025, except those provided in Section 4.2.2 of the Circular;
- c. Housing-Related Projects, except those provided in Section 4.2.3 of the Circular;

WHEREAS, on March 27, 2025, the BAC conducted a public bidding for the procurement of various infrastructure projects enumerated in the Invitation to Bid (IB) posted on March 04, 2025, pursuant to the provisions of R.A. 9184 and its Revised Implementing Rules and Regulations (RIRR), which is/are among the Prohibited Projects pursuant to GPPB Circular No. 01-2024 and related laws;

WHEREAS, the BAC has observed all the requirements and procedures prescribed by R.A. 9184 and its RIRR in the Opening of Bids including the bid evaluation and post-qualification of the **Single/Lowest Calculated and Responsive Bid**;

WHEREAS, the following bidder participated in and submitted its bid on the projects for evaluation and passed the post-qualification process and may now be considered and declared as the **Single/Lowest Calculated and Responsive Bid**, to wit;
