



## CONTRACT AGREEMENT

### CONSULTING SERVICES FOR THE STRUCTURAL INVESTIGATION AND SEISMIC ASSESSMENT OF THE AMORANTO GRANDSTAND AT AMORANTO SPORTS COMPLEX

**QUEZON CITY**, a local government unit existing under the laws of the Republic of the Philippines, represented herein by the **HONORABLE MA. JOSEFINA G. BELMONTE**, in her capacity as City Mayor, with office at Quezon City Hall Compound, Elliptical Road, Diliman, Quezon City, Metro Manila, and hereinafter referred to as the "**QUEZON CITY GOVERNMENT**";

**GIBMA ENGINEERING SERVICES**, a sole proprietorship duly organized and existing under and by virtue of the laws of the Republic of the Philippines with office address at 93 Kalikasan St. Karangalan Village Phase 2A, Brgy. Dela Paz, Pasig City herein represented by its **PROPRIETOR, ENGR. GILBERT B. MAGBUTAY** hereinafter referred to as the "**CONSULTANT**";

WHEREAS, the **QUEZON CITY GOVERNMENT** is desirous that the **CONSULTANT** execute for the **CONSULTING SERVICES FOR THE STRUCTURAL INVESTIGATION AND SEISMIC ASSESSMENT OF THE AMORANTO GRANDSTAND AT AMORANTO SPORTS COMPLEX** with **PROJECT NO. CONSUL-25-003B**, hereinafter referred to as the "**PROJECT**", and the **QUEZON CITY GOVERNMENT** has accepted the Bid amounting to **TWO MILLION TWO HUNDRED SEVENTY-NINE THOUSAND NINE HUNDRED NINETY PESOS AND 16/100 ONLY (₱ 2,279,990.16)** by the **CONSULTANT** for the execution and completion of such works and the remedy of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.

  - (d) Instructions to Bidders;
  - (e) Bid Data Sheet;

- (f) Addenda and/or Supplemental/Bid Bulletins, if any;
  - (g) Bid forms, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents/statements submitted (e.g., bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
  - (h) Eligibility requirements, documents and/or statements;
  - (i) Performance Security;
  - (j) Notice of Award of Contract and the Bidder's conforme;
  - (k) Other contract documents that may be required by existing laws and/or the Entity.
3. In consideration of the payments to be made by the **QUEZON CITY GOVERNMENT** as hereinafter mentioned, the **CONSULTANT** hereby covenants with the **QUEZON CITY GOVERNMENT** to execute and complete the **PROJECT** and remedy any defects therein in conformity with the provisions of this **CONSULTANT** in all respects.
4. The **QUEZON CITY GOVERNMENT** hereby covenants to pay the **CONSULTANT** in consideration of the execution and completion of the **PROJECT** the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.

IN WITNESS WHEREOF the parties have hereunto set their hands to this Agreement on 19 AUG 22 2025, at Quezon City, Philippines.




