



CONTRACT FOR LINE 4: SOLID WASTE CLEANUP, COLLECTION AND DISPOSAL
PROJECT FOR DISTRICT IV FOR THE YEAR 2026 (EARLY PROCUREMENT ACTIVITY)
DSQC-26-SERVICES-0001

This CONTRACT executed on DEC 26 2025 by and between:

QUEZON CITY GOVERNMENT, a local government unit existing under the laws of the Philippines, represented herein by the Honorable **MA. JOSEFINA G. BELMONTE**, in her capacity as City Mayor, with an office at Quezon City Hall Compound, Elliptical Road, Diliman, Quezon City, Metro Manila, and hereinafter referred to as the "the ENTITY"

-and -

INTERNATIONAL SOLID WASTE INTEGRATED MANAGEMENT SPECIALIST INC. JOINT VENTURE WITH PERSAN CONSTRUCTION, INC., a corporation duly organized and existing under the laws of the Republic of the Philippines with office address at Sitio Lukutang Maliit, San Isidro Rodriquez, Rizal, represented herein by its Authorized Representative, **ENGR. REYNALDO S.L. PEREZ**, hereinafter referred to as the "SERVICE PROVIDER"

WHEREAS, the Entity invited Bids for certain goods and services, particularly **LINE 4: SOLID WASTE CLEANUP, COLLECTION AND DISPOSAL PROJECT FOR DISTRICT IV FOR THE YEAR 2026 (EARLY PROCUREMENT ACTIVITY)** under Project No. **DSQC-26-SERVICES-0001** (the "Project");

WHEREAS, the Supplier submitted a responsive bid and was awarded the contract for the procurement in the total amount of **FOUR HUNDRED EIGHTY-FOUR MILLION ONE HUNDRED THIRTEEN THOUSAND FOUR HUNDRED TWENTY-NINE PESOS AND 32/100 ONLY (PHP484,113,429.32)** inclusive of the 12% Value Added Tax (VAT), hereinafter referred to as the "Contract Price."

NOW, THEREFORE, for and in consideration of the foregoing premises, the parties hereby agree as follows:

1. Unless otherwise stated, terms and expressions used in this Contract shall have the same meanings as those assigned to them in the Conditions of Contract, which form an integral part of this Contract.
2. The following documents as required by the Implementing Rules and Regulations of Republic Act No. 12009 shall form part and be read and construed as integral parts of this Contract, viz.:
 - a. Philippine Bidding Documents (PBD);
 - i. Invitation to Bid;
 - ii. Instruction to Bidders;
 - iii. Bid Form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - iv. Bid Data Sheet;





- v. Schedule of Requirements;
 - vi. Technical Specifications;
 - vii. General and Special Conditions of Contract;
 - viii. Supplemental Bid Bulletins, if any; and
 - ix. Other contract documents that may be required by existing laws and/or the Entity.
- b. Winning bidder's bid, including the Eligibility Requirements, Technical and Financial Proposals, and all other documents or statements submitted;
 - c. Performance Security;
 - d. Notice of Award of Contract; and the Bidder's Conforme thereto; and
 - e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBD, such as but not limited to the Notice to Proceed and Warranty Security.
3. In consideration of the Contract Price of **FOUR HUNDRED EIGHTY-FOUR MILLION ONE HUNDRED THIRTEEN THOUSAND FOUR HUNDRED TWENTY NINE PESOS AND 32/100 ONLY (PHP484,113,429.32)** inclusive of the 12% Value Added Tax (VAT). or such other sums as may be determined in accordance with the terms of the Contract, the Supplier agrees to deliver and perform the items and related services for the **LINE 4: SOLID WASTE CLEANUP, COLLECTION AND DISPOSAL PROJECT FOR DISTRICT IV FOR THE YEAR 2026 (EARLY PROCUREMENT ACTIVITY)** described herein in accordance with the terms and conditions specified in the Contract and its annexed documents.
 4. The **QUEZON CITY GOVERNMENT** agrees to pay the above-mentioned sum to the Supplier in accordance with the schedule and manner provided in the Bidding Documents and its annexes.
 5. Any dispute, difference, or claim arising out of or relating to this Contract, including its existence, validity, interpretation, breach, or termination thereof, may be submitted to arbitration or other form of alternative dispute resolution in accordance with the applicable law, such as Republic Act No. 9285 (Alternative Dispute Resolution Act of 2004) or Executive Order No 1008, series 1985 (Construction Industry Arbitration Law).
