This CONTRACT executed on APR 29 2026 by and between:

QUEZON CITY GOVERNMENT, a government agency of the Republic of the Philippines, represented herein by the Honorable MA. JOSEFINA G. BELMONTE, in her capacity as City Mayor, with an office at Quezon City Hall Compound, Elliptical Road, Diliman, Quezon City, Metro Manila, and hereinafter called "the Entity";

-and -

FIRST DATACORP., a company duly organized and existing under the laws of the Republic of the Philippines with principal office address at 3/F Citibank Center, 8741 Paseo de Roxas Makati City, herein represented by its Authorized Representative, SHERELYN U. GALANG, hereinafter called "the Supplier".

WHEREAS, the Entity invited Bids for certain goods and services, particularly SUBSCRIPTION OF DATA ANALYTICS TOOLS FOR BUSINESS PERMITS AND LICENSING DEPARTMENT under Project No. ITDD(BPLD)-26-SERVICES-0323 (the "Project");

WHEREAS, the Supplier submitted a responsive bid and was awarded the contract for the procurement in the total amount of FIVE MILLION PESOS AND 00/100 ONLY (Php5,000,000.00) inclusive of the 12% Value Added Tax (VAT), hereinafter referred to as the "Contract Price."

NOW, THEREFORE, for and in consideration of the foregoing premises, the parties hereby agree as follows:

1. Unless otherwise stated, terms and expressions used in this Contract shall have the same meanings as those assigned to them in the Conditions of Contract, which form an integral part of this Contract.
2. The following documents as required by the Implementing Rules and Regulations of Republic Act No. 12009 shall form part and be read and construed as integral parts of this Contract, viz.:

    - i. Invitation to Bid;
    - ii. Instruction to Bidders;
    - iii. Bid Form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
    - iv. Bid Data Sheet;
    - v. Schedule of Requirements;
    - vi. Technical Specifications;
    - vii. General and Special Conditions of Contract;
    - viii. Supplemental Bid Bulletins, if any; and
    - ix. Other contract documents that may be required by existing laws and/or the Entity.
